2025 EQUINE BOARDING AGREEMENT

For good and valuable consideration receipt of which is hereby acknowledged, MZ Equestrian, LLC, on behalf of Glenview Vista, LLC (collectively referred to herein as “MZ EQUESTRIAN”), located at **2260 Glenview Lane, Vista, CA 92084** (“Premises”) and _____ (“Owner”) enter into this Boarding Agreement (“Agreement”) on this day _____ for the purpose of boarding horse(s), subject to the following terms and conditions:

TERMS AND CONDITIONS

1. **Consideration:** By signing this Agreement, Owner acknowledges and accepts board fees and other terms set forth in the attached Exhibit B Boarding Rate Sheet in exchange for their Horse(s) occupancy on premises as fully described in Exhibit A Horse Information. MZ EQUESTRIAN reserves the right to change Board Fees and other rates as outline on Exhibit B at any time by providing Owner with 30 day written notice. Owner may bring additional horses to board at MZ EQUESTRIAN at a later date, provided space is available, and MZ EQUESTRIAN agrees. For all new horses, Owner shall fill out a new Exhibit A. All terms of this Agreement shall apply to any new horses Owner boards with MZ EQUESTRIAN in the future. In exchange for the Board Fee, MZ EQUESTRIAN agrees to provide Bermuda or Alfalfa hay twice a day (3-4 flakes), water, and corral/stall cleaning. Additional hay can be provided at Owner’s cost. It is expressly understood that MZ EQUESTRIAN does not provide grooming, training, turnout, exercise, or any other related services for boarded horses.
2. **Deposit:** A security deposit in the amount of **\$250 per horse** shall be due upon execution of this Agreement for each new boarder. The security deposit will be returned to Owner upon termination of this Agreement less any outstanding balance(s) owed to MZ EQUESTRIAN.

3. **Owner’s Responsibility:** Owner is responsible for paying Horse’s training, grooming, insurance, farrier, and veterinary fees as well as all specialty fees like bodywork, massage, etc. Owner agrees Horse is current on all vaccinations (required vaccinations: Rabies, Tetanus, West Nile, and Eastern and Western Encephalomyelitis, Influenza, and Equine herpesvirus - EHV) and worming. Owner agrees to provide Proof of Health of horse(s) to MZ EQUESTRIAN prior to Horse’s arrival on Premises. **Proof of Health shall include: 1) Veterinarian Health Certificate 2) Worming and Immunization Record, and 3) Negative Coggins Test (if coming from out of state).**

4. **Payments & Late Fees:** All Board Fees shall be made payable to MZ EQUESTRIAN, LLC. Accepted payment methods are check, direct transfer, or credit card. Board Fees shall be deemed timely if received by the 5th of the month in which it is due. Late penalties shall apply to any Board Fees not made by the 5th of each month. If Board Fees are paid on or after the 6th day of each month, Owner agrees to a ten (10) percent late fee calculated on the full amount due, which shall be due and payable in addition to all other Board Fees. An additional ten (10) percent late fee calculated on the original amount due shall accrue and shall be payable for each additional ten (10) day period or fraction thereof, that the Board Fees remain unpaid. If all balances due are not paid in full, the unpaid balance shall still be considered delinquent, and the ten (10) percent late fee shall continue to apply to the unpaid balance. There is a \$50.00 Non-Sufficient Fund (“NSF”) fee for declined or returned payments. Declined or returned payments may also be subject to the late fees outlined above.

5. **Risk of Loss and Standard of Care:** Owner assumes all risk of loss or injury to Horse. During the time that the Horse(s) is/are in custody of MZ EQUESTRIAN, MZ EQUESTRIAN shall not be liable for any sickness, disease, estray, theft, death, or injury which may be suffered by Horse or any other cause of action whatsoever, arising out of or being connected

in any way with the boarding of said Horse, including, but not limited to, any personal injury, disability or death. MZ EQUESTRIAN MAINTAINS A STANDARD OF CARE IS THAT OF ORDINARY CARE OF A PRUDENT HORSE OWNER IN CALIFORNIA AND NOT AS A COMPENSATED BAILEE. In no event shall MZ EQUESTRIAN be held liable to Owner for Horse's death or injury. MZ EQUESTRIAN shall not be responsible for the theft, loss, damage, or disappearance of any personal property, including but not limited to tack, feed, equipment, trailers or other property stored on Premises or at horse shows; such property is stored at Owner's risk. By signing this Agreement, Owner agrees that they have inspected the Premises and have found it satisfactory. Owner agrees to all payment terms herein with Premises "as is".

6. Damage to Property and Loss of Personal Property: Owner is hereby warned that while on MZ EQUESTRIAN'S premises, direct loss or damage, theft or injury to Owner's horses, tack, equipment, vehicles and trailers is not covered by MZ EQUESTRIAN'S insurance. Owner, having the financial interest in such items, must carry his own insurance under a homeowner's, tenant's, general liability or other insurance policy, or under a separate policy. Any property left for thirty (30) days) or more in possession of MZ EQUESTRIAN after this Agreement is terminated shall become the property of MZ EQUESTRIAN. This includes saddles, bridles, tack trunks, and all other equipment left in MZ EQUESTRIAN's possession. Any damage to Premises beyond normal wear and tear caused by Horse shall be the responsibility of the Owner and all repairs shall be billed to the Owner's account.
7. Trailer Parking: Trailers may be stored on premises provided space is available. The area around the trailer must be maintained at all times by Owner. MZ EQUESTRIAN is not responsible for damage or theft of trailer or its contents. Trailer storage fees are listed in MZ Equestrian's current Rate Sheet attached hereto as Exhibit B and are subject to change at any time. Trailers will be assigned to a specific space. All trailers should have a locking hitch to prevent theft, with keys left in a safe but accessible location on-site in case of wildfire or other natural disaster. If parking on premises Owner agrees trailers can be used for emergency evacuations in the event of wildfires or other natural disaster. Owner hereby agrees and understands the trailer described below or any trailer brought on the premises later may be sold for the balance of fees due and related costs, including attorney fees and court fees if trailer storage fees are forty-five (45) days past due. Trailer will be sold at auction.

8. Insurance: Owner fully understands that MZ EQUESTRIAN does not carry any insurance on any Horse not owned by it for boarding or for any other purposes, whether liability, accidental injury, theft, or equine mortality insurance and that all risks connected with boarding or for any other reason for which the Horse in the possession of, and on the Premises are to be borne by the Owner. Owner understands that MZ EQUESTRIAN is not obligated to procure any insurance protecting Owner against any losses due to fire, earthquakes, natural disasters, theft, death, or disability arising from any injuries or accidents arising to said Horse, including but not limited to injuries caused by the negligence of MZ EQUESTRIAN, their agents, or employees. MZ EQUESTRIAN strongly recommends each Owner maintain major medical and mortality insurance. **Owners are required to carry specific Equine Liability Insurance of not less than \$1,000,000 per occurrence.** This equine liability insurance shall include blanket contractual liability coverage. A current Certificate of Liability Insurance must be on file with MZ EQUESTRIAN and Owner agrees to provide MZ EQUESTRIAN with a copy of the policy as well as the company's name, address, and policy number. Failure to comply with the provisions hereof shall be at Owner's sole risk and grounds for termination of this Agreement.

9. Emergency Care: Except where specifically instructed otherwise, MZ EQUESTRIAN or its agents or assigns, agrees to attempt to contact Owner, Owner's agent, or Owner's veterinarian in the event of an emergency. If MZ EQUESTRIAN is unable to contact Owner, Owner's agent, or Owner's veterinarian within a reasonable timeframe based on the severity of the injury/illness of Horse, MZ EQUESTRIAN is authorized to contact an alternate emergency veterinary service for care and treatment of Horse. Such care shall be paid by Owner within fifteen (15) days from the date that Owner receives notice thereof, or MZ EQUESTRIAN is authorized on behalf of Owner, to arrange direct billing to Owner. MZ EQUESTRIAN shall assume that owner desires surgical care if recommended by a veterinarian in the event of colic, or other life-threatening illness, unless MZ EQUESTRIAN is instructed in writing by Owner that Horse is not a surgical candidate. If Owner has multiple horses on Premises and the surgical instructions vary by horse, Owner must provide Horse's surgical

instructions on Exhibit A for each of Owner's horses.

In the event MZ EQUESTRIAN cannot contact Owner, Owner's Agent, or Owner's veterinarian and in the opinion of the attending veterinarian, the Owner's horse is suffering from a terminal illness or life-threatening injury, the attending veterinarian has my permission to put my horse down, unless MZ EQUESTRIAN is instructed herein in writing by Owner that Horse is not to be euthanized. If Owner has multiple horses at the facility and the euthanasia instructions vary by horse, Owner must provide euthanasia instructions for each horse. I also give my permission for MZ EQUESTRIAN to call a rendering service to have horse removed from the premises and agree to cover all costs of such treatment and removal.

Owner Warranties: I, the Owner, warrant that except for the following limitations, I am the sole lawful and registered owner of Horse and have unlimited rights to care and custody of them. I warrant that if I am not the owner of Horse, I have full authority to bind owner of Horse according to the terms of this Agreement. I warrant that there are no liens or other encumbrances, express or by law, that are outstanding in respect to horse(s) on Premises. I warrant that the horse(s) boarded on Premises have no known medical conditions, allergies, or contagious disease at the time the Horse enters Premises that are dangerous to other horses or persons on Premises. I warrant that the only limitations on ownership of the Horse are listed below (for example, lease (list name and contact of Lessor), syndication ownership (name of syndicate and contact information for syndicate), horse purchased on installments (name of previous owner and contact), previous seller with right of first refusal, etc). are: _____.

10. Inherent Risks and Assumption of Risk: INHERENT RISKS WARNING AND NATURE OF THE HORSE WARNING: UNDER CALIFORNIA LAW, AN EQUINE PROFESSIONAL IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN EQUINE ACTIVITIES RESULTING FROM THE INHERENT RISKS OF EQUINE ACTIVITIES. Owner acknowledges there are inherent risks associated with equine activities such as described below, and hereby expressly assumes all risks associated with participating in such activities. The inherent risks include, but are not limited to the propensity of horses to behave in ways such as running, bucking, biting, kicking, shying, spooking, bolting, pawing, stumbling, rearing, falling, or stepping on, that may result in an injury, harm, or death to persons on or around them; the unpredictability of a horse's reaction to such things as sounds, lighting changes, natural disasters, weather, sudden movement, and unfamiliar objects, persons, or other animals; certain hazards such as surface and subsurface conditions, collisions with other animals; the limited availability of emergency medical care; and the potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the animal or not acting within such participants ability. Owner expressly releases MZ EQUESTRIAN, its agents, and assigns, from any and all claims for personal injury, loss of life or property damage, even if caused by negligence (if allowed by the laws of this State) of MZ EQUESTRIAN or its representatives, agents, or employees.
- a. Additional Risks Posed by Wildfire: Owner understands that portions of the Western United States are at elevated risk of wildfires throughout the year. Wildfires are, by their nature, fast-moving, unpredictable, and dangerous. Wildfires can bring flames, sparks, and hot objects. Wildfires can change course, forcing MZ EQUESTRIAN to undertake emergency evacuations of themselves and all of the staff that care for the horses boarded on Premises. Owner understands that it is Owner's sole responsibility to be prepared for an emergency evacuation of their horse(s) and personal property. This includes but is not limited to having access to a horse trailer in sound working condition or a cooperative situation whereby the horse can be transported, as MZ EQUESTRIAN cannot transport any horse or property owned by Owner. MZ EQUESTRIAN cannot guarantee that it can prevent or limit wildfire losses.
- b. Additional Risks Posed by Natural Disasters: Owner understands that Premises may experience natural disasters such as severe storms, earthquakes and floods throughout the year. Such natural disasters are by their nature, fast-moving, unpredictable and dangerous, which may cause MZ EQUESTRIAN to undertake emergency evacuations or procedures for themselves and all staff on Premises. Owner understands and agrees that it is Owner's sole responsibility to be prepared for such natural disasters and to have a plan for an emergency evacuation of their horse(s) and personal property. MZ EQUESTRIAN cannot transport any horse or property owned by Owner. MZ EQUESTRIAN cannot guarantee that it can prevent or limit natural disaster losses.
- By signing below, Owner releases MZ EQUESTRIAN, its agents, and assigns, of all liability in connection with any injury

sustained on and from the Horse. Owner acknowledges that horseback riding is an inherently risky activity and hereby releases MZ EQUESTRIAN, its agents, employees, assigns, vendors or contractors from ANY liability for injury, damage, or loss to Owner or Owner's personal property.

11. **Indemnities and Hold Harmless:** Owner agrees to indemnify, defend and hold harmless MZ EQUESTRIAN from any and all loss, claims, cost, liability, duties, obligations, actions, cause of action, or expenses (including, without limitation, actual attorney's fees) of any kind or nature whatsoever arising out of or related in any manner whatsoever to the Owner's Horse(s), the presence of the said Horse(s) on Premises, or the presence of the Owner or any other person (including, without limitation, Owners' guests, invitees, and service providers (collectively, "Owner's Invitees) on Premises related in any manner whatsoever to the Horse. Owner or Owner's Invitees agree that neither MZ EQUESTRIAN nor any of its owners, agents, assigns, employees, or representatives shall have any liability of any kind or nature whatsoever related in any manner whatsoever to any injures to any person or property occurring on Premises, from any cause whatsoever, including (without limitation) the negligence of MZ EQUESTRIAN or any of its owners, agents, employees, or representatives. Owner agrees to hold harmless MZ EQUESTRIAN from any and all claims arising from damage or injury caused by Horse to anyone and defend MZ EQUESTRIAN from any such claims. This includes but is not limited to, any personal injury or disability the Owner or Owner's Invitees may receive on Premises. Owner, or Owner's Invitees, acknowledge and assumes responsibility for their presence and/or participation in equine activities, including the principals of assumed risk regarding equines as live animals, which actions may not be fully predictable or controllable. Owner agrees to disclose any and all hazardous properties of Horse(s) boarded with MZ EQUESTRIAN.
12. **Limitation of Actions:** Any action or claim brought against MZ EQUESTRIAN for breach of Agreement or for loss due to negligence must be brought within one (1) year of the date of such claim or loss incurs.
13. **Right to Refuse Services:** MZ EQUESTRIAN reserves the right to refuse the continuation of boarding services of any horses for any reason, to include but not limited to: animal's poor health or unsoundness, dangerous propensities, habits and/or vices, and/or non-trainable condition which MZ EQUESTRIAN may not be equipped or capable to handle; Owner's refusal to obey MZ EQUESTRIAN rules, or to cooperate with MZ EQUESTRIAN on reasonable requests relative to the management, training, welfare and safety of animals and people on Premises. In such event, MZ EQUESTRIAN shall give Owner seven (7) days written notice to remove Owner's horse(s) from Premises. After all fees have been paid in full this Agreement is terminated. Failure to pay training, grooming or care fees and other fees as due to third-parties shall also entitle MZ EQUESTRIAN to immediately terminate this Agreement and maintain Owner's horse(s) in MZ EQUESTRIAN'S possession until all fees and charges are paid in full subject to the Lien provision in Section 14 of this Agreement.
14. **Waiver of Agister Lien Civil Code §3080:** Owner hereby agrees and understands that said Horse(s) described in Exhibit A may be sold for the balance of board due, and related costs, including attorney fees and court fees after the such fees are two (2) months past due. Owner expressly waives all provisions of California Civil Code §3080 et al. (which provides for a court-ordered sale of Horse). There shall be public notice of the sale of said Horse. MZ EQUESTRIAN will provide fifteen (15) days written notice of sale of said Horse to Owner at the address provided as part of this Agreement. At the conclusion of the sale, the price paid for the Horse shall be conclusive evidence for all purposes of the value of said Horse. Any money received by MZ EQUESTRIAN in excess of the amount owed by Owner, including attorney fees and court costs of MZ EQUESTRIAN, will be paid to Owner. However, MZ EQUESTRIAN will not be obligated to store property and retain or maintain the Horse in question in the event the amount due exceeds the anticipated unregistered value of the Horse. In the event MZ EQUESTRIAN exercises its lien right in accordance with all procedures required by California law, as above described for nonpayment, this Agreement shall constitute a Bill of Sale and authorize the process transfer application for any breed or organization registration as may be applicable to said Horse, upon affidavit by MZ EQUESTRIAN representative setting forth the material facts of the default and foreclosure as well as MZ EQUESTRIAN compliance with foreclosure procedure as required by law. Should the amount received from auction, less all related expenses, be insufficient to pay all amounts due to MZ EQUESTRIAN, then Owner shall be personally liable for any deficiency thereof. In the event collection of this account is turned over to an attorney, Owner agrees to pay all attorney fees, costs, and other related expenses for which a minimum charge of \$250 will be assessed.

15. **Termination:** It is agreed by Owner and MZ EQUESTRIAN that this Agreement may be terminated by either party by giving 30 days' notice. All notices must be issued in writing unless otherwise agreed upon by MZ EQUESTRIAN and

Owner. MZ EQUESTRIAN reserves the right to terminate this Agreement immediately if Horse is deemed dangerous or a threat to the use and enjoyment of the Premises, in such event MZ EQUESTRIAN shall give Owner seven (7) days written notice to remove horses from premises and no pro-rated Board Fees shall be returned to Owner. In all cases of termination, all outstanding balances must be paid to MZ EQUESTRIAN before Horse leaves premises.

16. **Minors:** All children under the age of 18 must be supervised by an adult or legal guardian at all times while on Premises. At no times will MZ EQUESTRIAN, LLC be liable for children under the age of 18 who are not supervised. Parent/legal Guardian agrees to hold MZ EQUESTRIAN, LLC, its agents, assigns, representatives, employees, contractors, subcontractors, owners, managers and the like, harmless from any and all incidents caused by non-supervised children or their guests, and to defend and indemnify the same from any such claims. Parent and/or legal guardian acknowledges and assumes full responsibility for their child's presence and/or participation in equine activities, including the principal of assumed risk regarding equines and as it pertains to live animals, whose actions may not be fully predictable or controllable as outlined in Section 10 above.
17. **Code of Conduct & Signing Release and Waiver of Liability:** Owner acknowledges and agrees to abide by the MZ EQUESTRIAN RULES (Attached hereto as Exhibit C). This includes any changes or additions to the rules that may be made by MZ EQUESTRIAN from time to time. Upon notification of any changes or additions to the rules, Owner shall have thirty (30) days to either accept (e.g., by doing nothing) or to opt to terminate this Agreement. The receipt of any updated rate sheets or rule changes shall constitute notice of any and all such rate or rule changes. Owner shall abide by all terms of the rules (Exhibit C) and shall ensure that Owner's relatives, guests, and trespassers understand and abide by such terms. ***Owner understands that Owner and/or Owner's guests CANNOT be on Premises without signing a release and waiver of liability.*** Owner is responsible for ensuring that any and all guests sign a waiver and release of liability agreement and hereby agrees to indemnify MZ EQUESTRIAN for any and all claims brought by guest's that have not signed a release. Failure of compliance with these terms by Owner, Owner's relatives, guests or trespassers, will result in notice of termination being given to Owner. Immediate expulsion of Owner's horse(s) shall result if Owner, Owner's relatives, guests or trespassers are found to have used illegal substances on the premises, stolen other's property, intentionally damaged MZ EQUESTRIAN or Owner's property, abused animals or physically or verbally abused staff, Owners, trainers, independent contractors, guests or MZ EQUESTRIAN personnel. The acts and omissions of Owner's relatives, guests or trespassers shall be construed as the acts and omissions of Owner. **Owner Initials:** _____
18. **Governing Law and Venue:** This Agreement shall be governed by the laws of the State of California. Any legal action commenced to enforce or interpret this Agreement shall be brought in San Diego County, California. The parties hereto consent to both venue and jurisdiction in San Diego County, and any attempt to pursue legal action in any other state shall be void for lack of jurisdiction in that foreign court.
19. **Voluntariness:** Each of the parties hereto fully understands the terms, conditions, and provisions of this Agreement, voluntarily enters into the same and believe its terms to be fair, just, adequate, and reasonable.
20. **Assignment:** No party may assign or transfer this Agreement without the prior written consent of the other party.
21. **Default:** If Owner fails to timely pay MZ EQUESTRIAN any fees owed as set forth in the Rate Sheet attached hereto as Exhibit B, the MZ EQUESTRIAN shall have the right to: a) terminate this Agreement upon (7) seven days written notice in which Owner shall relocate Horse and Owner's property; b) Obtain lien upon the Owner's Horse(s) and/or tack for any unpaid balance as outlined in Section 14 above; c) without process of law, retain the Owner's Horse(s) and tack described herein until the amount of indebtedness is discharged and/or d) seek any other remedies provided in law or equity. On any breach, the other party shall have the right to recover expenses and costs within the parameters of paragraph 28, below. **A VIOLATION OF THE RULES OF MZ EQUESTRIAN IS DEEMED A MATERIAL BREACH OF THIS AGREEMENT WHICH ALLOWS THE MZ EQUESTRIAN TO RESORT TO ALL ITS REMEDIES UPON SUCH VIOLATION.**
22. **Force Majeure:** Neither party shall be liable hereunder for any failure or delay in the performance of its obligations under this Agreement, except for the payment of fees, if such failure or delay is on account of causes beyond its reasonable control, including civil commotion, war, fires, floods, accident, earthquakes, inclement weather, telecommunications line failures, electrical outages, network failures, governmental regulations or controls, casualty, strikes or labor disputes, pandemics, epidemics, local disease outbreaks, public health emergencies, communicable diseases, quarantines, terrorism, acts of God, or other similar or different occurrences beyond the reasonable control of the party so defaulting or delaying in

the performance of this Agreement, for so long as such force majeure event is in effect. Each party shall use reasonable efforts to notify the other party of the occurrence of such an event within 5 business days of its occurrence, which notice shall include a description of the force majeure event and an estimate of the length of time such event will delay or prevent performance hereunder.

23. Dispute Resolution: In the event of a dispute arising from or relating to this Agreement, the parties will attempt in good faith to resolve such dispute(s) by engaging in the following steps. Any claim or controversy in which the amount in controversy is \$10,000 or less shall be decided by the Small Claims Court **of San Diego County, California**. Any claim or controversy in which the amount in controversy exceeds \$10,000 but less than \$50,000, the parties agree to participate in private mediation with a company agreeable to both parties. Mediation must be initiated within 90 days of the notice of dispute. The cost of mediation shall be borne equally by the parties involved unless the mediator(s) deem such division of costs to be inequitable. Should the parties fail to initiate mediation proceedings within 90 day notice of dispute, the non-agreeing party shall be deemed in default and the non-defaulting party can proceed with litigation. The award rendered by the mediator(s) shall be final and judgment may be entered upon it in accordance with applicable law in any court having jurisdiction thereof. Nothing in this provision shall interfere with MZ EQUESTRIAN's right of lien as outlined in Section 14 above.
24. Entire Agreement: This Agreement represents the entire agreement among the parties unless exhibits have been attached hereto. The terms are contractual in nature and are not mere recitals, and shall be binding upon the respective heirs, executors, administrators, successors, representatives and assigns of the parties hereto.
25. Severability: The illegality or unenforceability of any provision of the Agreement of any instrument or agreement required hereunder shall not in any way affect or impair the legality or enforceability of the remaining provisions of this Agreement or any instrument or agreement required hereunder.
26. Attorneys' Fees and Costs: If any party materially defaults in performing any of his or her obligations under this Agreement, and in the event the parties' dispute resolution efforts pursued in compliance with this Agreement are unsuccessful, and the dispute proceeds to litigation, the prevailing party in any such litigation shall be entitled to recover their reasonable attorneys' fees and costs.
27. Counterparts: The Agreement may be executed in any number of counterparts, and by electronic signature, each of which shall be deemed an original. All of which together shall be deemed as one and the same instrument.
28. Waiver: No waiver of any breach of any term or provision of this Agreement shall be construed to be, nor shall be, a waiver of any other breach of this Agreement. No waiver shall be binding unless in writing and signed by the party waiving the breach.

MZ EQUESTRIAN RULES
Updated 5-6-2025

Welcome to Glenview Vista, operated by MZ Equestrian, we are pleased to be able to offer public boarding that includes many amenities and access to beautiful public trails. It is our responsibility to the Owners to provide a safe, clean, and well-maintained facility. Therefore, some rules are necessary. Please have every family member and guest who will be using MZ Equestrian read and understand the following rules. It is the sole discretion and judgment of MZ Equestrian whether the conduct of Owner/Owners, etc., is in violation of the Rules.

1. **Facility Hours:** 7:00 A.M. – 9:00 P.M. Glenview Vista / MZ Equestrian is home to several families and we need to respect their privacy. Arena lights must be turned off by 9:00 P.M. No riding after 8:30 P.M. and Owners must leave by 9:00 P.M. In the event of travel or shows, please inform the Management of early or late arrival. MZ Equestrian is not locked at night thereby allowing people emergency access to their horses whenever necessary. However, except in the case of injury or illness, no Owners or guests should be at Glenview Vista / MZ Equestrian after 9:00 P.M.
2. **Release of Liability / Waiver:** It is required that anyone visiting or handling a horse on premises must have a signed liability release on file with MZ Equestrian. If he/she/they decline to complete the release form, he/she/they will be denied access to the facility. This includes any service vendors (farriers, equine therapists, haulers, or veterinarians) that boarders engage. Please ensure that all your guests and vendors complete this form and return the completed/signed copy with a full, legible first name and last name to the Ranch Office. A boarder's failure to comply with this requirement will result in immediate termination of boarding services.
3. **No Smoking, Vaping or E-Cigarettes:** MZ Equestrian is a non-smoking environment. Our facility is in a fire risk area and surrounded by seasonally dry vegetation. Additionally, barn environments naturally include many flammable materials including feed and bedding. Therefore, no smoking of any kind will be permitted on the premises. Violators of this policy will be asked to vacate the premises immediately.
4. **Emergency Preparedness:** In preparation for emergencies, **all Owners are asked to provide a halter and lead rope for their horse in a location that is visible and accessible from the front of the horse's stall or corral.** The halter should be clearly marked with the horse's name and or owner's name for identification. Fire Extinguishers are available throughout the premises for emergency use. An evacuation plan A with diagrams has been prepared for the premises and are available for viewing in the Office, Main Barn, and Community Tack Rooms. Emergency Phone Numbers are posted and available in the Office, Main Barn, and Community Tack Rooms. A first aid kit for people is available in the Office and in the Main Barn.
5. **Riding:** The use of the jumps is restricted to supervised lessons with a facility approved trainer only. Riders can walk their horses around the facility if they remain at the walk **but must refrain from riding on the asphalt access road (from parking lot past the Ranch Hand mobile homes to Main Home).** No riding is permitted inside of a corral or stall, inside the barn, under the trellis of the Ranch Office Patio, or anywhere else not clearly designated for equestrian activities. Double riding is not permitted and must be avoided on the premises. If a rider has consumed alcoholic beverages, they must refrain from riding.
6. **Helmets & Safety Equipment:** Safety riding helmets are encouraged for all riders but are required for any rider under the age of 18. The helmet should be properly fit to the rider's head and of an appropriate size (adult size helmet for an adult, child sized helmet for a child). At all times while

mounted, riders under the age of 18 must wear a harnessed and fully fastened protective ASTM/SEI approved safety helmet for equestrian use. Helmet and chin straps must be fitted properly according to manufacturer's instructions. All riders, regardless of age are required to wear a safety riding helmet when engaging in jumping a horse over obstacles in the arena. The use of additional personal safety equipment and gear designed specifically for equestrian sports including air vests and safety vests with air canisters is the personal choice of each rider. When used, they must be used in accordance with the manufacturer's instructions.

7. **Footwear:** Closed-toed footwear is required for any person handling a horse, and boots with a heel are required for all riders. Appropriate footwear shall be worn by anyone visiting MZ Equestrian (no sandals or flip flops).
8. **Driving/Parking:** The speed limit is **5 MPH** on premises and the Glenview Lane access road. Please be a good neighbor. Park in designated areas only unless for short-term drop-off of bedding, or feed. Parking is available in our parking lot, along the asphalt road behind the Ranch Hand Homes and up along the road to the main house, along trailer row (only if you are not blocking a trailer space and or our dumpsters), and in the lower ranch gravel trailer parking area. Do not park next to your corral, the Office Patio, arenas, turn-outs, or barn unless you have received permission due to extenuating circumstances. If you park along the retaining wall opposite the trailers, leave your keys in the office or with an on-site contact in case we need to move your vehicle. If we have had rain and the dirt roads on the ranch are saturated, please refrain from driving on them at all and use the asphalt parking areas only.
9. **Trailers:** When accessing the ranch via trailer, there is only one way in and one way out. Trailers should enter through the "Delivery/Trailer" entrance near the ranch office, and proceed up the slight grade by the garage, go past the barn and main arena, up the slight grade by the manure dumpster, and to the right by trailer row to eventually park. If it is wet or has rained recently, please check with the Ranch Managers to see if the slight grades are passable. The roads in this facility are mostly clay and become extremely slick when wet.
10. **Barn and Corral Aisle ways:** All barn and corral aisles must be maintained as points of egress. Therefore, aisles must have a 10-foot clear space for egress and any items stored in the passageway must clear this 10-foot space and be stored neatly adjacent to the boarder's corral or stall. No feed or personal tack items may be stored in the aisles. Boarders are expected to use the community tack rooms and feed storage areas provided to store such items.
11. **Feed:** We regularly feed **hay three times a day**. Feeding time is between 7:00 A.M - 8:00 A.M., 11:30 A.M. – 12:30 P.M. and 4:30 P.M. – 5:30 P.M. Horses are fed 1 - 2 flakes per feeding. Arrangements for horses needing more feed or special diets must be made by the owner as MZ Equestrian is not able to accommodate these special needs. We will provide normal rations for horse trailering. If you feel your horse has not received the correct amount of feed, please bring it to the attention of Management, do not "help yourself" to the feed in the hay barn. Refrain from feeding horses that are not your own unless you have written permission and a release on file.
12. **Minors:** Minors must be supervised by a parent or guardian while on premises unless minor is a participant formally engaged in a camp, clinic, program or as a working student in which case said minor must be supervised by the head of such program/trainer.
13. **Turnouts:** Turnouts are permitted in the Upper Ranch Round Pen, the Lower Ranch Round Pen, the Lower Ranch Parkside Round Pen (Priefert), the Parkside/Mid-Ranch riding arena, Mid-Ranch Lesson Arena, Lower Ranch 48 x 48 Turnouts, and in the Upper Ranch Riding Arena only. There is a 20-minute limit on areas regularly designated for turnouts if other Owners are waiting. Boarders are responsible for their horse when it is being turned out, so do not leave the proximity of the round pen or turnout corral or leave the premises during turnout. Leaving a horse unattended is grounds for immediate termination of boarding services. Boarders are responsible for cleaning up after their horse in all riding arenas, round pens, and turn-out paddocks – this is very important for the longevity of the footing that manure be removed from the footing immediately. Muck tools are available for this purpose. The Lower Ranch Main Riding Arenas are not designed for regular

turnouts, they may only be used for turnouts in extreme circumstances such as if every other turnout is being used and they are not being used for riding. If a boarder uses either of the Lower Ranch Main Arenas for turnout and any riders and/or trainers come to use them during said turnout, then boarder using the Main Riding Arena for turnout must vacate immediately and the 20-minute turnout limit does not apply.

14. **Lunging:** Regular lunging of horses is permitted in the Upper Ranch Round Pen, the Lower Ranch Round Pen, the Lower Ranch 48 x 48 turnouts, the Parkside/Mid-Ranch riding arena, Mid-Ranch Lesson Arena, and in the Upper Ranch Riding Arena only. Only in extreme cases, where all other turnout or arena space is occupied may the Lower Ranch Main Riding Arena space be used for lunging. Please be mindful of other Boarders/horses in proximity when using a lunge whip. Boarders are responsible for cleaning up after their horse in all riding arenas, and round pens. Muck tools are made available.
15. **Corral/Round Pen/Turn-out Gates:** Please swing gates inward (when possible), **close and secure them behind you when leaving a corral, round pen, or turn-out regardless of whether the space is occupied or empty.** Boarders are responsible for cleaning up after their horse in all riding arenas, round pens, and turn-out paddocks. Muck tools are available for this purpose.
16. **Repairs/Modifications:** Please notify Management of any needed repairs and do not make direct requests to the MZ Equestrian employees unless in case of emergency (water supply or safety hazard). Any modifications to corrals must be approved by Management and must meet Facility safety specifications and insurance regulations. Repair requests must be made in writing via the digital repair request. Repairs will be prioritized based upon a “safety first” basis. Not all requests will be deemed valid based upon the Facility safety specifications and or insurance regulations and some may not be completed as such.
17. **Tack Rooms:** The facility provides public tack rooms (3 adjacent to the Hay Barn, 3 in Upper Ranch near the Mare Motel, 4 in the Mid-Ranch area near the crossties, and 2 in the main barn). No food/feed should be kept in the tack rooms as they attract rodents. Additionally, please keep the doors to the tack rooms closed when they are not in active use to limit rodent and pest access. The tack rooms are not burglar proof, so we recommend valuable tack not be kept in them. Please mark all of your tack and supplies with your last name.
18. **Wash Racks:** Only wash horses in the designated wash racks near the main riding arena/office and the main barn. Dirt and manure are to be put in the adjacent manure bins. If your horse has shed while being bathed, then use the muck rack and other tools available at the wash rack to clean up after your horse. Do not body clip horses in wash racks.
19. **Grooming Racks:** Owners may groom horses in their stall/corral or in the designated grooming areas. Do not tie horses outside pipe corrals or tack rooms to groom or saddle. All manure and clippings are to be put in a waste can near the grooming racks.
20. **Farrier Work/Horse Shoeing:** Farrier work may only be completed in the designated crosstie/grooming areas. Farriers should sweep up all trimmings and put them in the muck bucket.
21. **Outside Venders:** Only approved outside vendors will be allowed to come on the premises and care for horses. This includes anyone blanketing, feeding, walking, turning out or riding any horse. MZ EQUESTRIAN will supply list of venders who frequent the ranch and have completed the Liability Release Waiver, upon request.
22. **Socializing and Guests:** Owners are welcome to picnic/BBQ in designated community areas including the MZ Equestrian Ranch Office and Patio. Guests are welcome and are subject to the Rules and Regulations and must sign a Release of Liability Waiver. Absolutely no handling of horses, whether on the ground or riding, under the influence of any illegal substance or alcohol. Violators of this policy will be asked to vacate the premises immediately.
23. **Damage to Stalls/Pens:** Any damage above and beyond normal wear and tear shall be charged to the Owner. Charges will include the materials needed to repair the corral and the related labor charges.

24. **Stalls:** Owners rent a type of accommodation, not a particular stall. The management reserves the right to relocate horses to a like size/feature corral or stall in the interest of creating the best and safest environment for everyone.
25. **Dry Stalling:** A stall can be dry stalled for a maximum of three months. The dry stall fee is 75% of the normal board. Owners must submit a request to dry stall in writing to Management two weeks prior to the time dry stall is to begin.
26. **Stall Improvements:** All changes/additions to stalls must be approved & implemented by Management. All such improvements become the property of MZ Equestrian.
27. **Arenas:** All arenas are available to all Owners unless the Management has claimed “closed/private use” of an Arena for a specific repair of a safety hazard, for conditioning or water/drag, for a clinic or local horse show. Such closures will be communicated to the Owners by use of a white ziptie device indicating that the arena is closed. Arenas will be closed and locked during inclement weather for safety reasons and to properly seal and protect the footing. Boarders are responsible for cleaning up after their horse in all riding arenas, round pens, and turn-out paddocks. Muck tools are made available.
28. **Feed/Shavings Changes:** Changes to feed or shavings must be requested in writing using the QR access codes available throughout the ranch. Changes in feed or shavings that result in billing updates will be done on a pro-ration basis on the following billing statement.
29. **Stallions:** No stallions are allowed or horses who have not been gelded for at least three (3) months.
30. **Mucking Stalls:** Owners choosing to muck their stall are responsible for taking the manure to a manure dump site at the facility. Do not leave manure anywhere outside the stall. The manure can also be piled inside the stall close to the front gate and Ranch workers will remove it when they clean the stall. No excess shavings or trash should be included in the manure.
31. **Trainers:** Trainers utilizing the facility for the purpose of training horses or working with clients must be approved by MZ Equestrian Management. Approved Trainers must provide MZ Equestrian Management with a valid Certificate of Insurance that names MZ Equestrian as an additional insured. The only people allowed to act in the capacity of a Trainer are the “approved” Trainers who maintain their business at MZ Equestrian.
32. **Dogs:** Owners and their guests are allowed to bring dogs on to the premises only if they are UTD on all vaccinations, leashed safely in an area that will not cause conflicts with horses or riders, and are provided water and bedding if they are left secured for longer than 10 minutes. Dog owners are responsible for removing their dog’s waste and placing it in a trash receptacle. Dogs that are deemed aggressive by management will not be permitted on-site.
