## **FORCE Baseball Membership**

The FORCE Baseball membership fee covers the following:

## **Membership Term & Cancellation**

The FORCE Baseball membership requires a **minimum commitment of six (6) months**.

## **RELEASE OF LIABILITY**

By electronically agreeing to this document, the participant affirms that they have read and understood its contents.

In consideration of being accepted to participate in any way in the FORCE Baseball Program, I, the undersigned, acknowledge, understand, and agree that:

**1. Risk of Injury:**

I acknowledge that participation in baseball involves inherent risks of bodily injury,

including but not limited to paralysis, dismemberment, disability, and death. While rules, skills, equipment, and personal discipline may reduce these risks, serious injury or property loss may still occur.

**2. Assumption of Risk:**

I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the releasees or others, and assume full responsibility for my participation.

**3. Compliance and Safety:**

I agree to comply with all stated and customary terms and conditions for participation. If I observe any unusual or significant hazard or have concerns regarding my readiness to participate, I will immediately notify the nearest official and remove myself from participation.

**4. Release and Waiver:**

I, for myself and on behalf of my heirs, assigns, personal representatives, and next of kin, hereby release, indemnify, and hold harmless **FORCE Baseball**, its officers, officials, volunteers, employees, agents, sponsors, advertisers, other participants, and, if applicable, the owners and lessors of premises used for the activity (“Releasees”), from any and all claims for injury, disability, death, or loss or damage to person or property, whether caused by the negligence of the Releasees or otherwise, except in cases of gross negligence or misconduct, to the fullest extent permitted by law.
