AGREEMENT TO PARTICIPATE AND BE A MEMBER IN GOOD STANDING IN CHSRA DISTRICT 4

In applying for membership to CHSRA District 4, I _____ (member's name) agree to participate at my district level according to the following terms:

- 1. I agree to submit a current report card at the completion of each semester/trimester and a mid-term grade report in October and March to the District 4 Membership Secretary, Theresa Porter (HS) or Charla Allen (JH).**

REPORT CARDS: It is the responsibility of the contestant to get their most current report card report (with a 2.0 GPA and at least 4 passing grades or if less than 4 classes, must be passing ALL with a 2.0 GPA) uploaded to the NHSRA portal. If the membership secretary does not have the most current grading report by the grading period specified below that ends on or before the rodeo entry closing date, the member will not be able to rodeo and will forfeit all current entries. Grading period is defined as, covers no less than five weeks and corresponds to the dates submitted on the grading period request form.

- Semester/Trimester Report Card (Spring) – Submit with membership enrollment, beginning of new season. This should be your final report card from Spring 2025.
- 1st Mid-Term Grade Report – Must be signed by your school between October 6 – 10, 2025 and uploaded to the NHSRA Membership portal by October 17, 2025.
- Semester/Trimester Report Card (Fall) – Upload to the NHSRA Membership portal in December/January.
- 2nd Mid-Term Grade Report - Must be signed by your school between March 2 – 6, 2026 and uploaded to the NHSRA Membership portal by March 13, 2026.

The membership secretary will provide you with the mid-term form to be completed.

- 2. I agree to perform my assigned rodeo duty at each of our District 4 Home Rodeos**

CONTESTANT RODEO WORK DUTY: Every member of District 4 entered in the rodeo will be assigned work duty except event directors. If a member does not fulfill their duty assigned and does not get their card signed off by the adult event director and back to the rodeo secretary at the end of the rodeo, a \$25 fee will be assessed and the member will be considered in "bad standing" until the fee is paid.

- 3. I agree to submit Sponsorship of a minimum \$500 (HS) or \$300 (JH), by November 1st**

SPONSORSHIPS: Members will forfeit entries to the next rodeo if sponsorship is not received by the due date.

- 4. I agree to sell the 15 MANDATORY CHSRA ATV Raffle tickets at \$10 each**

ATV RAFFLE TICKETS: All raffle tickets and money are due at or before our January Rodeo. Ticket proceeds go to the CHSRA Scholarship fund.

- 5. I agree to provide a mandatory auction item of \$50 value or more for District 4's fundraiser auction**

AUCTION ITEM: Auction item must be turned in at check in. Members will be fined \$100 if an auction item is not received.

6. I agree that parents/legal guardians must be an associate member

ASSOCIATE MEMBER: I understand that in order for CHSRA D4 to be able to produce safe, fair, and quality rodeos, parents/guardians will participate in District 4 activities as an "ASSOCIATE MEMBER". Associate memberships are available for \$20 each. Any adult that is helping around the arena is required to have an associate membership due to insurance purposes.

7. I understand that, should I become "not in good standing" I must write a letter to the District 4 Board to request my membership be restored to "good standing".
8. I understand that in order to qualify for year-end awards, I must participate in no less than 50% plus one rodeo per event during the 2025-2026 District 4 calendar.

IF I FAIL TO FULFILL THE TERMS OF THIS AGREEMENT AND ADHERE TO THE DISTRICT 4 POLICIES (BYLAWS) OF CHSRA AND DISTRICT 4, I WILL NOT BE A MEMBER IN GOOD STANDING. I UNDERSTAND THAT IF I AM NOT A MEMBER IN GOOD STANDING, I MAY FORFEIT FROM COMPETING IN FUTURE CHSRA RODEOS. I FURTHER UNDERSTAND THAT IN ORDER TO RECEIVE YEAR-END AWARDS, I MUST BE A MEMBER IN GOOD STANDING.
