2025-2026 MEMBERSHIP INSTRUCTIONS AND INFORMATION

Please read through these instructions, this is step-by-step on all required documents. As the new rodeo season is beginning, here is some information that will help you get your membership paperwork in order. **If you still have questions, please contact your district membership secretary.** The National Membership Portal will open for renewals on August 1st. State Paperwork will be available on [HYPERLINK "http://www.chsra.com"](http://www.chsra.com)

To GUARANTEE to rodeo in September, your national registration or renewal must be completed (NHSRA dues paid) before August 13, your state and national paperwork uploaded by August 20th, and state dues paid by August 31st. Membership secretaries will do their best to process paperwork, but do not wait until the last day. This is a multi-step process, and it takes time to check paperwork. All district secretaries are volunteers and have jobs outside of rodeo too, so if you do not get a response right away, please know they are doing their best. Please read through this information as it is step-by-step instructions on how to complete your membership from start to finish.

Some districts may have earlier deadlines, so please check your district website

We encourage you to attend your district's membership meeting where ALL information will be gone over and questions will be answered.

If joining after September 1, your completed national and state paperwork must be uploaded AT LEAST 3 weeks BEFORE entries OPEN to ensure you can enter. -Example- If entries open on October 21, you will need to have ALL PAPERWORK uploaded by October 1

Membership will close on March 1, 2026. All state and district requirements are mandatory regardless of join date. Please make sure that you are aware of your district's fundraising obligations when you join

Returning Members-NATIONAL PAPERWORK

- Update your membership on <https://nhsra.equestevent.com/> If you need your username, contact Jen Fleming (secretarychsra@gmail.com) . **DO NOT CREATE A NEW ACCOUNT, this will delay your membership**
- Once your information is updated, you will need to pay your national dues online with a credit card. Once payment is processed, you will be taken to a page to print off the unsigned forms (national membership application and minor's release). **YOU MUST PRINT OUT THE COMPUTER-GENERATED FORMS-NO HANDWRITTEN NATIONAL FORMS WILL BE ACCEPTED.** There are TWO REQUIRED forms: National Membership Application AND National Minors Release/Waiver
- Make sure that **BOTH PARENTS MUST sign BOTH forms.** If a parent is deceased or one parent has full/sole custody, that must be indicated on the signature line. Minor's release must be NOTARIZED
 - COURT PAPERS MUST BE UPLOADED SHOWING SOLE/FULL CUSTODY
 - If a signature is missing from either form or not notarized on minor's release, this will delay your membership. This is a NATIONAL requirement and you will be ineligible to rodeo until this is complete

New Members-NATIONAL PAPERWORK

- Create a profile on <https://nhsra.equestevent.com/> If you are under 13, you will have an additional step: an email will be sent to a parent's email for approval.

- Once your information is updated, you will need to pay your national dues online with a credit card. Once payment is processed, you will be taken to a page to print off the unsigned forms (national membership application and minor's release). **YOU MUST PRINT OUT THE COMPUTER-GENERATED FORMS-NO HANDWRITTEN NATIONAL FORMS WILL BE ACCEPTED.** There are **TWO REQUIRED** forms: National Membership Application **AND** National Minors Release/Waiver. Minor's release must be NOTARIZED
 - DO NOT PRINT OFF THE UNSIGNED INSURANCE CARD UNTIL AFTER YOUR MEMBERSHIP HAS BEEN APPROVED BY THE STATE, this will serve as your membership card, but must have your number on it
- Make sure that **BOTH PARENTS** sign **BOTH** forms. If a parent is deceased or one parent has full legal/sole custody, that must be indicated on the signature line of parent not signing.
 - COURT PAPERS MUST BE UPLOADED SHOWING SOLE/FULL LEGAL CUSTODY
 - If a signature is missing from either form or not notarized on minor's release, this will delay your membership. This is a **NATIONAL REQUIREMENT** and you will not be eligible to enter a rodeo until this is correct.
- Once your national application and your minor's waiver are signed, you will need to upload them to the membership portal. ******Make sure to label the documents correctly. Incorrect labeling will result in delayed processing. You will need to label the documents correctly before your membership is processed. Your membership **WILL NOT** be processed until you have uploaded your signed and notarized minor waiver (with notary acknowledgement if used) and signed national membership application on your NHSRA portal.
- Upload a copy of your birth certificate (new members only)

ALL MEMBERS-STATE PAPERWORK

- Go to www.chsra.com for the California Membership Packet. Make sure that you click on the correct division packet (High School or Junior High) This packet will contain:
 - Paperwork Checklist

 - Grading Period Request Form (Grading dates filled out AND SIGNED by school/district)

 - Concussion, By-laws, policy manual and ATV Acknowledgement
 - District transfer request (if you are rodeoing outside of your home district)

- Fill out and sign these forms.
 - California membership application, grading period request form and Home School Verification (if applicable) **MUST** be signed by the school principal, administrator or counselor.
- Associate memberships (each member is required to have at least 1, and associate members must be at least 18 years old) fees need to be completed online, following the link on www.chsra.com ******You are required to upload a copy of your receipt with your paperwork. This link will open on August 1.
- Upload the following documents your National Membership Portal-**MAKE SURE TO LABEL FILES AND CATEGORIZE THEM CORRECTLY, not following this step will delay your membership approval. Please do not merge the files**

- State Dues (\$50.00) will be paid online through the link on www.chsra.com. You will not be able to pay this fee until your paperwork is complete. Payment link will open August 23. You will need to pay this fee before you can enter any rodeos.

- ❖ If you plan to rodeo in September, you must have your national dues paid by August 13. All state and national paperwork must be uploaded by August 20 to guarantee enough time to process paperwork and pay state dues. Remember your district secretary is a volunteer and they will do their best to help you

2025-2026 CHSRA ATV Raffle Ticket Guidelines

- ALL CHSRA Members are required to sell ATV Raffle Tickets
- 15 tickets are required from both High School and Junior High members (\$150 value)
- Money and stubs must be turned into your district by FEBRUARY 1.
 - Each district may give their members an earlier deadline, so please check with your district
- If your ticket stubs and money are not turned in to your district by February 1st, you will not be eligible to enter or participate at any CHSRA sanctioned rodeos or events (district or state level)
- You will be ineligible to join the 2026-27 season if you do not turn in your money from this (2025-26) season.
- Each district will have an ATV ticket chairman, who will disburse and collect all tickets and money. Any questions should be directed to your district chairman.

Disciplinary Action

CHSRA shall have the right and responsibility to enforce the rules of the National High School Rodeo Association. Action taken may include disqualification, censure, probation, removal, suspension or expulsion. Disciplinary action shall be authorized against any member, contestant, parents or guardian of members or contestants, or any member of the public attending a national, state/province rodeo, district qualifying rodeo or CHSRA sanctioned function. A member or contestant may be subject to all disciplinary procedures due to action of parent or guardian. In the event that an issue must come before the disciplinary committee, the contestant shall be notified as soon as possible by the person or persons disqualifying the Contestant.

Contestant Disqualification

Please make sure to read and fully understand pages 34-38 of the 2024-2026 NHSRA Rule Book. This section refers to all ways a contestant could be disqualified from the rodeo competition. It is your responsibility to be familiar with the different offences that could result in disqualification from the 2025-2026 CHSRA Rodeo Season. The following section is regarding conduct, and association with substances that will result in immediate disqualification: page 36, #7 a (1):

Having any association with alcoholic beverages, vaping, marijuana products, tobacco products, and narcotic or other non-medicinal drugs while in attendance at any approved High School Rodeo, whether at a motel or on the rodeo grounds or going to or from the rodeo or at any rodeo function. Contestants will be disqualified for the use of those products.

Social Media

In accordance with the NHSRA rules for contestant disqualification under Conduct (3): Conduct or speech of any kind detrimental to the best interest of the National High School Rodeo Association or the sport of rodeo while in attendance or coming to and going home from a rodeo, CHSRA has expanded this to all platforms of social media. Any negative speech regarding NHSRA, CHSRA, the facilities, volunteers, staff, business associated with or member of the CHSRA will result in the possible suspension for the 2025-2026 rodeo season.

The social media policy will extend to any photographs or videos posted on any social media platform that shows the contestant's association with alcoholic beverages, vaping products, marijuana products, tobacco products and narcotic or other non-medicinal drugs while in attendance at any approved High School Rodeo, whether at a motel or on rodeo grounds or going to or from the rodeo or at any rodeo function. Contestants could face possible suspension from the 2025-2026 rodeo season.

If a contestant is disqualified from the 2025-26 CHSRA Rodeo Season, the contestant will forfeit any placings, points, awards, monies and/or scholarships that have been awarded.

The NHSRA Rule Book states: (10) Disciplinary action(s): Any member of a State/Province Association, student or adult who: a) fails to comply with the requirements and standards for members contained in the Rules, By-laws and Constitution or Policy Statements of the Association as adopted by the National Board of Directors or the National Executive Committee; b) engages in the acts of insubordination, serious misconduct association with alcohol, narcotic or other non-medicinal drugs or acts which are detrimental to the reputation, principles and interests of the Association; c) engages in conduct constituting grounds for disqualification from any event or function as provided in the NHSRA rules; or d) any other acts specified hereafter, shall be subject to the Disciplinary Action provided below. Violation of any of the provisions of the Rules, By-laws and Constitution by the parents or guardians of a student member of the NHSRA will subject the student member to all levels of the Disciplinary Action provided herein. (Found in 2024-2026 NHSRA Rule Book, page 6)

2025-2026 CHSRA Membership Paperwork Checklist

2025-2026 CHSRA GRADING PERIOD REQUEST FORM

TO BE FILLED OUT BY SCHOOL OFFICIAL

California High School Rodeo Association requires all members to maintain *BOTH* a 2.0 GPA as of the latest grading period (minimum 5 week) *AND* at least 4 passing subject grades or if less than 4 subjects, must be passing in all with a 2.0 GPA. If these qualifications are not met, you will NOT be allowed to rodeo until the next grading period shows that you have met the qualifications. The grading period must end prior to close of entries.

Grades that are not current or have not met the above stated qualifications will not be allowed to check in at the rodeo. NO EXCEPTIONS! This rule will be strictly enforced.

This form gives the CHSRA State Board, district presidents and membership secretaries permission to contact the school to verify grades if there is a question or concern.



Contestant Qualifications, pg 31, Rule #1

In accordance with the NHSRA rulebook pertaining to contestant qualifications, students who attend a homeschool, private school, religious school or correspondence school are eligible for membership if the school is recognized and approved by the state/province board of education or National Board of Education in the state/province the member is applying for membership. The contestant would need to show proof that the school they are attending is accredited and that they have met the grade requirements.

If the school the student is attending is not accredited by the State or National Board of Education the student shall demonstrate composite grade-level academic proficiency on any State Board or National Board of Education recognized achievement test or other mechanism as provided for in State or National Board of Education rules. A student shall be eligible if they achieve a minimum composite score or survey test score within the average or higher than average range as established by the test service utilized on any nationally-normed test.
