STATE OF TEXAS § § KNOW ALL PERSONS BY THESE PRESENTS: **COUNTY OF BEXAR** 

WHEREAS, KC Renovations, Inc., a Texas Corporation ("Declarant"), is the developer of all lots situated within that certain subdivision known as Lakeview Villas located in Bexar County, Texas.

WHEREAS, the Declarant filed an instrument entitled Declaration of Covenants, Conditions and Restrictions for Lakeview Villas Subdivision – Plat No. ("Declaration") which was filed on April 24, 2019, as Document Number 20190074224 of the Official Public Record of Bexar County, Texas.

WHEREAS, Section 7.5, of the Declaration entitled Amendment states that the Declaration may be amended and provides in part "(a) This Declaration may be amended ... upon the express written consent of at least sixty-six and two-thirds percent (66-2/3%) of the outstanding votes (determined pursuant to language herein) held by Members at a meeting at which a quorum is present in person or by proxy..."

WHEREAS, the San Antonio Lake View Villas HOA, Inc. ("Association") is charged with the management and operation of the Association in accordance with the Bylaws of San Antonio Lake View Villas HOA, Inc. ("Bylaws") and administering and enforcing those certain covenants, conditions and restrictions contained in the recorded Declaration.

WHEREAS, pursuant to Article 3.2 of the Bylaws, entitled Special Meetings Owners representing at least 30% of the votes in the Association requested a special meeting of the members for the purpose of amending the Declaration to:

- (1) Delete Section 4.10, entitled Management Agreement; and
- (2) Delete Section 6.8, entitled Property Management.

WHEREAS, the Association scheduled a Special Meeting of the Members for Tuesday, September 12, 2023, for the purpose of considering and voting on the two proposed amendments to the Declaration.

WHEREAS, pursuant to Section 3.8 of the Bylaws, entitled Quorum, a quorum of 66.66% of all votes were present, in person or by proxy, at the Special Meeting on September 12, 2023.

WHEREAS, more than the required number of votes was received for both amendments to pass and become effective.

NOW, THEREFORE, BE IT RESOLVED, that the *Declaration of Covenants, Conditions and Restrictions for Lakeview Villas Subdivision – Plat No.* \_\_\_\_\_\_ is hereby amended as follows:

- (1) Section 4.10, entitled Management Agreement is deleted in its entirety; and
- (2) Section 6.8, entitled <u>Property Management</u> is deleted in its entirety.

Except as modified hereby, all other terms and conditions of the Declaration shall remain in effect and unchanged.

Except as otherwise defined herein, all terms used herein shall have the same meaning as they have in the Declaration.

BE IT FUTHER RESOLVED that this amendment be filed of record in the Official Public Record of Bexar County, Texas.
