#### Purpose, Goals, and Objectives

- a. Monitor and ensure welfare of clients seen by Supervisee.
- b. Facilitate and promote development of Supervisee's addiction counselor identity and competence.
- c. Promote development of clinical competencies of addiction counseling using TAP21, Addiction Counseling Competencies, and ATTC Performance Assessment Rubrics.
- d. Prepare counselor-in-training supervisee for written examination and obtaining state certification.

#### **Context of Services**

- a. Supervisee must obtain 96 hours of clinical supervision, including 12 hours of individual supervision for initial certification; 24 hours for re-certification.
- b. Group Supervision will be provided monthly on the 3<sup>rd</sup> Saturday of each month, 11am 3pm. Individual and triadic supervision sessions will be conducted at the convenience of the participants at least 1 hour per month for initial certification and 1 hour per quarter for recertification.
- c. Fees are \$50.00 for each 4-hour group supervision and \$50.00 for individual and triadic supervision.
- d. If there is a schedule change supervisee will be notified via email or phone.
- e. Psychodynamic supervision, collaborative case conceptualization, interpersonal process recall, and role plays will be used in supervision.
- f. Supervisor will gather information through supervisee self-report, monitoring clinical service provision, observing Supervisee, documentation reviews, as well as ancillary information obtained from others with whom the Supervisee has a professional relationship (internship or work supervisor).

#### **Documentation**

- a. Supervision will be guided by using the ATTC Performance Assessment Rubrics, TAP21, and Addiction Counseling Competencies.
- b. Informal feedback will be provided monthly and written evaluation may be provided every 6 months.
- c. Supervision notes will be kept by Supervisee as well as Supervisor.
- d. When needed and with input from Supervisee, an Individual Supervision Plan will be development and amended as necessary.

#### **Duties and Responsibilities - Supervisor**

- a. Review Supervisee audio/video tapes, psychosocial evaluations, progress notes, treatment plans, and discharge plans when submitted by the Supervisee.
- b. Question Supervisee to justify approach and techniques used.
- c. Intervene when client welfare has been determined to be at risk.
- d. Ensure that ethical guidelines and legal statues are upheld.
- e. Monitor addiction counseling dimension competencies
- f. Discuss the quality of the supervisory relationship and work to resolve conflicts.
- g. Document crisis or emergency consultations.
- h. Present, describe, and model appropriate directives.
- i. Maintain Professional Liability Insurance.
- j. Assist Supervisee in reviewing various counseling theories, with the goal of gaining an appreciation for an integrative practice approach.
- k. Assist Supervisee in gaining greater self-awareness during counseling and supervision sessions.

#### **Duties and Responsibilities - Supervisee**

- a. Uphold all ethical guidelines and legal statues.
- b. Maintain Professional Liability Insurance.
- c. Prepare homework to include recorded sessions and documentation as assigned by Supervisor.
- d. Be prepared to discuss client cases.
- e. Justify case conceptualizations made and approach and techniques used.
- f. Discuss any boundary issues or violations that occur.
- g. Consult supervisor or designee in emergencies after calling proper authorities and site supervisor.
- h. Execute Supervisor's directives.
- i. Adhere to all agency/internship site/workplace policies and procedures.
- j. Practice working from a variety of and appropriate counseling theories.
- k. Demonstrate willingness to discuss in supervision Supervisee's experiences of professional development.

#### **Evaluation**

- a. Submit 1 recorded session for review per 10 hours of supervision completed for review in supervision.
- b. Submit 1 example of documentation per quarter for review in supervision.
- c. Halfway through initial certification a formal review will be completed by Supervisor.
- d. Upon completion of supervision Supervisor will evaluate Supervisee for the application for certification.
