

# PRESCRIPTION TO END GENOCIDE IN GAZA

## Issued by Doctors Against Genocide In accordance with the Genocide Convention, the Geneva Conventions, and the Medical definition of Genocide

### CLINICAL MANIFESTATIONS:

- **Mass forced starvation:** 1.1 million children under siege; famine conditions confirmed (IPC data)
- **Total blockade of Gaza** since March 2, 2025: No food, water, fuel, medicine
- **Systematic destruction of healthcare:** All hospitals bombed, ambulances targeted, over 1,000 medical workers killed
- **Mass displacement:** 1.9 million civilians forcibly uprooted—90% of Gaza's population
- **Over 300,000 killed**, 70% are women and children
- **Global epicenter of child suffering:** Highest number of orphans, amputees, and trauma victims on Earth
- **Scholasticide:** Erasure of all universities and majority of schools
- **Public incitement to genocide** by Israeli officials: Calls for total annihilation, forced expulsion, and ethnic cleansing

### DIAGNOSIS:

### LIVE-STREAMED GENOCIDE

**A state-led campaign of mass extermination, starvation, and forced displacement—committed with impunity and in full violation of the Genocide Convention, Geneva Conventions, and international humanitarian law.**

## PRESCRIPTION:

- **END THE SIEGE AND DELIVER AID:** Immediate and unconditional lifting of the blockade on Gaza. Ensure full, unrestricted humanitarian access—food, water, fuel, and medical supplies must flow freely. Canada should send a diplomatic convoy to help break the siege and support the safe delivery of aid.
- **ENFORCE A PERMANENT CEASEFIRE:** Support the implementation of UN Security Council **Resolution 2728**. Canada must push for an immediate, unconditional ceasefire and back international civilian protection missions.
- **STOP ARMING APARTHEID:** Enact a full two-way arms embargo on Israel. End all military exports and security cooperation. Impose targeted sanctions on Israeli officials and institutions complicit in war crimes and genocide.
- **ENFORCE THE GENOCIDE CONVENTION**
  - Canada is legally obligated to prevent and punish genocide. Failure to act is complicity. Refer perpetrators to the ICC, suspend state immunities, and prosecute.
- **HOLD CANADIANS ACCOUNTABLE:** Investigate and prosecute Canadian citizens who have served in the Israeli Occupation Forces (IOF) for potential involvement in war crimes and crimes against humanity.
- **ENFORCE INTERNATIONAL LAW:** Uphold the Geneva Conventions and UNSCR 2286. Protect healthcare, prosecute attacks on civilians and infrastructure, and refer perpetrators to the International Criminal Court.
- **RECOGNIZE PALESTINE, END COMPLICITY:** Officially recognize the State of Palestine and cut all ties, financial, trade, academic, and cultural, with illegal Israeli settlements. Revoke charitable status for Canadian entities that support them.
- **DEFEND FREEDOM OF EXPRESSION IN CANADA:** Reject anti-Palestinian racism and legislation that criminalizes protest or solidarity. Protect the right to speak out against Israeli apartheid and genocide.
