PRESCRIPTION TO END GENOCIDE IN GAZA

Issued by Doctors Against Genocide In accordance with the Genocide Convention, the Geneva Conventions, and the Medical definition of Genocide

CLINICAL MANIFESTATIONS:

- Forced Mass starvation: 1.1 million children under siege; famine conditions confirmed (IPC data). Gaza is now the hungriest place on earth
- Total blockade of Gaza since March 2, 2025: No food, water, fuel, or medicine
- Systematic destruction of healthcare: All hospitals bombed, ambulances targeted, over 1,500 medical workers killed
- Mass displacement: 1.9 million civilians forcibly uprooted—90% of Gaza's population
- Over 300,000 killed, 70% are women and children
- **Global epicenter of child suffering:** Highest number of orphans, amputees, and trauma victims on Earth
- Scholasticide: Erasure of all universities and majority of schools
- **Public incitement to genocide** by Israeli officials: Calls for total annihilation, forced expulsion, and ethnic cleansing

DIAGNOSIS: LIVE-STREAMED GENOCIDE

A state-led campaign of mass extermination, starvation, and forced displacement—committed with impunity and in full violation of the Genocide Convention, Geneva Conventions, and international humanitarian law.



PRESCRIPTION:

IMMEDIATE LIFT OF THE BLOCKADE

End the weaponization of food and medicine, restore unrestricted access to food, water, fuel, and essential medical supplies by well established UN and Humanitarian mechanisms.

- UNRESTRICTED HUMANITARIAN ACCESS
 Support S.Res 224 calling for the urgent delivery of humanitarian aid to address the needs of starving civilians in Gaza.
- ENFORCE CEASEFIRE NOW Implement UN Security Council Resolution 2728 (March 25, 2024): Immediate, unconditional ceasefire.
- **PROTECT HEALTHCARE UNDER INTERNATIONAL LAW** Enforce UNSCR 2286 (2016) and Geneva Conventions: Stop all attacks on healthcare infrastructure; prosecute violators.

IMPOSE FULL ARMS EMBARGO AND SANCTIONS

End all military assistance to the State of Israel. Cut off the weapons used in war crimes and mass civilian slaughter in accordance with the US **Leahy Law**. Apply targeted economic sanctions on officials and entities complicit in the genocide.

• FEED THE CHILDREN, NOT THE WAR MACHINE

Launch emergency feeding and medical programs for every starving child. Their survival is non-negotiable.

ENFORCE THE GENOCIDE CONVENTION

Member States are legally obligated to prevent and punish genocide. Failure to act constitutes complicity.

We are healers. We cannot be silent while healthcare is weaponized and patients are starved, bombed, and denied care.
