

2026 DLP Commercial Maintenance Bracket Challenge Official Rules

1. NO PURCHASE NECESSARY

No purchase, payment, or store visit is necessary to enter or win. A purchase will not improve your chances of winning. Void where prohibited by law.

2. SPONSOR

The challenge is sponsored by DLP Commercial Maintenance Systems, LLC, located at 2040 Venture Circle Southeast, Canton, OH, United States.

3. ELIGIBILITY

This challenge is open to current employees, active clients, and potential clients of DLP Commercial Maintenance Systems, LLC who are legal residents of the United States and are 18 years of age or older. Employees of competing maintenance firms are not eligible to participate.

4. ENTRY PERIOD

Entries will be accepted starting on March 15, 2026. All brackets must be completed and submitted by the official tip-off of the first game of the first round (the "Entry Deadline").

5. HOW TO ENTER

Online Entry: Visit CBS Sports to join the "DLP Commercial Maintenance Bracket Challenge" group. Limit: One (1) bracket entry per person. Any participant found using multiple email addresses to submit multiple brackets will be disqualified.

6. WINNER SELECTION

The winner will be the participant whose bracket earns the highest point total based on the scoring system of the host platform. Tiebreaker: In the event of a tie, the participant who most closely predicts the total combined score of the Championship Game will be declared the winner. If a tie remains, a random drawing will occur.

7. PRIZE

The Grand Prize consists of a one-time \$200 Service Credit applicable toward any one (1) qualifying standalone service provided by DLP Commercial Maintenance Systems, LLC.
