

Prayer Ministry Liability Waiver

I acknowledge that Philip or Zipporah Madison (or both), as a ministry of Mind The Heart Ministry, has voluntarily agreed to pray for me using various inner healing and deliverance methods. I understand that this is a Christian ministry activity of Mind the Heart Ministry and is not professional counseling. **I understand that Philip and Zipporah are not licensed counselors.** I understand that Philip and Zipporah Madison are doing what they can as a caring and compassionate people to try and help me achieve more freedom in my life. I understand that Philip or Zipporah Madison is not guaranteeing any results from our ministry time together.

I further state that I have **voluntarily sought assistance of my own initiative and that I am under no obligation to accept or implement any of the advice or help that I might receive** from Philip and Zipporah Madison. I understand that I am free to reject any or all of the assistance or recommendations I may receive through this ministry activity.

I understand that if I receive ministry from Philip or Zipporah (or both), **they are committed to respect the disclosed information**, but not to complete confidentiality. (If needed, the information may be shared with selected other leaders, with great discretion, to further your total healing process. This may include future meetings with spiritual mentors to set up appropriate boundaries for your personal and spiritual growth. This may also include disclosures that may be required by applicable law such as those instances set forth in the following section.)

I understand and agree that Philip and Zipporah are required by law to report information to law enforcement agencies in these instances:

- 1. When there is a reasonable basis to believe or suspect that a person may take harmful, dangerous, or criminal action against another person or against him/herself; and/or*
- 2. When there is a reasonable basis to believe or suspect a situation involving any act of child or elderly abuse or neglect.*

I agree to hold Philip and Zipporah Madison and Mind the Heart Ministry harmless and free from any and all liability, loss, or damage, real or perceived, that may arise as a result of my interactions with Philip and Zipporah Madison. In the event of any claim for personal injury (which includes mental, emotional, and spiritual health), I, my heirs, executors, administrators, or assigns agree to indemnify and hold harmless Philip and Zipporah Madison from any and all claims or causes of my action or by any other person or entity, by whomever or wherever made or presented, and under no circumstances will I present any claim against Philip or Zipporah Madison for personal injuries or otherwise, caused by any act of negligence by Philip or Zipporah Madison.

I have read this disclaimer and release of liability and understand the potential dangers/risks of engaging in this ministry with Philip and Zipporah Madison and assume all risks associated with this ministry and am fully aware of and understand the terms and legal consequences of agreeing to this release.
