- The business/organization understands that security, accident and theft insurance related to their booth and merchandise is solely their responsibility. The business/organization **must** provide the Chamber with a copy of their insurance policy naming the Campbell Chamber of Commerce as an additional insured.
- Should the business/organization violate any of the above requirements, the Chamber of Commerce reserves the right to ask the business to leave the Festival without a refund.
- No refund will be issued if cancellation is made after **ONE MONTH OUT FROM DATE OF EVENT**.
- In consideration for the opportunity of being a **Business Row** participant in the **Boogie Music Festival**, and for the service provided by the Campbell Chamber of Commerce, I/we (on behalf of ourselves, our heirs, assigns and legal representatives) release the Chamber of Commerce, its officers, employees, agents and servants of liability for their negligence. I understand that this is a rain or shine event, and there will be no refunds.
