This Membership Agreement (“Agreement”) is entered into as of the date signed below by and between Rocky Mountain Stunts (RMS) and the undersigned applicant (“Applicant”). By signing this Agreement and submitting your current marketing materials, you agree to be bound by the terms and conditions set forth herein.

1. Introduction

2. Membership Benefits

As an RMS Team Member, you will receive the following benefits:

3. Membership Requirements

In order to maintain the integrity and unity of the Rocky Mountain Stunts team, the following requirements must be met:

Brand Representation: All marketing materials must prominently display the Rocky Mountain Stunts name and web address along with your performer-related information to ensure consistency and reinforce our brand.

Open Communication: Members must maintain ongoing, effective communication with RMS management regarding career decisions and upcoming training opportunities.

Representation and Conduct: Members are expected to speak highly of and cross-promote fellow team members, and to promote Rocky Mountain Stunts with sincerity and pride in all industry circles.

Social Media Engagement: When posting action-related content (including stunts, fight choreography, martial arts, etc.), you must include the hashtags #rockymountainstunts and #warriorquest along with any additional tags. This practice reinforces our solidarity and strengthens the team’s presence.

4. Cost of Membership

There are no annual dues or membership fees required to join Rocky Mountain Stunts. Our membership is built on a foundation of unity, teamwork, and solidarity. The focus of our community is on collective training, professional growth, and mutual support. The only costs associated with Rocky Mountain Stunts are:

The "Warrior Quest" Action Training Program: Participation in our signature training program designed to hone your action skills.

Specialized Workshops: Enrollment in *Member only* Stunt and Practical FX workshops offered periodically.

Promotional Items: Purchase of team merchandise such as hats, shirts, jackets, or other non-required promotional products.

These programs and items are offered on an optional basis to further enhance your skills and team experience and are not mandatory for maintaining your membership.

5. Submission of Marketing Materials

As a condition of this membership, you agree to submit all current marketing materials, including but not limited to your statistics, demo reels, headshots, resumes, and downloadable PDFs, for review. These materials must be signed by you upon submission, certifying that they comply with the guidelines established by RMS.

6. Team Commitment

By signing below, you acknowledge that you are committed to operating under a team mentality. You agree to actively contribute to the collective success of Rocky Mountain Stunts and to uphold the standards and values outlined in this Agreement.

7. Termination of Membership

Rocky Mountain Stunts reserves the right to terminate your membership at its sole discretion if you fail to adhere to any term of this Agreement. This includes, but is not limited to, violations of brand representation, open communication, professional conduct, and social media engagement requirements. Upon termination, you will immediately lose access to all membership benefits and must cease representing yourself as an RMS Team Member. Such termination may occur with or without prior notice, and RMS shall not be liable for any consequences resulting from the termination.

8. Use of Likeness

I, the undersigned, hereby grant permission to Rocky Mountain Stunts, LLC to photograph, record, and capture my voice, performances, poses, acts, plays, training footage, film clips, and appearances. I further authorize the use of my picture, photograph, silhouette, and any other reproduction of my physical likeness and voice in any promotional endeavors, written materials, or motion picture/television/video projects undertaken by Rocky Mountain Stunts, LLC and its affiliates. I also grant Rocky Mountain Stunts, LLC the unlimited right to distribute, exhibit, and exploit such media by any method or device.

I agree that I will not assert or maintain against Rocky Mountain Stunts, LLC any claim, action, suit, or demand of any kind or nature whatsoever, including but not limited to those based upon invasion of privacy, rights of publicity, or any other civil rights, in connection with the authorized use of my physical likeness and sound. I hereby agree to indemnify and hold harmless Rocky Mountain Stunts, LLC, its employees, heirs, or assigns from any and all claims, liabilities, demands, actions, causes of action(s), costs, and expenses arising out of the foregoing.
