Proposed Amendment to Wapiti Bowmen Constitution

Subject: Termination Clause

Purpose: To update provisions for distribution of Wapiti Bowmen's assets in the event the club terminates at some point in the future. The proposed change is intended to have the club's assets benefit locally rather than being sent to a national organization (e.g., the National Bowhunter Education Foundation currently mentioned in the Constitution).

ARTICLE XI: TERMINAL CLAUSE

In case of termination of this organization, all remaining treasures funds shall be turned over to the National Bowhunter Education Foundation **distributed as follows:**

- a. **An amount of \$25,000.00 shall be distributed to support the local S3DA program or, if the local S3DA program is no longer functional, to support an alternative non-profit youth archery organization, and**
- b. **After the distribution described in Paragraph a, above, is completed, all remaining funds shall be distributed to an existing non-profit organization which has an established program for providing college scholarships to deserving students in a field of study which supports archery and/or protection of Oregon's wildlife, habitat and hunting heritage. If more than one existing non-profit provides such an established scholarship program, the funds may be divided between such organizations at the club's sole discretion.**

Distribution of funds pursuant to Paragraph b, above, shall be subject to the receiving non-profit organization agreeing to manage the distributed funds in the form of an endowment to provide for scholarships to be awarded in perpetuity.

The proposed change to the Wapiti Bowmen Constitution will be voted on by members attending the April 6, 2021 membership meeting. The meeting will be held at Big Town Hero in Lebanon and will begin at 6:30 PM. All current Wapiti Bowmen members attending the meeting are eligible to vote on whether or not to adopt the proposed change to the Wapiti Bowmen Constitution.
