If the buyer is not able to pick up the puppy chosen within the week of availability, there will be a holding fee of \$25 per day for continued care of puppy as if you were to board him/her.

Terms: The puppy is being sold as a pet companion only; the puppy must be spayed/neutered by one year of age. If the puppy has not been spayed/neutered by this time, the dog may come back to us. If you breed this puppy without purchasing breeding rights from the breeder, a lawsuit will be filed against you, and you will be liable for all court and legal fees incurred by the seller, Mendy Smith, also known as Saginaw Dachshunds. All puppies become the property of Saginaw Dachshunds aka Mendy Smith.

Health Guarantee:

SAGINAW DACHSHUNDS, LIMITED WARRANTY & HEALTH GUARANTEE:

This limited warranty covers only the puppy described in this agreement. To activate the guarantee, the buyer must have the puppy examined by a licensed Veterinarian within 3 business days from time of pick up. If a veterinarian finds the puppy to be unsuitable, return the puppy immediately. Changing your mind, family dispute, landlord problems does not warrant a refund. Using Banfield Pet Hospital @ PetsMart, or feeding any food besides Royal Canin, Open Farm, Fromm or Science Diet voids the guarantee. If the puppy is declared to be in a life-threatening condition due to, genetic or hereditary problems by a licensed Veterinarian, return the puppy along with all registration papers, a written report from the veterinarian to the seller, and the puppy will be replaced with one of equal value. If the puppy should die within 10 days, all registration papers and a letter from a licensed veterinarian stating the cause of death must be given to the seller before a replacement puppy of equal value will be considered. Death due to illness or accidental death is not covered. The puppy is guaranteed for one year from the puppy's date of birth for any life-threatening congenital or hereditary disorders. **NO CASH WILL BE REFUNDED**. Seller is NOT responsible for any Veterinarian charges, shipping charges, or delivery charges. Seller's liability is limited to the price paid for the puppy, no other charges or fees. Any shipping expenses for returning the new puppy would be at the buyer's expense. All appropriate shots for the puppy's age have been given, and a record of this vaccination history is supplied when you pick up your puppy. However, puppies are not fully immune until the vaccination series is complete. These diseases can be spread via contact, air, hands, and clothing. Please take precautions. The purchaser further understands that Parvo and other infectious diseases could be present at the veterinary clinic and other places buyer takes said puppy. Saginaw Dachshunds will not be held liable if any infectious diseases are found in the puppy after delivery to the purchaser of the puppy. A Health Guarantee from our veterinarian will be issued along with the puppy's shot/worming records.

Seller does not guarantee against hypoglycemia, coccidia, giardia, internal/external parasites (worms, fleas, ticks), alopecia, CDA, cold or heat-related issues, physical or emotional stress; non-descending testicles, luxating patellas, hernias, open fontanelle, overbite/underbite. These defects will be pointed out and noted; the buyer is purchasing knowing these defects. All puppies sold as pets only. List any known flaws or effects:

No guarantee is given as to the size, weight, hair coat, breed ability, or disposition of the puppy. This guarantee is not valid if the puppy is sold or given to a third party. Buyer agrees that he/she understands this contract fully and that this contract is under the jurisdiction of the State of Texas. It is agreed that the place of venue of any litigation or arbitration shall be in Tarrant County, and shall not exceed the price paid for said puppy. No Veterinarian, shipping, or delivery fees will be covered by the seller.

Please give children's Benadryl 1 hour before vaccines. (1cc per 2lbs) Saginaw Dachshunds (Aka Mendy Smith) is not responsible for the puppy having reactions to vaccines, especially to the Leptospirosis vaccine. Dachshunds are very susceptible to reactions if given Lepto. However rare, the reaction can even lead to death. It's strongly suggested not to give the puppy the Lepto vaccine until it's 1 year of age.
