Patriot Pivot Closer Rental Agreement

The undersigned Landowner/Operator has requested rental of the pivot track closer from LFLCD, referred to in this agreement as the "District". Because of unpredictable weather and repairs, the District cannot adhere to a strict rental schedule. Your cooperation and patience will be greatly appreciated.

The Landowner or operator:

A 75-horsepower tractor is required to operate the closer.

To pay the District a Minimum rental fee of \$100.00 per 24 hour period Pickup and delivery are the responsibility of the Landowner/Operator. A cleaning deposit of \$105.25 is required.

To schedule a rental, call (970) 534-5768 Tuesday thru Thursday 10-4. Rental periods not to exceed 72 hours unless prior arrangements are made.

The Landowner/Operator must use the closer for their own property. Loaning the Closer to another party is prohibited. Custom work is also prohibited.

The Landowner/Operator will exercise normal and reasonable care of the Closer while in their possession.

The Landowner/Operator will make no repairs to the Closer, they will notify the District Office of any problems. The Closer will be parked until repairs can be completed. Any unauthorized repairs will be subject to having the Closer inspected and evaluated at the Landowner/Operator's expense.

The Landowner/Operator will be responsible for any repairs that need to be made to the Closer, because of misuse or abuse.

The Landowner/operator is responsible for properly placing the closer on the trailer and correctly installing the binding chains and binders.

The District:

The District is not responsible for operating or leasing out tractors to operate the Closer

The District will properly maintain and note any mechanical defects/problems before the Closer is rented.

The District reserves the right to cancel due weather, agronomics, and/or field conditions.

The Landowner/Operator hereby agrees to hold the District harmless from any and all claims for bodily injury or property damage resulting in any manner whatsoever from the operation, possession or participation of the leased Closer.
