C. 2025 Tree Program was proposed to work with North Platte NRD from Scottsbluff NE to bring trees in from Bessey Nursery. They have offered to let us purchase our trees through them, and they will store them for us if necessary, repackage them into bundles of 10 for the same price as they sell them for in their district. This allows us to fill orders for replacement trees, otherwise district members would have to purchase in lots of 25 and 50. The nursery used in 2024, pricing with shipping would cost 2 to 2 ½ times more doing a joint opportunity with NRD.
