## **Broadcaster/Seeder Rental Agreement**

The undersigned Landowner/Operator has requested rental of the Broadcaster from LFLCD, referred to in this agreement as the "District". Because of unpredictable weather and repairs, the District cannot adhere to a strict rental schedule. Your cooperation and patience will be greatly appreciated.

### **The Landowner or operator:**

To pay the District a Minimum rental fee of \$25.00 per 24 hour period. Pickup and delivery are the responsibility of the Landowner/Operator. Cleaning deposit \$100.

To schedule a rental, call (970) 534-5768 Tuesday thru Thursday 10-4. Rental periods not to exceed 72 hours unless prior arrangements are made.

The Landowner/Operator will exercise normal and reasonable care of the Broadcaster while in their possession.

The Landowner/Operator will make no repairs to the Broadcaster, they will notify the District Office of any problems. The Broadcaster will be parked until repairs can be completed. Any unauthorized repairs will be subject to having the Broadcaster inspected and evaluated at the Landowner/Operator's expense.

The Landowner/Operator will be responsible for any repairs that need to be made to the Broadcaster, because of misuse or abuse.

The Landowner/Operator will be responsible securing the Broadcaster and all parts to the trailer for transport.

### **The District:**

The District is not responsible for operating or leasing out tractors to operate the Broadcaster.

The District will properly maintain and note any mechanical defects/problems before the Broadcaster is rented.

The District reserves the right to cancel due weather, agronomics, and/or field conditions.
