
Meet our District Manager

Equipment Rental



Two no-till drills are available to assist with seeding pastures, testing alternative or cover crops, and improving soil health. Goshen County Economic Development Corporation grants helped fund the purchase of these no-till drills. These drills rent for \$12/day and can cover approximately 50 acres per day. Staff offers

delivery and calibration at your desired location.
