**Fire levy renewal:** The Union Fire Commissioners have authorized the placement of the fire levy renewal on the August 6, 2024 ballot. The fire levy renewal is \$1.50 per \$1,000 assessed valuation.

**Fire levy history:** The fire levy was established by the voters of Union in 1962 when the fire district was created.

**Fire Levy Importance:** The fire levy makes up 76.5% of our operating budget and funds both fire and emergency medical response programs. The Union Fire Department emergency programs are currently operating at the levels discussed below:

#### **EMERGENCY MEDICAL/FIRE RESPONSE:**

- All members are certified emergency medical technicians and internationally certified trained firefighters.
- Emergency response times average 5:30 EMS/6:49 Fire. (Fastest in Mason County)
- Two ambulances with state of the art medical equipment dedicated to serving the community of Union.
- Emergency medical response is fast with modern medical equipment. This allows for the greatest chance for positive patient outcomes during a medical emergency.
- With a fast fire response; life rescue is achievable and property loss can be minimized.
- All emergency response programs are operating well and will continue at or above current levels moving forward.

**What will this cost?** If approved by voters, the levy lid lift will renew the fire levy at \$1.50 per \$1,000 tax assessed value. This equates to \$19.58 per month for the owner of a \$500,000 home.
