

## **Protests in Los Angeles: A** Christian Call to Order Responsibility & Kingdom Authority




In early June 2025, Los Angeles—along with nearby cities like Compton and Paramount—has witnessed growing unrest following federal ICE raids targeting undocumented workers. What began as peaceful demonstrations has escalated into confrontations involving tear gas, burning vehicles, and the deployment of roughly 2,000 National Guard troops under a federal Title?10 order—an action that bypassed state consent and raised serious legal and moral questions.

1. Upholding Law and Order, Biblically Scripture emphasizes the importance of lawful conduct. Romans 13:1-4 teaches that governing authorities are instituted by God to maintain order and punish wrongdoing. When protests cross into violence—burning cars, hurling rocks at officers-they violate not only civic law but biblical standards of respect for authority. Leaders in Los Angeles have duly declared unlawful assembly zones and acted to disperse chaotic, destructive gatherings. Cont. Page 10



### S.F. Parents Dodge Bullet but not for long

"Grading for Equity," was set to launch this fall as a pilot program in 14 high schools in San Francisco. The initiative, spearheaded by Superintendent Maria Su, would have drastically changed how grades are calculated—eliminating homework, participation, and classwork from consideration and basing 100% of a student's grade on "summative" testing.

Passing thresholds would be significantly lowered...a C grade could be awarded for a score as low as 41, and a D for as low as 21 out of 100!

Not surprisingly, San Francisco Unified School District Test scores are in the tank! English/Language Arts (Reading, Writing, Spelling) test score is 53% of district students test at grade level or above, while only 45% test at grade level or above in Math. Seems that a more rigorous academic standard is called for...not a more forgiving rating scale!

District officials said the policy was designed to promote fairness and reduce bias in grading. Consultant Joe Feldman, a leading voice behind the initiative, has worked with other districts on similar reforms. The San Francisco Unified School District (SFUSD) had allocated \$172,000 for his services, pending board approval.

Parents rights activists are heralding the Informed Parents capability to deliver an OPT OUT Notice prepared by Pacific Justice Institute for a parent having a child in public schools in California. Now every parent of a public school child may OPT OUT his/her child from non-family friendly sex education, intrusive surveys, and non-parent approved counseling.

The plan quickly drew sharp criticism after it was first publicly reported. Critics—including San Francisco Mayor Daniel Lurie—accused the district of lowering academic standards and eroding student accountability. On social media and parent forums, many expressed concerns that the plan would harm student readiness for college and careers.

Adding to the controversy, the plan was not brought before the Board of

In response to the public outcry, Superintendent Su announced that the district would pause the initiative for at least another year. "I have decided not to pursue this strategy for next year to ensure we have time to meaningfully engage the community."

In the professional world, excellence is the standard...employers expect competence, accountability, and results. Shouldn't we hold our public schools, funded by taxpayers, to the same expectations? When a system lowers standards instead of raising achievement, it fails the very students it claims to support. Our children deserve better—and so do the families and communities counting on their success.

#### I have always admired my father, Robert H. Schuller, for his courage.

It was natural for me to step into his ministry of love and mercy, but courage? That was a step too far for me. Or so I thought.

Then, my grandchildren, who are homeschooled and in private Christian schools, started telling me things I had hoped they had been sheltered from. "What's going on Grandma?"

**It was clear that** there were no safe places anymore for the children.

**So, I had to decide:** stay in my comfort zone, or step into places that required courage.

## Taking a Stand for His Children

I read in Joshua 1:9 to "Be strong and courageous!"

**How could I, a grandma,** do or say enough, to rescue all the children from the pervasive attacks on their true identity — God's beloved children? But if I didn't take a stand, what legacy was I leaving?

**So, I found myself** as a Lead Intercessor for Jenny Donnelly's movement, "Don't Mess With Our Kids" (hervoicemovement.com). Jenny joined with Ross Johnston to take this movement to the streets of 5 cities in America: NYC, Miami, Houston, Seattle, and LA. LA was my city. My role was to lead a national prayer team from the safety and comfort of my home, praying over the other cities, in real time.

**In NYC, we prayed** for the torrential rain to abate enough for the children of the city to receive the donated bikes and the parents the message of Christ's love. It did. The rain abated. Miami and Houston were beautiful!


Then, Seattle! Over 400 protestors overwhelmed the police. Breaking

through the barriers, they became violent and publicly hurled abhorrent words and displayed deplorable acts in front of the children. We intercessors do not war against flesh and blood but against spiritual hosts of wickedness in the heavenly places. I will forever remember when the shift occurred, and the worship rose above the violence. And the park became infused with the sweet Holy Spirit of love and mercy.

LA was seven days later. LA required leaving my safe, comfort zone. Upon arriving there with my prayer team, we learned the city had not given us a permit. They had given a permit for the Pride parade the following week, but not for our Christian event.

Ross and Jenny prayed and decided that if the Pride parade had a right to the street, so did the church. So, all of us were informed we would be holding the event without a permit. This meant no barricades or police protection.

**So, along with 400 hundred others who came** out to take a stand for the children, this grandma stepped out



into Hollywood Boulevard. We stood in front of cars, drawing a line in the sand with our bodies: Enough is enough!

Our peaceful stance allowed many beautiful children in LA, to receive a bike, free haircuts, face painting, music, and the love of Jesus. Not to mention — their true identity as His beloved kids.

**These days call** for courageous stands. If not the church of Jesus, then who?

### Getting Christians to Vote is Key in California

Christians who choose not to vote have created a mess. California is a one-party state. It shows.

**California has a crumbling infrastructure.** Its water system, once the envy of the world, is being dismantled. Ditto schools. It has the highest poverty rate in the nation. Based on rate of incarceration, California looks like the Alabama of 1870.

**California leads the nation income disparity.** Its economy features exploiting noncitizens through human labor trafficking, offshoring jobs and wage suppression. Its forests burn. Voters can no longer count on free and uncorrupted elections.

**"Rendering unto Caesar" i**ncludes participating in the life of the community. That means paying taxes, obeying the law, serving on juries and in the military and, most significantly, voting. Christians who don't vote ought to view themselves as responsible for California's decline from Golden to Third World State. School kids suffer. Those in poverty and the homeless suffer. Families suffer. Unborn children never have a chance to live. The State's forests burn. Those who can, leave.

**Senator Ted Cruz put it this way,** "There are 90 million evangelical Christians in the United States, it's about 30 percent of our population. In the last election, 54 million evangelical Christians stayed home. If Christians will simply show up and vote our values, we'll turn this country around."

**He went further,** "The message my father conveys to pastors is that we have too many pastors hiding behind the pulpit who are afraid to preach the word of God, who are afraid to say to Christians, we have a scriptural obligation to be salt in the light, we have a scriptural obligation to be watchmen on the wall, and every one of us has a responsibility to be engaged in our public life, voting our values."

In 2018, Pastor Franklin Graham put it bluntly when he described the class that calls the political shots on today's west coast. "Progressive?" he said, "That's just another word for godless."

**According to the Pew Research Center, Christians** make up almost two thirds of California residents. Nationwide, an estimated 25 million Christians don't vote in presidential elections. 65 million do not participate in local elections. 15 million are not registered voters. California includes about ten percent of the nation's Christians.

**Working it out, if California Christians follow the national trend,** over two million California Christians will sit out the 2020 presidential election. Six and a half million will fail to vote in the next round of local elections. One point five million aren't even registered to vote.

If even a small portion of Christians who now sit on the sidelines got involved, the state would be transformed.

In June of 2019, David Clausen of the Family Research Counsel, put it this way.

"It is no surprise that withdrawing from the political process has become a temptation for many Christians. . . . Do we really need to get involved in the messy world of politics?" His answer. Yes, it is. "Engaging in politics," he writes, "is not only unavoidable, it is also an opportunity to obey God and show love to our neighbors. American Christians, with our right to vote, have a unique opportunity and duty to affect the political process."

**Dran Reese, of the Salt and Light Counsel, is on a mission to develop Biblical voters.** "Christians," she writes, "have written platforms on what they believe. This is called the Bible." Other voters rely on their own platforms. Low information voters listen to the media and "parrot what they say." Her guide suggests "Breaking free to become a true Biblical Citizen is to take your Biblical knowledge... and align to the party that most represents your faith and values."

Getting Christians to vote is possible. It is a necessary step in moving California out of its political dead-end.



## **Christian's First Amendment Rights Violated at Mayday USA Event by City of Los Angeles - Lawsuit?**

On May 31, during the Mayday USA event in Hollywood, the City of Los Angeles allegedly violated the First Amendment rights of a Christian group seeking to assemble and protest.

Mayday USA had applied for a permit to gather on Hollywood Boulevard to support parents and children and to celebrate their Christian faith through prayer, song, and baptisms. However, the City denied the permit, classifying the event not as a protest or assembly protected under the First Amendment, but instead as a concert or performance. Officials instructed the group to apply for a different permit through the Bureau of Street Services (BOSS), which handles permits for concerts and entertainment events.

The BOSS office subsequently denied the request, stating that they do not approve permits for protests or free speech activities—effectively leaving the group without a path forward. Organizers claim this is a tactic the City uses to discourage groups from exercising their constitutional rights.

Notably, the same type of permit requested by Mayday USA was approved for the LA Pride event the following week—at the same location and time—which also included community celebration and advocacy.

**Attorneys representing Mayday USA** argue that the City's actions amount to a clear violation of their First Amendment rights. The City later suggested the group apply for

a last-minute permit, which severely restricted their activities: baptisms were prohibited, and organizers were told that extended singing or speaking would not be considered protected speech under the First Amendment.

Mayday USA is currently exploring legal action against the City of Los Angeles in response to what they view as unconstitutional restrictions and discriminatory treatment.

California's public schools are falling short, jeopardizing both our students' potential and the state's future. #### **CONVERSATION WITH A MOM**

This afternoon, I received a call from a mother inquiring about how the CEO Act works and when it will take effect.

**After giving her a brief overview,** we discussed her family's situation. She and her husband have chosen to send their children to a faith-based school, which costs between \$1,200 and \$1,500 per month. Due to rising costs and inflation, they have had to cut back on their own food expenses to afford tuition. They also forgo vacations to prioritize their children's education.

I told her that she and her husband are remarkable parents for making such a sacrifice. Every month, they pay \$5,500 in tuition to keep their children in the school of their choice. Since this is after-tax income, they actually need to earn \$11,000 to cover these costs.

With the CEO Act providing \$17,000 per child annually for education, their family would free up \$5,500 per month—allowing them to save for retirement, take vacations, and ease their financial burden.

These are the families we are saving with the CEO Act.

It's painfully clear to us that African Americans today are grappling with monumental challenges. #### We must confront the critical questions head-on:

- 1. Is this disparity due to slavery?
- 2. Is this disparity due to racism?




#### **Victors or Victims?**

success. While many are familiar with the tragic burning of this vibrant community, few know that it rebounded fully within just two years. African Americans were not mere victims; they were true victors!

#### But what happened between that glorious era and now?

First, racists devised a new tactic to stifle black prosperity: The Minimum Wage. This law was specifically designed by the KKK and the Democrats to prevent black men from taking white jobs. With the minimum wage law in place, white business owners had no incentive to hire black men because they couldn't pay them less. The origins of the minimum wage are rooted in racism, and today, it continues to act as a barrier to wealth. Seattle mayor orders emergency curfew, calls upon National Guard after protests escalate

As Christians, we affirm the role of law enforcement—not as oppressors, but as instruments appointed by God to promote justice (1Peter 2:14). Yet with such power comes responsibility. It must be wielded judiciously, not abused. The careful distinction between peaceful protest and harmful unrest must be maintained. Upholding law and order is not about supporting one political side—it's about safeguarding peace, protecting innocent lives, and preserving the dignity of every person.

#### 2. Personal Responsibility to Do Right

Jesus calls us to live differently, reflecting kingdom values in even the most heated contexts. Amid protests, Christians—regardless of political stance—should embody restraint, compassion, and truth. We can speak out against injustice and stand with the vulnerable, yet do so peacefully and lawfully. Personal accountability isn't optional: Ephesians 4:31–32 urges us to "put away" bitterness, anger, and slander, and "be kind to one another."

Every believer has a role. Are we praying for our leaders—police, military, government—and for those who protest, that they may act righteously (1 Timothy 2:1–2) Are we stepping into community conversations with grace, not hostility? This crisis reminds us that faith is more than personal—it reshapes daily conduct, attitude, and interaction in times of tension.

#### 3. All Authority Belongs to Jesus

The core of our reflection is this: every governing authority falls under the

ultimate sovereignty of Jesus Christ. Colossians 1:16 reminds us that "all things ... are created through him and for him." In March 2025, as Los Angeles braced for the National Guard deployment—a move Governor Newsom vowed to legally challenge—the Christian witness must affirm that no regime, policy, or political agenda supersedes the Lordship of Christ.


This doesn't mean passivity in injustice. On the contrary, we pursue justice, mercy, and humility (Micah 6:8). But we do so while trusting that Christ is working across governments and conflicts to bring redemption and reconciliation.

The city is tense, lines are drawn, and communities are hurting. Yet Christians are uniquely positioned to respond:

- ■By supporting lawful authority—advocating peaceful protest, not lawlessness.
- ■By owning our personal responsibility—modeling kingdom values in word and deed.
- ■By proclaiming Christ's sovereignty—challenging factions that elevate mortal laws above the eternal Lawgiver.

As the LA and other protests across the country continue, may the body of Christ be a peacemaker, a bridge, and a voice of hope. We expose injustice, yes—but not by becoming unjust ourselves. We challenge authority, yes—but in a land where every ruler answers ultimately to the King of kings. In every instance, our call isn't to stir division, but to be salt and light—reflecting the sacrificial, reconciling heart of Christ in the public square.

The short answer is Yes. With California's open top-2 system, AND with 7 credible Democratic gubernatorial candidates splitting the vote in the June primary, it is indeed possible for 2 Republican candidates to lock out all the Democratic gubernatorial hopefuls. In that scenario, because there will not be a "write-in" option in the general election, a Republican is guaranteed to be the next governor.

Let's back up. In 2010, California passed Prop 14. Under Prop 14, candidates for all partisan offices (From state assembly to Governor) will compete in the jungle primary. The top 2 candidates, regardless of party affiliation, move on to the general election. THERE IS NO "WRITE-IN" option in the general election.

It is quite common for a blue district to have 2 Democrats, or for a red district to have 2 Republicans in the finals, (For example, in 2024, Republicans Dahle and Fennell faced off in the Republican majority Senate district 1.) Nevertheless, there is a path for 2 candidates of a weaker party to "lock-out" a district where the other party has a clear advantage, IF the stronger party has too many candidates splitting the votes.

**So far, Republicans** have been the primary victims of this: In 2022, 2 democrats "lock-out" 5 Republicans in the competitive 4th BOE District, which covers Orange County and San Diego County. Also in 2022, 2 Democrats, with 41% of the vote between them in the primary, "lock out" 6 Republicans in Senate District 4, a district considered a safe Republican seat.

**On the flip side,** Republicans ALMOST did it in 2014: In the statewide election for Controller, Republicans

## Can The 2026 General Election for Governor be between 2 Republicans?



Ashley Swearengin and David Evans came within 0.7% of being the only 2 candidates in the November General election. That was in an election with only 2 serious Democratic candidates, while 2 other minor candidates shared 10%. Swearengin went on to lose to Yee in the General election.

Now let us get back to 2026. As of today, SEVEN major Democratic Candidates have announced their candidacy to replace Gavin Newsom, who is termed out. They are: Former President of the State Senate Toni Atkins; Former State Attorney General and former Secretary of HHS Xavier Becerra; Current Lt. Governor Kournalakis; Elani former Congresswoman and favorite of Progressives Katie Porter; Current State Superintendent of Public Instruction Tony Thurmond, Former Controller and current state Democratic Party vice chair Betty Yee; and lastly former mayor of LA, Antonio Villaragosa, who has endorsement of Disney CEO Michael Eisner. YAY! (Meanwhile, Kamala is trying to court a couple of major donors. Donors are understandably leary after witnessing how she mishandled the finances of her last campaign.)

With a line-up like this on the Democratic side, 2 Republicans have a decent chance of locking out all SEVEN democrats in the primary and guaranteeing the governorship, if they can each get to 18% ~ 20% of the votes. The governorship in the most populous state would be hugely consequential (appointments, vetoes,

heads of key departments, national bully pulpit etc.) To make it happen, the Republican party needs to do 3 things: 1) Mobilize voters for the June Primary. 2) Fairly decide which 2 Republican candidates to support, 3) Strive for an even split of the votes between these 2 candidates.

1) mobilization, the GOP should aim to mobilize 4 million conservative voters for June 2026. It is hard: In 2022, the best performing Republican statewide candidate (Lanhee Chen for Controller) got 2.5 million votes in the June primary. But it is doable: Trump got 6 million votes in November 2024; even the cashstrapped campaign of Brian Dahle for Governor got 4.4 million votes in November 2022 against entrenched incumbent Newsom. 2) Focus on 2 candidates: This is just as hard: There will likely be up to a dozen Republican candidates signing up to run: Among them will be some with negligible chance of winning. But together they will take away somewhere between  $5\% \sim 12\%$  of the total votes. The 2 top Republican candidates need these votes.

The State election code makes it quite easy to run for Governor: a few dozen signatures and a few thousand dollars are all it takes to put one's name on the primary ballot. The CAGOP cannot stop them. Thus, CAGOP would need a fair and transparent process, a process that can attract both major and lesser candidates. Some of these candidates may opt for other local or

statewide offices. More importantly, the supporters of these lesser candidates could be convinced to NOT waste their votes in the primary. 3) Communicate. Once the 2 leading candidates emerge, the next step for the CAGOP would be to reach conservative voters with a straight forward plan: The Northern Counties (In Yellow) will mobilize for one candidate, while the Southern Counties (in Green) will mobilize for the other. The mission would be simple too: "LOCK OUT THE DEMS". The CAGOP can enlist the help of Conservative talk radios, YouTube Channels, and even major media institutions such as Epoch Times. The 2 candidates need NOT spend money fighting each other.

Instead, they can marshal their limited resources in their respective counties to focus on voter turn-out.A Course Correction for California? After 16 years of Democratic Governors, California could use sensibleRepublican governor to implement certain much-needed course corrections in this state. Admittedly, with a statelegislature likely in Democratic hands, any Republican Governor can only be effective if he/she focuses onpragmatic solutions with broad support. But winning Governorship still is a big deal. Could the StateRepublican party, under the new leadership of Chairwoman Corrin Rankin, pull off this groundshifting

# Apostle Paul: Authority on Sin or Unenlightened Ancient? -Acts 19:11-12 (NLT): "God gave

A popular cartoon drawing depicts a white sheep standing next to Jesus, who is embracing a rainbow sheep. The colorless one fusses about "the verses" while the Lord, crown of thorns atop his head, asserts that "love" transcends all.

Unsurprisingly, the alleged taboo verses aren't listed, so what exactly is the sketch referring to? The Old Testament addresses homosexuality (Genesis 19, Leviticus 18:22 and 20:13), but any words Jesus spoke concerning the

matter were never recorded. I believe the texts "in question" are by Apostle Paul (1 Corinthians 6:9-11, 1 Timothy 1:8-11, and Romans 1:18-32—I recommend reading these in the NLT, a version noted for accuracy). Other scriptures mention "sexual immorality" (Jude 5-7 references Sodom and Gomorrah), but these passages are more specific.

The conundrum is this: Was Paul representing the heart of God or not? Jesus never intended to live on earth for eternity. After his resurrection, he promised the Holy Spirit, so although he no longer walked here "in the flesh," he could still lead us. Christians are called to represent Jesus with our words and actions. Did Paul have the authority to speak for Christ, particularly in the category of sexual sin?

Here are a few examples (not a complete list) from Paul's life I propose authorized him to speak for Jesus (from the book of Acts):

- Jesus appeared to Paul (Saul) and questioned him about his persecution of Christians. From that encounter, Paul transformed into a bold evangelist, proclaiming Jesus as the Messiah.
- He preached the Gospel under threat of murder. Jews vowed to kill him. Mobs threatened attack.
- He performed many miracles, including restoring the ability to walk to a man who had been lame from birth.
- In Lystra, Jews stoned him so severely that they dragged his limp, presumed dead body out of town. He also suffered many other beatings and whippings.
  - He cast out numerous demons.
- He found himself arrested and thrown in prison multiple times because of the Gospel.
- **He raised a young** man from the dead.
- A poisonous snake bit him, but he did not die from the bite.

Paul the power to perform unusual miracles. When handkerchiefs or aprons that had merely touched his skin were placed on sick people, they were healed of their diseases, and evil spirits were expelled."

When Paul warned against homosexuality, was he simply unenlightened, blinded by the norms of ancient culture? God certainly planned to preserve Paul's letters for posterity. Would he have allowed the apostle to define sexual sin incorrectly (or fail to specify "overruling" forces such as "love"), resulting in endless confusion? I conclude the only reasonable answer is no. Yes, love is important; however, so is defining sin. Love compelled Jesus to submit to a brutal execution-because of sin. Especially in June during "pride month," may conservative Christians, unashamed and proud, stand on the truth of God's infallible word he spoke through his servant Paul.


As the author of Death As A Salesman, What's Wrong With Assisted Suicide, I am frequently called on to explain the inherent dangers of legalizing the practice of assisted suicide.

I have been on Dr.Phil's show twice. Each time as his guest, I was the only advocate for caring for, and comforting the patient instead of killing them. Each time, Phil and his producers stacked the other participants with advocates from the Death With Dignity crowd. In the most recent show, a woman with a disabling illness was seeking suicide. Sadly, instead of counseling her, Phil instead promoted and affirmed her depression. I felt Phil was violating the duty of a psychologist. Instead of redirecting her suicidal feelings, he affirmed her suicidal ideation, as did his other 'guests'." And yes, she then went to Switzerland and was killed there, by very dangerous and questionable death practitioners. The man who supervised her killing was then indicted by Swiss authorities.

**Personally, I find Phil McGraw** to be an affable man. Affable but deeply mistaken, and therefore dangerous. He likes being popular. He loves polling, he even took an audience poll that day. But It is very clear to me that his purpose was to position himself as a 'leader of the majority', a media icon.

He appears to follow polls and popularity rather than sound safety and protection of patients. And for a psychologist, that is truly shameful.

What many fail to understand is that in promoting and affirming such suicides, isolated and vulnerable viewers can easily be seduced by death's lure. Copy-cat suicide and suicide clusters are often directly linked to the errant promotion and commentary of suicide as a 'benefit.' Individuals who may view themselves as similarly situated, see the accep-



tance of suicide for that individual, and then justify suicide for themselves.

**Promotion on media talk shows** is bad enough. As early as 1989, the Center for Disease Control warned against even the reporting of suicides and how the article placement itself could cause suicide clusters and contagion. See Center for Disease Control, Suicide Contagion and the Reporting of Suicide. Recommendations from a National workshop, June 1, 1997.

If you or a loved one are facing a difficult, seemingly insurmountable situation, suicide is never the answer. Good, ethical medical care can address the deeper emotional issues that lead to suicidal ideation. Depression can be treated, and treated effectively, even if an underlying physical condition may linger.

See good doctors. Counsel with good counselors. Don't get your values from the television set.
