



ing God can lead to a soul weighed down with regret?







President Trump's recent moves in Washington in the education arena have kindled the flame of hope for parents in education. His ExecutiveOrders regarding men in women's sports and the ridding of the federal government of DEI (Diversity, Equity, and Inclusion), signals a return to common sense.

**But before we launch the tickertape parade,** we must remember that education is a local endeavor. Education decisions are made at the local level by school board members based on state law and community input. Curricula guidelines are mandated by the state legislature and adopted bylocal school boards.

The federal government provides incentives as it did with Common Core and can withhold funds for specific purposes or educational programs such as compliance with Title IX. It does not mandate that certain subjects or curricula be taught. It does make funding available to local schools if certain actions or subjects are undertaken or taught. Generally, federal involvement follows the carrot rather than the stick approach.

If we wish a say in how our children and grandchildren are educated, our eyes must stay focused on our local school board. The school board sets class sizes, determines fiscal

issues such as teachers' salaries and which schools will be open or closed, adopts policies governing the actions of school personnel, determines which books will find a home in their school libraries, and, in accordance with state law, determines the curricula taught in our children's classrooms.

# OPT OUT in the News! U.S. Supreme Court Hears Maryland Case Parents Right to OPT OUT Their Children

In a Maryland case, the U.S. Supreme Court is weighing the extent to which parents can opt their children out of public school instruction in which LGBT-themed books are read as part of the curriculum. Informed Parents is closely watching this case. In 2024, Informed Parents partnered with Pacific Justice



Institute to facilitate the ability of every parent of a public school student in California to OPT OUT of pleasure-based Comprehensive Sexuality Education, intrusive surveys, and third party counseling (Planned Parenthood, etc.) without the knowledge and permission of parents.

To date, several hundred parents have taken advantage of this OPT OUT Service provided by Informed Parents


and Pacific Justice Institute. To make this service available to every parent of a public school child in California necessitated the creation of an extensive software program and database containing the name and contact info for each school, school principal, and school district superintendent in California.

Not surprisingly, this program and database requires constant review and updating. Additionally, Informed Parents created a **Parents OPT OUT Hotline** to answer parents questions and provide a reporting venue for parents whose schools and districts are not allowing them to exercise their OPT OUT rights. Watch for Informed Parents "California School OPT OUT Campaign" launching in May to inform parents of their right to OPT OUT their child.





# Weaponized Chaos Against Trump's Agenda



We are witnessing a historic event never before achieved per President Trump's first one-hundred days in office. Victor David Hanson, of the Hoover Institute, summarized it best in his podcast on YouTube.

# Duties of the Civil Magistrate, and Citizens under them

#### **Nullification vs interposition**

We will begin this second installment with a brief definition of terms, starting with 'nullification' and 'interposition'. Put briefly, nullification is the legal result of sufficient/successful interposition. Stated differently, once you have interposed effectively enough, that interposition then bears the ripe fruit of nullification. In turn, nullification is when a law is ignored. It is unenforced, and assuming a righteous act of interposition (and further assuming the backdrop of a righteous justice system), unenforceable.

Now that we have defined nullification with respect to interposition, we must define the latter term itself. To interpose means to "come in between." Okay, come between what? In the Doctrine of the Lesser Magistrates this means between a lower authority, and a higher authority. The lower steps

in to defend the rights and dignity of a citizen against a higher authority.

Higher? Lower? Lets look at layers of government. If you arent aware, we here in the USA have been blessed with many layers of government. They are (from small to big): individual, family, church, neighborhood, town/city, county, state, country. For interposition to take place, a smaller unit of government must come between a larger unit of government when that larger unit seeks to deal unjustly with an individual. Got it? Now you know what interposition is!

What is unjust? What is just? The last half of this article will seek to provide a rudimentary answer to those questions.

The act of interposition is an expression of righteousness. Any system of law, if it is to have metaphysical/spiritual standing in the hearts of men, must be based on God's Law. Any other standard will war against the conscience and nature itself. The Declaration of

Independence refers to God's Law as "The Laws of Nature." Scripture refers to God's Law in James 1:25 as the "perfect law of liberty". Other translations call it the "perfect law of freedom." Liberty and freedom are very similar words, and they are the very prized possession of many Americans. Thank God!

What about wicked men? Surely God's Law doesn't have any standing with the wicked? Well, it actually does! I encourage you: set aside 10 minutes to ponder Romans 1 very carefully. To that end, I highlight a few verses:

Verse 18 says the wicked suppress the truth. This implies that the truth is always pressing upon the hearts of even the most vile, as they push back.

Verse 19 is extremely explicit in stating: "What may be known about God is plain to them, because God has made it plain to them." Read that one slowly. God has been made plain to all. They don't need to set foot in a church, they don't need a fog machine or a synthesizer, or a piano, or a

stained glass window... they just need to look around them, in any direction. What may be known about God is plainly seen, even for the wicked. Okay, before you get too skeptical or too curious about how God accomplishes this, read the next verse

Verse 20 states that God's invisible qualities are understood from His workmanship. Look at a sunrise, look at your hand, your family members, your dog. That's Gods workmanship. Everyone on earth is constantly facing a revolving showcase of His works. (It is also for this reason why the wicked attempt to hide from God within urbanized areas, where His workmanship is on less of a grand display, as it becomes obfuscated by the handiwork of men.)

Back to interposition. We have seen that even the wicked have a sense of justice. Righteous interposition, will often garner support. We have to be faithful and obedient to God's Law and uphold it for His name's sake. Many will come to our aid. Even nature continues to lend itself to the cause of righteousness. We must encourage our elected officials to interpose against what is unjust.

# The Birth of Christ and the Birth of America

One of our most extraordinary founding fathers was John Quincy Adams. At eight, he was drilling with the Massachusetts Minutemen. At ten, he was in Europe with our diplomats. At 14, he was secretary/translator for our Ambassador to Russia. At 16, he was part of negotiations to end the Revolutionary War.

He attended Harvard and graduated in two years. He served as U.S. Minister to Holland, Prussia, Russia and Great Britain. He negotiated the treaty which ended the War of 1812. While secretary of state he authored the Monroe Doctrine. He acquired Florida and settled the border dispute in Oregon Country.

HE WAS ONE OF THE MOST ACCOMPLISHED AND SUCCESSFUL SECRETARIES OF STATE IN AMERICAN HISTORY.

After serving one term as president he went on to serve two decades in the House of Representatives. In 1841, he argued the Amistad case before the Supreme Court and won the release of enslaved African captives. His entire life was devoted to public service. On July 4, 1837, John Quincy Adams spoke these words: "Why is it that, next to the birth day of the Savior of the world, your most joyous and most venerated festivalre

turns on this day?"...Is it not that, in the chain of human events, the birthday of the nation is indissolubly linked with the birthday of the Savior?

# THAT IT FORMS A LEADING EVENT IN THE PROGRESS OF THE GOSPEL DISPENSATION?

Is it not that the Declaration of Independence first organized the social compact on the foundation of the Redeemer's mission upon earth? That it laid the cornerstone of human government upon the first precepts of Christianity, and gave to the world the first irrevocable pledge of the fulfillment of the prophecies announced directly from Heaven at the birth of the Savior and predicted by the greatest of the Hebrew prophets six hundred years before? # **The Trump Tariffs: Are** they a threat to our economy?

President Trump has raised the conversation on the use of tariffs in America. This has raised a tremendous amount of conversation and fear about the impact on our economy.

As we listen to the media and news commentators, one would think that consumers are going to pay the price at the cash register. One criticism is that tariffs represent a tax that will burden the poor and middle-class consumers.

However, we have a history of President Trump using tariffs between 2015 and 2020-in a period in which the economy had been the most robust in decades. So, what's the buzz all about?

#### **History of Tariffs in America**

In 1789, Alexander Hamilton, the Secretary of Treasury proposed that tariffs be levied on imports of various goods. As a result, the Tariff of 1790 was approved by the Senate on August 10, 1790.

As a result, enough revenue was raised to pay for US operating expenses, and "to repay an estimated \$75 million in foreign and domestic debt."

#### **Economists Disagree**

Policymakers and economists have stated in the news and business reports that tariffs can hurt consumers. They have argued that President Trump will slow economic growth. Economists strongly disagree, saying that "tariffs will increase inflation, slow economic growth, hurt U.S. workers and result in American consumers footing the bill for his tariffs."

However, this wasn't the experience of the first Trump tariffs.

#### What is a Tariff?

An introductory economic text defines a tariff as a tax imposed on a good when it crosses a national boundary. As a result, the prices of affected goods will increase.

One result of this effect is that the volume of imported goods will fall.

And the country imposing the tariff will see an increase in production of those goods within the country imposing the tariff.

However, most news reports stop here, with the text-book definition of a tariff.

#### So, what's all the buzz?

Are tariffs harmful to the consumer? In some industries, they may be. To answer this question, let's take a deeper dive into how tariffs are applied, and where is the payment made.

Tariffs are a tax on imports, and not on the finished product purchased by the retail consumer. Suppose there is a 10% tariff on all computer components

Here is an example of how tariffs are applied. Let's look at a popular PC mouse that one might purchase at Best Buy for \$30, a typical retail price. Best Buy will purchase a container of PC mice for distribution to their Best Buy stores. The buyer will buy the shipment from a wholesaler.

Suppose the wholesaler imports the shipment from Shenzhen, China. The price per unit is \$2.50. Therefore, the tariff is applied to the value of the imported product at the port of entry. In this example, a Customs and Border Protection (CBP) agent collects the tariff, and the money is deposited into the U.S. Treasury. The US will receive twenty-five cents for every PC mouse imported. The mouse is then sold to the retailer, and the retailer will sell the mouse for \$30.25, a slight increase to the total price of less than 1%.

#### **Benefit to America**

Over time production will move to America, and jobs are then created in America. Products with national security implications will move back to America for production. With President Trump's emphasis on developing AI and goals to enhance our military, the need to onshore the production of semi-conductors, silicon chips, and computers is of paramount importance if America is to remain on the cutting edge and the leader of the free world.

In most cases, the consumer will not have to pay significantly more at the cash register. The benefits of tariffs look to outweigh the costs as we have seen in 1789 and in the most recent years of 2016 to 2020 when President Trump successfully applied tariffs.

# Politically Correct? I Politely Decline

**Growing up, I was taught to avoid two topics of conversation:** religion and politics. Yet, even a casual study of history shows that these two spheres are all-too-common sources of human oppression.

#### Perhaps these are the most important subjects to talk about.

Our public dialogue is painfully watered down. It has become fashionable to champion "human rights" without acknowledging the Creator who gave us those rights. It's trendy to promote "tolerance" with no mention of foundational morals, such as charity and sacrifice. We enjoy the benefits of prosperity and freedom and yet fail to trace these blessings to their source.

The American founders succeeded against overwhelming odds not because of good intentions, but because of their overwhelming commitment to a righteous, reasonable God. They took a cue from their mentors, many of whom were pastors—the moral leaders of their day. As the Rev. John Witherspoon said in May 1776, "There is not a single instance in history in which civil liberty was lost, and religious liberty preserved entire."

**Everywhere, Christians face demands for silence.** We must defend truth and freedom by speaking out. Rather than concede, we must rebuff the rising tide of political correctness. Political correctness is nothing new; it was part of the social landscape in Lincoln's day, and Churchill's, and Reagan's. Will our opponents belittle our arguments? Undoubtedly. Will they blame us for the failings of society? Most certainly. But we cannot afford to be silent.

When people of conscience hold their tongues, the wicked are emboldened and evil wins. As the Apostle Paul reminds us, we "wrestle not against flesh and blood," but against spiritual powers and rulers. Thus, the New Testament writer urges his readers to "demolish arguments and every pretension that sets itself up against the knowledge of God." Christ wasn't silent before the Pharisees (nor was Lincoln before the slaveholders). Rather than backing up and blending in, people of faith are called to be salt and light in a dark world.

We can take such a bold stance only with prayer for God's help and mercy. Benjamin Franklin noted at the 1787 Constitutional Convention, "If a sparrow cannot fall to the ground without [God's] notice, is it probable that an empire can rise without [His] aid?" We need to pray for our families, and we need to pray for the church.

Many pastors no longer teach the concept of immorality; their houses of worship have become merely seeker-sensitive and user-friendly. Meanwhile, the very foundations of our society are destroyed for a lack of knowledge of Biblical principles. We must return to the Scriptures and to faith. As the Rev. Samuel Kendal warned in 1804: "If we depart from the principles of our ancestors, neglect religion and its institutions, are not attentive to the instruction of our youth in religious and moral duty ... we shall soon find ourselves unable to support the constitutions which have been the pride of our nation, and the admiration of the world."

Truly, our American heritage—the great experiment in self-government—is both wonderful and noble. The principles contained in our founding documents led to the abolition of slavery under the leadership of Abraham Lincoln, who

finished the Constitution's "magnificent structure" (to borrow a phrase from Frederick Douglass). We can also be proud knowing that the United States has set more people in other nations free than any other nation in history. But we cannot expect to continue this legacy if we insist on being morally neutral.

**U.S. Rep. Fisher Ames said it well over two centuries ago:** "All history lies open for our warning, open like a church-yard, all whose lessons are solemn ... lessons that whisper, O! that they could thunder to republics, 'your passions and vices forbid you to be free.'"

May people of faith in our day be willing to stand and speak where the flames are the hottest and the stakes are the highest.

My God does the impossible.


My God loves and will go to all lengths to rescue and deliver His children.

To pray for limitless faith.



How to Stop Corruption and Gain Efficiency in Government: Introducing Self-Regulating Feedback Loops

# THE POWER OF SELF-REGULATING FEED-BACK LOOPS (SRFL)

What keeps a gas heater from becoming a deadly hazard? The answer is a thermocouple—a small device made of two metals that expand and contract at different temperatures. It ensures that if the pilot light goes out, the gas supply is automatically shut off. This process happens without the need for external monitoring or oversight. The system is self-regulating.

We see similar mechanisms in electronics as well. For example, if a phone overheats, a built-in fuse will disconnect the power until it cools down. You don't have to worry about it—it just works.

Even in more mundane situations, self-regulation is apparent. How do two kids share a candy bar fairly? Simple—one cuts, and the other gets the first pick. The child doing the cutting knows that if they're unfair, they'll end up with the smaller piece, so they're incentivized to be precise. It's a built-in feedback loop ensuring fairness without the need for adult intervention.

#### **Applying Self-Regulating Feedback Loops to Government**

What if we could apply these same principles to government? Instead of relying on external audits or investigations—who often have little to lose—what if laws were designed to self-correct? If each party involved in a law had something to gain, but also something to lose if they failed to meet their responsibilities, we could dramatically reduce corruption and inefficiency.

Legislators should be asking themselves: How can we design laws that automatically regulate themselves?

Here are a few ideas on how we might implement Self-Regulating Feedback Loops (SRFL) to improve the government:

#### 1. First to Report Corruption Gets the Money

Corruption thrives when silence benefits everyone involved. But what if we flipped the incentives?

Imagine a politician accepts a \$50,000 bribe from a contractor. What if the first person to report the bribe gets to keep the money? If the politician reports it first, they keep the bribe, while the contractor loses their contract, faces an additional fine, and goes to jail. The politician also keeps their job and reputation.

But if the contractor reports it first, they get to keep their contract and earn double the bribe amount as a reward. The politician, in turn, goes to jail for five years.

If a third party—say a janitor, a junior employee, or anyone with proof—reports the corruption, they would receive 200% of the bribe amount, while both the contractor and politician face prison time.

This creates a race to expose corruption, as no one can trust anyone else to stay silent. In this model, the system polices itself. Everyone has an incentive to act honestly and expose wrongdoing.

#### 2. Government vs. Private Competition

Government inefficiency is often due to a lack of competition. When a government agency fails to meet its targets, it simply demands more funding to continue. But what if we changed that?

Under an SRFL model, government departments would publicly post their budgets and performance milestones, making them transparent. Private companies and individuals would be incentivized to monitor and report on the perfor-

mance of these agencies. If a department fails to meet its targets, funding is automatically redirected to a private company that can perform the work more efficiently.

Take the example of New Orleans after Hurricane Katrina, where reconstruction was delayed because government officials wouldn't issue permits. If an SRFL were in place, the department head would be required to publicly post timelines, such as "100% of permits will be issued within two weeks." If they failed, private companies could immediately take over the contract. The officials responsible would face demotion and pay cuts, ensuring accountability.

Additionally, a secondary SRFL would reward citizens who prove a permit was wrongly issued, with the responsible official facing consequences.

If a department fails three times, it's permanently replaced by private competition. This approach forces public agencies to compete for efficiency, just like private companies.

#### 3. SRFL in Government Contracting

In government contracting, losing bidders typically walk away, but they could be part of the solution.

Under an SRFL system, losing bidders would become unpaid monitors, incentivized to catch failures by the winning contractor. If the primary contractor misses deadlines or delivers subpar work, the losing bidder would take over and receive the remaining payments. The original contractor would forfeit their payment for that phase and be banned from future government contracts for three years.

Additionally, every contract would include an SRFL clause: if a contractor exceeds their budget or timeline, they would be permanently banned from future government work. Fraud would be punishable by prison time, and every milestone and deliverable would be made public. If any citizen identifies a failure, they would receive 5% of the bid amount as a reward, and the company would lose the contract.

This would transform the internet into a vast network of watchdogs, making it impossible for contractors to evade accountability.

#### 4. Tying Budgets to Performance

Government agencies often receive the same funding year after year, regardless of their performance. Why is this the case?

Instead, a portion of each department's budget should be tied to measurable outcomes. If an agency meets or exceeds its goals, it should receive additional discretionary funds. If it fails to meet its targets, its budget would be cut. Agencies that consistently fail would have their services opened to private bidders.

This model has already been successfully tested in some cities that outsource public services to competing private firms, achieving higher efficiency at lower costs. Expanding this approach would ensure taxpayer dollars are being used effectively.

#### 5. Tying Congressional Pay to Performance

Why should Congress be exempt from self-regulation? The pay of lawmakers should be directly tied to fiscal responsibility.

If the government runs a deficit—even by \$1—congressional pay should decrease by 33%. If inflation exceeds 3%, their salaries should decrease accordingly. But if Congress returns a budget surplus to taxpayers, they should receive a proportional pay raise for that year only.

This would create an incentive for lawmakers to balance the budget, control inflation, and be more fiscally responsible. Congress should have as much to lose as the rest of us.

Self-regulating feedback loops are not just a theoretical concept—they already exist in nature, engineering, and even in the way children negotiate over candy bars. So why aren't we applying these principles to government?

Every law passed is an opportunity to embed an SRFL. A competent legislator can refine these ideas, and former government employees know exactly where these mechanisms are needed most.

The question isn't whether we can eliminate corruption and inefficiency. The real question is whether we are willing to design systems that automatically eliminate them.

I challenge legislators: Think in feedback loops. Every time you write or support a law, ask: How can we make this law function like a thermocouple or a fair candy bar split?

When we build laws that enforce themselves, we create a government that is efficient, transparent, and accountable to the people. This is the true foundation of a government of the people, by the people, and for the people.

# Legislation to Enhance Transparency and Provide Parental Due Process Rights Introduced in Alabama

SALEM, OR. – Pacific Justice Institute is headed back to the Oregon Court of Appeals for Round 2 in its fight for a Christian healthcare worker who was denied unemployment benefits on multiple occasions after declining to receive a COVID-19 vaccine.

The Pacific Justice Institute – Center for Public Policy (PJI-CCP) is continuing its mission to protect parental rights through the introduction of HB 340 in Alabama by Representative Kenneth Paschal (R-District 73). The bill, called the "Department of Human Resources Transparency and Due Process Rights Notification Act," aims to safeguard the rights of parents and legal guardians during child welfare investigations.

Child welfare investigations carry one of the most extreme consequences imposed by the state – the potential termination of the relationship between a parent and child – yet existing law provides few procedural safeguards. Numerous parents have reported feeling pressured – or even coerced - into unfavorable "agreements" due to social workers and investigators capitalizing on their lack of knowledge regarding their legal rights.

PJI-CCP worked with Rep. Paschal, DHR and other organizations and stakeholders on the bill's language. "The U.S. Supreme Court has continuously afforded parental rights the highest legal protection available, however, basic practical protections for families suddenly immersed in the complex child welfare system are inconsistent at best," said Brad Dacus, President of PJI. "It is crucial to inform parents of their rights from the very start of a child welfare investigation in order to safeguard their parental rights."

# Specifically, the bill requires the following:

DHR to notify a parent or individual with legal custody that he or she is under investigation;

DHR to provide the parent or individual with legal custody with a written explanation of his or her due process rights, such as the right to review certain records, the right to retain counsel, and the right to seek an administrative review of investigation results; and

DHR to offer family preservation services before a child is removed from the home, with certain exceptions.


Additionally, under HB 340, DHR would be required to develop uniform rules and regulations concerning the notification requirements of the legislation and require DHR employees to undergo training.

The Alabama Federation of Republican Women and the Alabama Republican Party State Executive Committee have already passed resolutions in support of HB 340. The bill is currently pending before the Alabama House Committee on Children and Senior Advocacy.

**Pacific Justice Institute** – Center for Public Policy Urges Illinois Lawmakers to Oppose Burdensome Restrictions on Homeschooling Families

#### March 25, 2025

SPRINGFIELD, IL – Today the Pacific Justice Institute joined thousands of families to urge lawmakers to stop legislation attacking private and home schools in violation of parental rights and religious freedoms. As amended, House Bill 2827, the "Homeschools Act," is a 60-page measure that would create new requirements for private schools and homeschooling families



to report their educational activities to government authorities.

# The bill would establish requirements for parents to meet to homeschool their children and if they do not com-


ply, they could face up to a Class C misdemeanor, punishable by up to 30 days in jail, or removal of the children from their home. "House Bill 2827 is an assault on the long-recognized foundational principle that parents are the primary educators of their children," said Brad Dacus, president and founder of PJI. "For 100 years, the U.S. Supreme Court has recognized a parent's right to decide their child's education."

Additionally, House Bill 2827 would require all elementary and secondary private schools - including religious schools - to register annually with the state and report detailed personal information on all enrolled students. There are no guidelines within the bill to regulate how the collected information would be used, stored, or accessed, making it ripe for government abuse. Despite 90,000-plus public declarations of opposition, the measure passed out of the House Education Policy Committee by a vote of 8-4 along party lines with 1 committee member voting present. The bill now is before the full House of Representatives for a vote. "PJI has been advocating for homeschooling families since its inception and is firmly committed to continue to fight against this attempted governmental overreach as it is considered by Illinois lawmakers," Dacus said.





In 2025, over a lunch, Pastor Sam Gallucci of Embrace Church in Oxnard, California shared how he is transforming church sanctuaries and social halls into schools. These spaces, unused during the day, provide an ideal setting for education.

This innovative approach revives the once-popular 19th-century one-room schoolhouse model that served as the foundation of America's education system. Historically, farmers sent their children to these schools, where a single teacher educated multiple grade levels. Today, this model is experiencing a renaissance.

During the era of the one-room schoolhouse, America had the highest literacy rates, according to the Armed Services Vocational Aptitude Battery (ASVAB), a standardized test used to assess skills and aptitudes for military careers. At that time, American students mastered reading, writing, spelling, math, history, and civics—academic competencies that many students today struggle with.

Pastor Gallucci's model offers parents an alternative to California's struggling public schools. His school recently admitted four ninth graders from the Oxnard school district who.

despite attending public school since kindergarten, are completely illiterate. He is baffled at how these 14-year-olds were promoted through the system without the ability to read.

The California Assessment of Student Performance and Progress (CAASPP) reveals a widespread problem in the state's public schools. This standardized test evaluates student proficiency in English Language Arts/Literacy (ELA), math, and science. In the 2023-24 school year, CAASPP results showed that 44% of 11th graders could not read proficiently, and 72% could not perform grade-level math. Despite this, these students graduate with limited job prospects, often relegated to minimum-wage jobs.

California's public education system was once among the best in the nation. Fifty years ago, it ranked at the top. Today, it ranks near the bottom in reading, English, and math. This decline has persisted for decades, with no clear plan from Sacramento or local school districts to reverse the trend. Yet, public school supporters continue advocating for the same failing system.

In 1988, the California Teachers Association promised that increased funding would reverse this decline. CTA said, "We need more money." Voters responded by passing Proposition 98, which guarantees 39% of the state budget for public education. This equates to \$23,000 per student annually from kindergarten through 12th grade. With an average class size of 30 students, each classroom receives \$690,000 per year. However, despite teachers

earning an average salary of \$92,000, little of the remaining \$598,000 benefits students directly. Instead, much of it funds non-teaching staff and high-paid administrators, with over 50% of public school employees not being teachers.

To address this crisis, a historic initiative is set to empower parents: the Children's Educational Opportunity (CEO) Act. This statewide initiative, scheduled for the November 2026 ballot, aims to revolutionize California's education system by ensuring every child, regardless of race, income, or zip code, has access to quality education.

Under the CEO Act, every K-12 student in California will have the option to open an Education Savings Account (ESA) funded with \$17,000 annually, tax-free, from Proposition 98 funds and without rasing taxes. Parents can use these funds to select the best educational environment for their child, whether it be public school, charter school, private school, faith-based school, or homeschool. This places educational decisions in the hands of families rather than bureaucrats and politicians.

Former Thousand Oaks Mayor Kevin McNamee stated, "Students from wealthy families have access to all educational opportunities, while low- and middle-income students do not. A quality education should not be a privilege of the wealthy—it is a right for every child. The CEO Act ensures both equality and equity by providing every student with the same financial resources to pursue the best education available."

Any unused ESA funds roll over annually, earning interest that can be applied to future education expenses. After high school, unused funds can be used for trade schools, community colleges, universities, or postgraduate programs for the student's lifetime. Additionally, students can transfer unused ESA funds to a family member's account, similar to a 529 college savings plan available to wealthier families.

# California's "Great Awakening"

# Some are calling it, "The Great Awakening."

The latest <u>voter registration report</u> from the California Secretary of State shows that Republicans increased the number of registered voters in every single State Assembly, State Senate and Congressional District.

# The GOP also gained ground in all but two of California's 58 counties.

Overall, Republicans gained 46,000 registered voters statewide, while Democrats lost 30,000. Even the number of No Party Preference voters dwindled by 70,000 registered voters.

# Jack Fennell, a 22-year-old resident of Anaheim, noted that Democrats are losing the support of Gen Z voters.

An <u>AtlasIntel poll</u> released in March shows that approval for President Donald Trump among 18–29-year-olds soared to 52.7 percent in February from a net approval rating of -<u>17.4% in January</u>.

In the <u>Spring 2025 Yale Youth Poll</u>, Gen Zers said they would favor a Republican candidate in the 2026 congressional elections by an astounding 11.7 points. Trump even <u>picked up 11 points</u> from 2020 to 2024 among young women.

While those in his age group had always leaned liberal, things began to change during the COVID lockdowns when massive numbers of young people began protesting.

# "I started to realize that these people were all in their 20s and 30s, with flags and banners to protest the curfews," he recalled.

While Californians were forced into lockdowns and curfews, Newsome <u>attended</u> <u>a dinner party</u> at one of the world's most exclusive restaurants. Three days after <u>dining at the same restaurant</u>, San Francisco Mayor London Breed banned all indoor dining in the city.

While California's businesses were closed to the general public, former Democratic House Speaker Nancy Pelosi was <u>caught visiting a shuttered salon</u> in San Francisco for a wash and blowout.

#### "People are starting to see the hypocrisy," Fennell said.

While some Californians are switching political allegiance, a record number of residents are simply leaving.

Between 2023 and 2024 California lost a total of 239,575 residents to other states, accounting for the largest net domestic migration loss in the country, according to data released by the Census Bureau. The mass exodus has been going on for five straight years, and it's far from over.

An October <u>survey</u> by Emerson College revealed that 56% of California's remaining residents have also considered leaving, with most citing the high cost of living.

While Republicans still have an uphill battle for control of California's political seats, it's becoming increasingly more evident that its <u>voters are not as lockstep liberal</u> as many assume.

Evelyn Jones is a conservative political activist in California. She's also a Republican delegate and was a national delegate for President Trump at the Milwaukee RNC convention. Jones, who has lived in California for most of her life, came to the United States with her family from El Salvadore when she was seven-and-a-half years old.

"We all want to attain the American dream," Jones said. "And I think that's the spirit of America that we need to share with our younger generations."

However, Jones said that American Dream has become a nightmare in California, citing crime, homelessness, drugs, and parental rights as major contributors.

#### **Crime and Drugs**

California boasts that violent crime <u>declined</u> by 4.6% in 2024, and property crime decreased by 8.5%. However, the lower crime rates may have more to do with <u>inaccurate or incomplete</u> reporting by many of California's law enforcement agencies, or because many have stopped reporting crime data to the FBI altogether.

California's businesses suffer the most.



While data from San Francisco's authorities show that crime <u>decreased</u> in 2023, the filth and state of neglect of its downtown, and a record-high number of <u>vacant office spaces</u>, has exacerbated the already high levels of homelessness, drug use, and crime.

According to the Public Policy Institute of California, California saw a 28.7% increase in shoplifting in 2022 from 2021 and 2020. In September 2023, <u>Target</u> announced that it was closing down several California locations over concerns of a rise in retail theft.

The San Diego Post <u>reported</u> in April that the surge in retail thefts cost California businesses about \$4.4 million in 2024.

High-end stores are also being targeted by gangs of thieves with destructive, expensive smash-and-grab, and <u>flash-mob robberies</u>.

Mindy Pechu, a former candidate in the special election for the mayor of Oakland, blames the decline of her city on the Democrats who hold power. Crime has gotten so bad in her city that businesses are fleeing.

NBC Bay Area <u>reported</u> in 2024 that restaurants—like Denny's, Starbucks, Black Bear Diner, Taco Bell, In-N-Out Burger, and Subway—have closed their locations in Oakland out of fear for staff safety. Companies like Clorox, Kaiser, and Blue Shield were forced to enact measures to ensure the safety of their employees.

Newsweek <u>reported</u> that retail stores like Target, Nordstrom, and Macey's have also fled Oakland because of the crime.

"Oakland is very controlled not only the Democrats, but by the globalist culture, and they've destroyed it over decades," Pechu said.

"Oakland was phenomenal," she explained, recalling the glory days of the industrial city when the Chevrolet Assembly Plant was humming with productivity, and the city was thriving.

"Now you go through there, and there's garbage in the streets, drugs everywhere, guns everywhere," she lamented. "You wouldn't recognize it as a city in the United States."

Then there's the drugs.

<u>Data</u> compiled by AddictionGroup.org shows that California's illicit drug use rate has stood at 10.47% since 2010, surpassing the national average of 8.82%.

CalMatters <u>reported</u> in December that overdose deaths at California worksites is on the rise, surpassing the number of fatalities dure to accidents. In 2022, 110 workers died from drug overdoses, accounting for 18% of the Golden State's workplace deaths. That's seven points higher than the national average of 11%.

In March, San Francisco's Office of the Chief Medical Examiner announced that more than 600 people died from a drug overdose within the city from synthetic drugs like <u>Xylazine</u>, <u>Bromazolam</u>, and fentanyl.

The County of San Diego <u>reported</u> in November 2024 that the proportion of opioid overdose visits to emergency rooms increased by 12%, with fentanyl attributing to 27% of the opioid overdoses, an increase of 17% from Q3 2021 to Q3 2024.

In August 2024, California Gov. Gavin Newsome <u>announced</u> the seizure of nearly 2.5 tons of fentanyl powder and over 8.8 million pills at California's ports of entry in the first eight months of that year— "enough to kill one in every four California residents."

#### Homelessness

In March, the Public Policy Institute <u>reported</u> that 187,000 people were homeless in California, accounting for 24% of the nation's homeless population. Of those, 123,423 individuals were literally living on the streets, making



California the state with the highest rate of unsheltered homelessness in the nation.

Along with having the highest number of homeless people, California also has the highest number of illegal immigrants, <u>2.6 million</u> of them, with an annual cost to California taxpayers of around <u>\$23 billion</u>. Add the children, and that cost jumps to <u>\$30.93</u> billion.

Jones blames Newsome.

"He's not taking care of his citizens," Jones lamented. "He wants to take care of the people who aren't citizens, and I think everyone sees that. We're paying more for everything because he wants to protect non-citizens, and we don't understand what his obsession is with that."

#### Parental Rights

Another factor contributing to "The Great Awakening" is the fight for parental rights.

While an October 2024, Deseret News/HarrisX <u>poll</u> showed that a vast majority of Americans strongly oppose having their children exposed to graphic sexual content in schoolbooks, transgender ideology, boys in girls bathrooms and sports, and having their children embracing preferred pronouns and alternative genders, a 2023 <u>Spry Strategies survey</u> revealed that the majority of California parents feel the same way.

Dalila Epperson, a resident of Monterey County, is one of them.

"You go into the school library and see books that are for children, and they have very graphic pictures that I would not allow a teenager to look at, let alone a 10-year-old child," she said.

During her three decades as a resident of California, Epperson has noticed a shift in the political atmosphere.

"I've seen it. I've been a part of it. It's been pretty fabulous," said Epperson, who <u>made a run for the U.S. House</u> to represent California's 19th Congressional District this past November.

While unsuccessful at her bid for Congress, Epperson's fight for parental rights is ongoing.

"It is causing the Great Awakening," she said. "We're talking Democrats, Republicans, independents, libertarians, they're all coming together as parents and grandparents, as concerned citizens. They want common sense right now and right now it's the Republican Party."

A Public Policy Institute of California <u>survey</u> released in April showed that than 7 in 10 parents of California's public school students—and 65% of California's adults overall—oppose allowing biological males to participate in girls' or women's sports.

However, the state legislature's Democrat supermajority voted that same month to block two bills—<u>Assembly Bill 89</u> and <u>Assembly Bill 844</u>—which would have banned biological males from participating on a sports team for girls.

While the majority of Americans want the federal government to do more to <u>protect children</u>, California's lawmakers are <u>blocking a proposal</u> that would make it a felony to purchase 16 and 17-year-old children for sex.

Gina Gleason also believes the Great Awakening has to do with a fight for parental rights.


Gleason is the director of <u>Real Impact</u>, a non-partisan Christian organization in Southern California that helps "educate, equip, and encourage Christians to make well-informed decisions when voting. She is also president of a local Republican Women's Club.

"I felt a calling into being involved in waking up the Christians who are sitting in church every Sunday and not knowing about some of the issues that they were facing as citizens," she said, "and I felt that they should be aware, because I saw so many issues pertaining to our children and what was going on in public schools, and I just kind of wanted to wake everyone up."

"I believe that the average Californian is on our side with some of these issues," she said. "It's been a long time coming."

#### "A Huge Disconnect"

Another thing contributing to "The Great Awakening" is the refusal of California's liberal leaders to listen to their constituents.



A <u>poll</u> released January 24 by Public Opinion Strategies showed that 93% of Republicans, 70% of independents, and even 52% of Democrats surveyed in California support requiring voters to show government-issued identification to vote.

Nevertheless, <u>California's new anti-election integrity law</u> went into effect on January 1, prohibiting local governments in the Golden State from requiring voters to show identification to cast ballots in elections, and <u>a bill</u> requiring voter ID and proof of citizenship to register to vote was rejected by California lawmakers on April 9.

On March 25, President Donald Trump signed an <u>executive order</u> that will require proof of citizenship to vote.

So, Democrats <u>filed a lawsuit</u> just six days later, arguing that the order is unconstitutional.

According to Epperson, it's this flagrant lack of concern for the will of their constituents that has a growing number of Democrats starting to pull back from supporting Democratic candidates, "even if they say they're moderate."

"They don't understand their own party right now, there's a huge disconnect," Epperson said.

"Going Too Far"

Jon Dolieslager also believes Californians are fed up with oppressive liberal policies.

"People are just getting tired of it," he said. "Even Democrats are looking at it going, 'Okay, this is going too far.'"

For the past 25 years, Dolieslager has owned and operated the Tulare County stockyard in Dinuba, California, which grows feed for cattle and provides a place for cattle farmers to store their cattle on the way to auction.

The agricultural industry in California also faces a litany of challenges, which are contributing to farm closures.

Tri-State Livestock <u>reported</u> in March that lawsuits filed by environmental groups have forced the closure of a dozen California ranches.

United AG <u>reported</u> that the overall number of farms in California fell 10% between 2017 and 2022. From its peak of having 87,991 small farms in 1997, California lost 24,867 of them by 2022.

The Bullvine reported in March 2024 that there was a 35% decline in the number of dairy farms in California between 2003 and 2023.

But while the liberal media pumps out articles saying that farmers are turning on Trump, Dolieslager knows who is really to blame.

"What the left doesn't explain is that this was all going on prior to Trump coming into office, and we are now paying the piper for what the Biden and Harris administration created," he said.

"Democrats are 100% to Blame"

Chad Bianco, a married father of four, moved from Utah in search of his California Dream in 1989 at the age of 22.

However, while he considers California the most beautiful state in the nation, his California Dream diminished as progressive Democrats took over.

"Over the last 10 years our state has become the worst at everything that we are supposed to be good at, and we have become the best at everything that we are supposed to be the worst at" he said. "Our schools are in shambles. It makes absolutely no sense."

During Newsom's tenure, California's state budget grew over 63%, ballooning from around \$200 billion in 2019 to about \$327 billion in 2024.

"We pay the highest taxes in the country, the highest income taxes, the highest sales taxes, the highest everything taxes in the entire country, and we have nothing to show for it, and the people in California absolutely realize now that progressive Democrats are 100% blame for everything that we have wrong in this state."



# The Alarming Dangers of Synthetic Marijuana The "Don't Do served us all wand dangerous and dangerou

WHAT IS SYNTHETIC WEED?

A Clemson University chemist named John Huffman created synthetic

marijuana in the early 1990s. According to american addiction centers.org, Huffman received funding to study cannabinoids but was not given approval to use the natural plant. Working around this roadblock, Huffman created the JWH-018 compound - a synthetic cannabinoid. Huffman and his team engaged in nothing nefarious and simply ran tests and wrote a report. "However, the formula surfaced a few years later as an alternative to real marijuana." The new compound began to be utilized to give a cannabis-like high to users and addicts while tricking drug tests that scanned specifically for naturally occurring THC. (1)

This get-the-high-pass-the-test chemical quickly became manufactured in mass under seemingly innocuous names like Spice, K2, and Blaze. Without cannabis leaves as an ingredient, these concoctions contain obscure, dried plant matter. Various vegetables, herbs, and spices are sprayed with chemicals, making it look like natural marijuana. This form is used in joints or pipes, while liquids are produced for e-cigarette and vaping devices. Additionally, this unknown-sprayed-with-harmfulchemicals mixture can be added to tea bags or even baked goods such as brownies. (2)

#### THE ILLS OF IMITATION

C. Michael White (Professor and Head of the Department of Pharmacy Practice, University of Connecticut) makes an appalling statement: "Synthetic cannabinoids are 30 times more likely to harm you than regular marijuana." Professor White explains the details to back up his claim in his article in Discover Magazine: https://www.discovermagazine.com/health/synthetic-marijuana-is-far-moredangerous-than-weed. One reason,

White notes, that makes synthetic marijuana so dangerous is the contaminants that have been identified in this tainted product. Here is a sampling of a broader list: brodifacoum (an anticoagulant or blood thinner in rat poison), heavy metals, pesticides, mold, salmonella, and fentanyl. (3), (4), (5)

With potentially deadly toxins found in synthetic weed, the side effects are extremely concerning: stroke, seizure, coma, psychosis, violent behavior, suicidal thoughts, hypertension, chest pain, severe nausea and vomiting, excessive bleeding, and loss of consciousness. (6), (7)

MALICIOUS MARKETING


According to the CDC, "Hundreds of different synthetic cannabinoid chemicals are manufactured and sold. New ones with unknown health risks become available each year." (8) And sadly, marketing is targeted at kids. A simple Google image search on "synthetic weed packaging" yields countless pictures of "Spice" pouches plastered with kid-friendly, cartooninspired graphics that may sometimes be found in convenience shops. Online sellers also deceptively sell fake weed as "incense" or "natural herbal" products.

The "Don't Do Drugs!" mantra has served us all well in the past. Illegal and dangerous narcotics were usually easy to identify. Now, while fake marijuana parades around as harmless fun, we must remain vigilant for our children. Despite the devious names and labeling, we can, by jointly sounding the alarm, render these evil manufactures out of business!



# Authority: Source and pathway for appeal

In this third installment we will discuss the source of all true authority, specifically what the Bible and history shows clearly to anyone who diligently searches. All authority comes from God. He makes this known through his creation. To further help us, God tells us in plain language that the Earth is his in Psalm 24:1. God goes further and explains that this includes the realm of the affairs of men in Daniel 4:17. All authority on earth is given/delegated by God.

A common framework for realms/spheres of government was initially formulated by Abraham Kuyper, and is restated in *The Doctrine of the Lesser Magistrates* by Matthew Trewhella. It is very helpful and is seen below. It is ordered vertically ascending, proceeding outward from the individual.

- **Civil Government**
- **Church Government**
- Family Government
- **Self Government**

**The delegated authority of each realm** (like everything else in existence) has its bounds set by God's law. This means that authority is not unlimited nor autonomous but rather subject to everything He has decreed.

When a higher adjacent realm is in rebellion to Gods law, it is the duty of the lower realm to appeal to a yet-higher authority. Lets look at both a small and a large scale example.

<u>SMALL SCALE:</u> A father tyrannically rules his house, in violation of His law. A God fearing wife would be duty bound to appeal to the elders of that family's local church.

**LARGE SCALE:** When a state is in rebellion to God's laws, then a county or city can appeal to a federal authority. We see this in the judicial system, when cases get appealed to higher courts such as the Supreme Court of the United States.

senior officers, camped in Newburgh, New York, spoke of mutiny against the government. When the general left the room, they voted to give Congress more time, and the Revolution was saved.

He suffered all the privations of his troops. During that time he visited his home in Mount Vernon only once, and that was on his way to fight Lord Cornwallis at Yorktown. Washington once said, "A leader is one who knows the way, goes the way, and shows the way." Washington did all three, and we would be well-advised to look for leaders like him; namely, those who put the interests of the people above their own.

Among His last words of advice to His apostle, Peter, Jesus said, "Feed my sheep." [John 21:17] Notice, the command was to feed the sheep, not fleece them. Great leaders, like Jesus and Washington, are willing to sacrifice everything for the benefit of their followers. That is true love. That is true leadership. Americans deserve and must demand leaders who love them enough to give up everything for them. Otherwise, they likely will try to take everything from them.

# Prayer for Our Leaders and Our Enemies



When was the last time you prayed for a government official? Better yet, when was the last time you prayed for a government official you didn't like?

Last year I had the pleasure of attending the Republican National **Committee's** spring retreat in West Palm Beach, Florida, where many congressional members (perhaps some potential vice presidential picks) and nominees for state and federal offices showed their support for the 45th President of the United States Donald Trump's candidacy for the upcoming 2024 election.

The gorgeous Florida setting invited various attendees of the Republican Party, many of which came from all around the country. Prayer was an active part of the retreat.

On the very first day of the event, RNC co-chair Lara Trump moderated a panel with Speaker of the House Mike Johnson, New York Congresswoman Elise Stefanik, and Florida Congressman Mike Waltz, where topics of foreign affairs, elections, and faith were discussed. Mr. Waltz made remarks about unleashing American energy-how dropping U.S. oil to \$50 a barrel through domestic drilling will result in a major reduction of worldwide dependence on countries like Iran and Russia.

Mr. Waltz was staunch in saying that manufacturing, supply chain growth, ending the appeasement of our enemies, and being respected as a country through correct paths is what makes our economy and our nation strong and great. Ms. Stefanik also suggested it was absurd of special counsel Jack Smith to disregard a DOJ policy known as the "60-day rule," discouraging prosecutorial action 60 days prior to an election.

When Mr. Johnson spoke, he conveyed the importance of faith in **America** and how it is something that should be protected. Faith and religion is the most important aspect of our nation's character. It's what allows us to show our benevolence to other nations and especially to our own citizens through constitutionally protecting our God-given rights to

worship and pursue something greater than ourselves, a pursuit of the transcendent. We can look back to founding leaders such as George Washington, who said in his 1796 farewell address, "Of all the dispositions and habits which lead to political prosperity, religion and morality are indispensable supports." Prayer itself is something I adopted into my schedule since high school, which tremendously helps and allows me to connect with God, who made our nation great.

Mr. Johnson said our nation is in great turmoil, with some student protesters at universities on American grounds actively pushing a rhetoric of pro-terrorism, even as Hamas still holds Israeli and nationals of other countries in a brutal hostage situation. I believe that a proper end goal of peace for both Palestinians and Israelis is needed, but to be advocating for a terrorist group? When a nation founded on Judeo-Christian values is hosting students on campus (many from other nations using student visas) who are harassing Jewish students on campus simply because they are Jewish, a solution must be found. During the panel, Mr. Johnson said he believes that "[pro-Hamas] students who are preying on other students shouldn't be in this country," and so do I. Then again, we need to be praying for these students as well as the financiers regardless so that they may come to realize what they are actually doing.

The education system has become **corrupt,** and this isn't a condemnation, it's simply an observation. While I was at Fullerton College, subjects that were being taught by a professor in the English Department included "transgender horror," "torture porn and its relationship with the attacks on 9/11," and "torture horror."

These are only a fragment of the inappropriate content that he published online for us to read. I immediately dropped the class as soon as I saw this content. I didn't dare allow my Christian morals to be compromised by being a part of any of this radical and illicit ideology.

#### As soon as I dropped out, I reported the professor of so-called "English," and

made sure the school administration was up to date on his content, but regardless they're all coalesced together on the same brick wall called the California educational system. It isn't easy having conservative values on high school and college campuses. When I was running a Turning Point USA Chapter at Esperanza High School, my TPUSA posters were vandalized with rude remarks and LGBTQ stickers.

Not only that, but I also had to battle for a mask exemption at the beginning of the school year, which led to me being segregated from all the other students and sitting at a desk with plexi-glass surrounding it. Schools need to do better in these types of situations-they need to respect the values we as faith-based conservatives hold. We need to pray that this education system changes, that salvation comes not only to those who profess evil, but also to those who protest for evil things, such as the pro-Hamas protesters on campuses.

On the last day of the RNC retreat in West Palm Beach, President Donald Trump provided attendees with an opportunity to speak on stage with himself and many members of Congress.



At Biola University, this vision has led to the creation of two major initiatives: the AI Lab and the AI Studio. 

# Why 30 Million Christians Don't Vote

# Conservatives get a spine:

**Tyranny is self-limiting. It rouses passions.** The winner-take-all of any tyranny means it tends to eat its own. Desperate grasping for power leads to reckless and self-defeating acts.

Americans can review their history for examples.

**George III misbehaved. Americans of 1776 acted.** Democrats pushed nationwide slavery. Abraham Lincoln appeared. Teddy Roosevelt stepped up to the plate to put down his generation's version of big tech. Ronald Reagan answered the call

when Americans once again said "Enough."

**Donald Trump followed these examples.** Voters, as they always seem to do, said "Enough." Not once, but two times. Globalist donors lost. Democrat sponsored repression, incompetence and corruption lost.

**President Trump continues to ride a wave.** It's rolling forward, despite desperate efforts of Democrat's, their donors and the Democrat press, to turn back the clock.

Some conservatives somehow remain paralyzed with fear. They focus on what propagandists want them to think about. As in the Revolution, this is a time to try one's soul. Some network outlets still worth watching include Newsmax and One America. Breitbart, Red State, the Bongino Report, the Daily Caller, the Daily Wire, HotAir, and the Postmillennial provide useful information. Podcasts doing professional work include the "All In"


Podcast, the Ruthless Podcast, and the Verdict with Ted Cruz. Breitbart's Fight Club is helpful. Christian News Magazine aims to fill the need for trustworthy information.

The reader probably already has a set of information sources. Outlets that sell outrage are losing. Those that inform are winning.

Every county and city includes election targets: councils, boards and commissions. School districts desperately new board members who insist on reading and math proficiency. City councils need members who reject this week's woke nonsense. America-first state and Federal office holders will arise from the pool of world-beating conservatives who are being elected today to school board and city councils.

Getting a spine starts with focus on reliable information sources. It means connecting with local people who want to make America great. Contesting for local, state and federal office follows. This is how the 1776 revolution got started. This is familiar territory.

**Getting a spine isn't hard.** Just stick to reliable information sources and laugh at propaganda. Expect setbacks but keep moving. The payoff is getting good people elected. It's that simple.



# One Way Jesus!


In the 1970s, the "Jesus Movement" swept across America like a wildfire. Among the young, often ex-hippie Christians who were rescued from the chaos of that turbulent decade, one simple phrase became a rallying cry: "One Way Jesus!"

"With a single finger pointed toward heaven, they declared to a broken world that salvation wasn't a complicated maze of religions or philosophies — it was a person. Jesus Christ alone is the way. That simple truth, shouted from beaches, coffee houses, and revival tents, is just as powerful today as it was then.

This proclamation wasn't a cultural fad. It was deeply rooted in the bold claim Jesus made in John 14:6: "I am the way, the truth, and the life. No one comes to the Father except through Me." At a time when the world was (and still is) searching for truth in a sea of confusion, Jesus pointed directly to Himself. He didn't merely show the way — He is the way.

The first disciples, much like us, struggled to understand. When Jesus spoke of going away to prepare a place, Thomas asked, "Lord, we don't know where You are going. How can we know the way?" (John 14:5). Jesus' response was breathtaking. He wasn't describing a distant road or future event alone — He was inviting them into a present reality: intimate relationship with the Father through Himself.

Many Christians think of "the way" as only leading to heaven after death. While it's true that believers are promised eternal life, the fuller context of John 14 reveals that Jesus was talking about immediate, personal access to the Father by faith. This is a "now and not yet"



reality. Jesus opened the way not only to an eternal dwelling place but to a living, vibrant connection with God right now.

The book of Hebrews expands this idea beautifully. It tells us we have boldness to enter the "holiest" — the very presence of God — by the blood of Jesus (Hebrews 10:19-22). He created a new and living way through His own body, offering us access to the Father without fear or shame. Our High Priest, Jesus, sympathizes with our weaknesses, allowing us to come boldly to the throne of grace (Hebrews 4:14-16).

Through Jesus, prayer itself is transformed. John 16:23 teaches that whatever we ask the Father in Jesus' name, He will give. Prayer isn't a ritual or formula — it's a relational conversation. By the Spirit, we pray with Jesus to the Father. In Christ, we aren't orphans pleading for scraps; we are sons and daughters welcomed into the Father's arms. Ephesians 2:13-18 adds even more beauty to the picture. Once far off, we are now brought near by the blood of Christ. Jesus broke down every barrier, reconciling us to God and

each other, granting us all access to the Father by one Spirit. Because of Him, we can draw near at any moment — with hearts full of gratitude and faith.

Often, we think intimacy with God requires pressing through long seasons of striving. Yet Scripture shows that, in Christ, intimacy is immediate. If we come with humility, gratitude, and a heart anchored in the finished work of Jesus, we can enjoy deep fellowship with the Father the very moment we pray. Moreover, Jesus isn't just the way to the Father; He is the way to the dwelling place. John 14:23 reveals that the Father and Son make their home with those who love and obey Jesus. The Greek word used here for "home" (mone) points to a permanent dwelling. It's the same word used earlier when Jesus says He is going to prepare a place for us. The astonishing reality is that Jesus prepares not only a future place for us in heaven but also a present dwelling place within us through the Holy Spirit.

The call to abide is woven throughout John's Gospel. In John 15, Jesus describes Himself as the true vine and calls us to abide in Him just as He abides in us. Abiding isn't a forced effort but the natural fruit of believing who we are in Christ — sons and daughters in whom the living God has chosen to dwell.

One Way Jesus. It's not just a slogan. It's the heartbeat of the Gospel. Jesus is the only way to the Father, the true dwelling place for our souls, and the source of unshakable life today and forever.
