*The world is standing at a critical
crossroads. The events unfolding before our
eyes are not merely political shifts, cultural
movements, or ideological struggles. They
represent a larger battle for truth, morality,
and spiritual allegiance.* More than ever, there is
a need for clarity and understanding concerning the future
of what is commonly called “The Christian Church” and the
current political situation, particularly in the United States
of America. What is at stake is not only the stability of
nations but the purity and mission of the Body of Christ in
a world determined to redefine it.

A Turning Point in Modern History

The political landscape of the modern world began to
dramatically change with the presidency of George H. W.
Bush. In 1991, during the aftermath of the Gulf War, Bush
uttered the words: “A New World Order” — words that
reverberated far beyond politics. The concept seemed to
promise unity, global cooperation, and prosperity. Yet behind
the optimism lay a deeper agenda: the re-structuring of
global power and the erosion of Biblical values within
Western civilization.

During this period, Brussels was already advancing toward
the establishment of the European Union. What appeared
to be an economic coalition became a centralized political

embarked on a calculated strategy of populating Western

to permeate every level of government, business, and even
religion.

These shifts did not take place in a vacuum. Under the

the Western world drifted dramatically to the left, embracing
philosophies and policies that undermined Biblical morality.
The result has been a sweeping transformation in the cultural
and spiritual fabric of society.

The Illusion of Human Control

At the heart of these developments is the illusion that human
beings can control history, establish a utopia, and legislate
morality apart from God. This is the same deception that has
existed since the Tower of Babel — man’s attempt to dethrone
God and exalt his own power. The globalist agenda, the re-
shaping of institutions, the rise of secular progressivism, and
the militant rejection of Biblical truth all fall under the category
of humanity’s efforts to establish evil over the land.

Yet Scripture reminds us of an unshakable reality: Jesus Christ
is in complete control. Psalm 2 describes the rulers of the
earth who conspire against the Lord and His Anointed. Their
schemes are met with the laughter of God, who has already
set His King on Zion. Christ is not merely the Savior of
individual souls; He is the head of the government of the
universe. Isaiah 9:6–7 declares, “*The government will be upon
His shoulder... of the increase of His government and peace
there will be no end.*”

This means that the true battle is not about who occupies
the Oval Office, Parliament, or the United Nations. The ultimate
question is: who rules the affairs of the human heart?

The present danger lies not only in political corruption but in
the assault against the Christian Church itself. The effort is
clear: to transform the Church into a woke institution, stripped
of its Biblical foundation and redefined by cultural ideology.

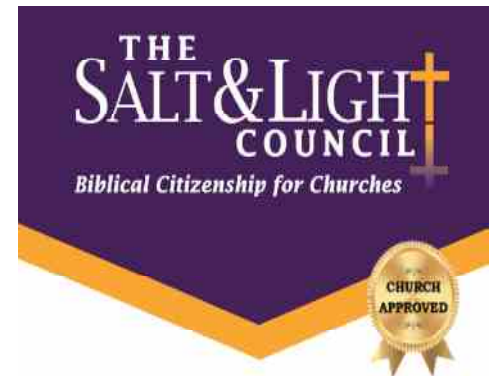

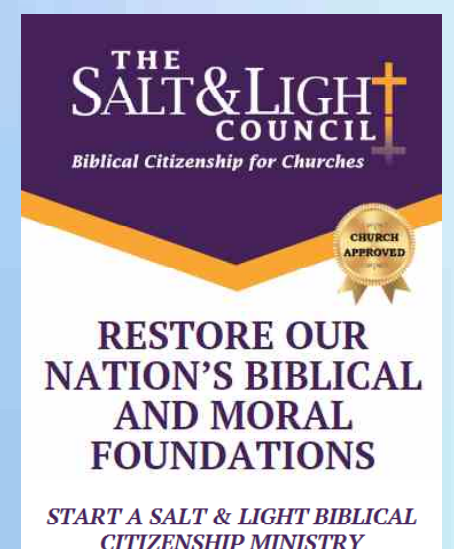

Parents Urged to OPT OUT CA Students

As a new school year begins, Christian parents across California are being urged to take a closer look at what their children are being taught—and take action. Informed Parents of California, a statewide grassroots organization, offers parents the opportunity to OPT OUT their children from inappropriate curricula, books, gender studies, counseling, and intrusive surveys. The OPT OUT System is designed to help moms and dads safeguard their children from controversial lessons and activities that conflict with their faith and values.

For too many years, parents have assumed that public schools would respect their role as the primary educators of their children. Yet in recent times, troubling trends have emerged. Curriculums increasingly include sexual content, ideologies about gender and identity, and political activism that many families believe has no place in the classroom.

The Bible reminds us that parents, not the state, are charged with raising children in the nurture and admonition of the Lord. The OPT OUT Notice is a practical way for parents to reassert their God-given authority. The system works simply: parents visit the Informed Parents of California

website, www.ip-ca.org. Click on the green OPT OUT button, complete an information form that identifies them, their child and their child's school, DocuSign on the screen, click submit and a legally binding OPT OUT Notice is sent by email to the child's school principal and school district superintendent...all in less than two minutes!

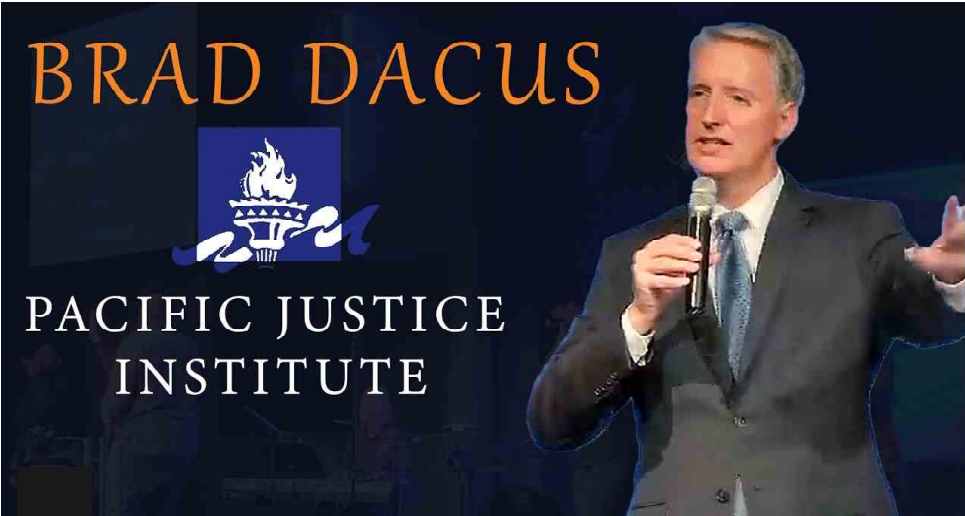
For many Christian families, this means protecting children from lessons promoting radical gender theory, graphic sexual education, or surveys probing into private family matters. By filing the OPT OUT Notice, parents stand on firm legal ground while ensuring that their voice is heard in the classroom.

Advocates stress that the OPT OUT system is not about withdrawing from education, but about reclaiming it. Our children deserve an excellent education that strengthens their minds without compromising their souls.

The call to action is clear: parents should not wait until harmful lessons are taught to react. Instead, they can be proactive—submitting the OPT OUT Notice at the start of the year.

As the culture continues to press into America's schools, Christian families have both the right and the responsibility to set boundaries. The OPT OUT Notice is one way to do just that—equipping parents to raise up the next generation to walk in truth.

AB 495 Risk to Child Safety and Parental Authority

The California Senate Appropriations Committee is currently scheduled to review AB 495, sponsored by Assembly Member Celeste Rodriguez, on August 18, 2025. We urge you to take the following actions to protect our children and parental rights:

- 3. Submit Public Comments:** Submit written opposition directly to members of the Senate Appropriations Committee by August 15, 2025. Email your comments to appropriations.senate@senate.ca.gov, clearly stating your concerns about AB 495's lack of safeguards and potential for abuse.
- 4. Spread the Word:** Share this email with your family, friends, church members and community. Post about AB 495 on social media using hashtags like #StopAB495 and #ProtectParentalRights to raise awareness of the far-reaching implications of AB 495.
- 5. Attend the Hearing:** If you're able, attend the Senate Appropriations Committee hearing in Sacramento on August 18, 2025, to show your opposition in person. Details on the hearing location and time can be found at <https://www.senate.ca.gov>. Let me be clear: Our children's safety and your parental rights are at stake. Pastor Jack Hibbs Urges Californians to Confront AB 495: “Parents Must Wake Up”

Pastor Jack Hibbs: ‘Most Dangerous Bill We’ve Ever Seen’

California’s Capitol had a showdown on August 19th as parents’ rights advocates, pastors, and legal experts rallied against Assembly Bill 495, a controversial measure critics say guts parental authority and creates dangerous loopholes for child exploitation.

At the center of the mobilization was Pastor Jack Hibbs of Calvary Chapel Chino Hills, who issued a blunt call from his pulpit last week: if AB 495 becomes law, parents should consider leaving California altogether.

“You got to run with your kids. You got to go,” Hibbs warned. “Your child’s safety is number one in your life.”

The Bill at the Heart of the Firestorm

AB 495, authored by freshman Assemblywoman Celeste Rodriguez (D–San Fernando), is officially titled the *Family Preparedness Plan Act of 2025*. Marketed as a compassionate safety net for children of detained immigrant parents, the bill allows an “adult caregiver” with only a “mentoring relationship” to assume broad, parental-level authority over a child via a one-page Caregiver’s Authorization Affidavit.

No court hearings, notarization, or parental consent would be required. Background checks and identity verification are not part of the process.

Opponents argue this setup could turn California into a haven for child trafficking.

“Presto, someone walks away with your child,” warned Erin Friday, attorney and president of Our Duty-USA. “This is a child trafficker’s and kidnapper’s dream bill.”

Nicole Pearson, founder of Facts Law Truth Justice, was equally blunt in testimony before lawmakers:

“This isn’t fear-mongering. This isn’t hyperbole. The unintended consequences are terrifying, and they are unavoidable.”

Medical Decisions Without Parents

Critics emphasize that AB 495 extends far beyond emergency guardianship. Under the bill, an unvetted “caregiver” could enroll a child in a new school, authorize medical procedures, or approve psychiatric treatment—including powerful medications and sex-trait modification—without a parent’s knowledge.

“That’s not compassion,” said Greg Burt of California Family Council. “That’s state-sanctioned kidnapping.”

The Rally took place on August 19, 2025

To push back, advocacy groups Real Impact and Capitol Resource Institute organized a “NO on AB 495 Rally and Lobby Day” at the California State Capitol.

Featured speakers included Pastor Jack Hibbs, author Heidi St. John, and Jonathan Keller, President of California Family Council, with more voices present. Organizers called for at least 5,000 attendees.

“This isn’t about politics,” Hibbs stressed. “This is about the safety of your children.”

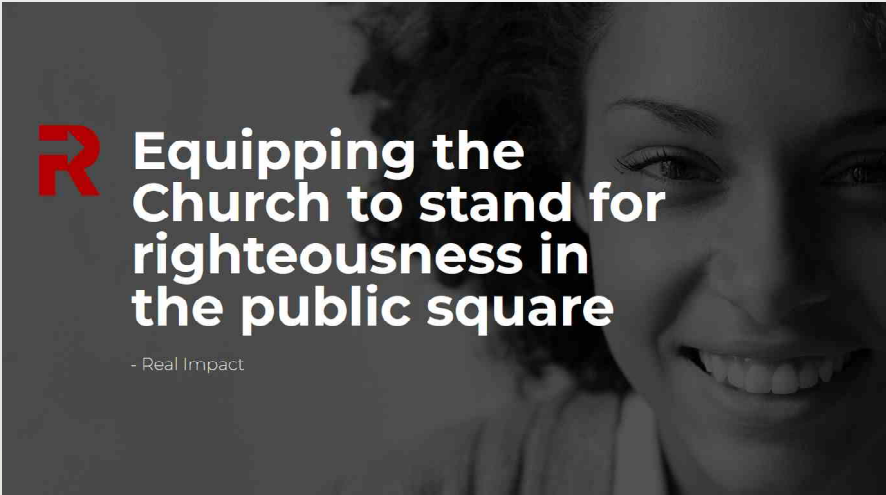

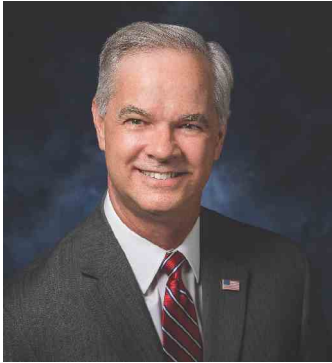

California's public schools are falling short, jeopardizing both our students' potential and the state's future. Standardized tests reveal alarming statistics: 44% of 11th graders cannot read proficiently, and 72% lack basic math skills. For many of these students, the result is a minimum-wage job with little opportunity for growth. How can we turn this around?

Christian's First Amendment Rights Violated at Mayday USA Event by City of Los Angeles - Lawsuit?

On May 31, during the Mayday USA event in Hollywood, the City of Los Angeles allegedly violated the First Amendment rights of a Christian group seeking to assemble and protest.

Mayday USA had applied for a permit to gather on Hollywood Boulevard to support parents and children and to celebrate their Christian faith through prayer, song, and baptisms. However, the City denied the permit, classifying the event not as a protest or assembly protected under the First Amendment, but instead as a concert or performance. Officials instructed the group to apply for a different permit through the Bureau of Street Services (BOSS), which handles permits for concerts and entertainment events.

The BOSS office subsequently denied the request, stating that they do not approve permits for protests or free speech activities—effectively leaving the group without a path forward. Organizers claim this is a tactic the City uses to discourage groups from exercising their constitutional rights.

Notably, the same type of permit requested by Mayday USA was approved for the LA Pride event the following week—at the same location and time—which also included community celebration and advocacy.

Attorneys representing Mayday USA argue that the City's actions amount to a clear violation of their First Amendment rights. The City later suggested the group apply for

a last-minute permit, which severely restricted their activities: baptisms were prohibited, and organizers were told that extended singing or speaking would not be considered protected speech under the First Amendment.

Mayday USA is currently exploring legal action against the City of Los Angeles in response to what they view as unconstitutional restrictions and discriminatory treatment.

CONVERSATION WITH A MOM

This afternoon, I received a call from a mother inquiring about how the CEO Act works and when it will take effect.

After giving her a brief overview, we discussed her family's situation. She and her husband have chosen to send their children to a faith-based school, which costs between \$1,200 and \$1,500 per month. Due to rising costs and inflation, they have had to cut back on their own food expenses to afford tuition. They also forgo vacations to prioritize their children's education.

I told her that she and her husband are remarkable parents for making such a sacrifice. Every month, they pay \$5,500 in tuition to keep their children in the school of their choice. Since this is after-tax income, they actually need to earn \$11,000 to cover these costs.

With the CEO Act providing \$17,000 per child annually for education, their family would free up \$5,500 per month—allowing them to save for retirement, take vacations, and ease their financial burden.

These are the families we are saving with the CEO Act.

Some pastors avoided the topic altogether, convinced they were standing on legal quicksand. Others whispered their convictions like fugitives, afraid of drawing the wrong kind of attention. A few preached boldly and waited for the axe to fall.

But here’s the question: Was the threat ever real?

On July 8, 2025, the IRS finally admitted the truth.

In a court filing that should have made front-page headlines across the country, the IRS stated that pastors may endorse political candidates (note: like Jeremiah and John the Baptist did) during worship services without risking their church’s tax-exempt status. Internal religious communication—such as a sermon—is now recognized as protected speech.

LET THAT SINK IN.

The bluff has been called. The muzzle removed. The government has backed down.

Pastors, you are free to do so.

Now here’s the twist: for churches, this entire debate may be moot anyway. (See the addendum.)

Still, for most pastors and boards who’ve bought into the fear, this moment matters. So let me give you the rest of the story.

The Johnson Amendment: A Phantom Weapon

Let’s rewind. The so-called “gag rule” comes from the Johnson Amendment, added to the tax code in 1954 by Lyndon B. Johnson while he was a Senator (D) —not out of principle, but out of political vengeance. Two non-church nonprofits had opposed his re-election, so he pushed a vague ban on political “intervention” for 501c3s.

It was never debated. Never tested. Never aimed at churches. It was merely tacked on to a bill that was going to pass. But it cast a long shadow.

For decades, pastors were told—by tax attorneys, by socialist atheistic politicians, by progressives—or actually by the devil who saw an opportunity to control those people who then advised churches and denominational headquarters, that endorsing a candidate from the pulpit could bring the IRS down on them. And so, many remained silent. Worse, laws change hearts, and so the hearts of the people, pastors, Christians even non-Christians believed without reason that political involvement by the church was just wrong.

But Has Any Church Ever Lost Its Status for a Sermon? No.

Only one church has ever had its 501c3 revoked: Branch Ministries in the 1990s. But here’s the key detail—it wasn’t because of a sermon.

Branch Ministries ran full-page newspaper ads telling Christians not to vote for Bill Clinton. Not a sermon. Not a worship service. A political ad in *USA Today*. The IRS struck, saying you can’t make political campaign expenditures with donated money, and the courts upheld it.

But no church—zero, none—has lost tax-exempt status for what a pastor said inside a worship service.

The myth was real. But the threat was never enforced.

Pulpit Freedom Sunday: The Great Dare

Yet pastors around the nation cowered in fear. So in 2008, Alliance Defending Freedom decided to call the IRS’s bluff. They launched Pulpit Freedom Sunday. Pastors across the country were invited to record themselves endorsing or opposing candidates and mail the sermon directly to the IRS.

THOUSANDS DID.

NO ONE LOST TAX STATUS.

The IRS, faced with a legal standoff it didn’t want, went quiet. And now in 2025, they’ve admitted in court filings that such speech is constitutionally protected.

But Here’s the Problem

In four years—or eight—a new president could appoint a Treasury Secretary who does want to silence pastors. One who hates the God of the Bible. One who doesn’t believe our laws should reflect the laws of nature and nature’s God despite that all laws are based on someone’s moral values.

SO HOW DO WE STOP THIS FROM HAPPENING AGAIN?

How do we permanently kill the Johnson Amendment’s power—not just repeal it, but bury it so deep no progressive administration can revive it?

THERE ARE TWO WAYS.

Precedent Is Built by Action, Not Hesitation

First: pastors must build the precedent now.

Courts do not respect silence. History does not honor timidity. If we want to establish the normalcy of pastors speaking boldly about candidates and laws, then it must happen regularly—not symbolically.

Endorse candidates from the pulpit. Oppose wicked laws. Name names when necessary. Do it not once a year, but all the time and certainly every election season, as a normal part of shepherding God’s people.

WHEN ONE CHURCH DOES IT, IT’S A NOVELTY.

WHEN A THOUSAND DO IT, IT’S A TREND.

But when ten thousand pulpits thunder, week after week, year after year, no IRS commissioner, no Treasury Secretary, and no progressive court can reverse it without igniting a constitutional firestorm.

What don’t we just have Congress Repeal the Johnson Amendment?

There are two issues:

1. Will they? Yes, Republicans campaign against the Johnson Amendment. But most lack the spine to actually repeal it. Democrats cling to it like armor against the church. If we wait for D.C., we’ll wait forever.
2. Let’s say they do repeal it. But here’s the problem: a future Congress could reintroduce it.

So what’s the best thing to do?

We don’t just need repeal. We need a kill shot.

Here’s the Tactical Solution

If you have connections, pass this on.

The current Treasury Secretary should select 100 willing Christian churches. These churches—fully informed, fully cooperative—each deliver bold sermons endorsing a candidate and condemning another. Then, in coordination, the Treasury sues them.

Yes—sues the very churches it’s working with.

Strange? Yes. But stay with me.



The cases race through the courts—deliberately, efficiently—and land in the Supreme Court, where they are thrown out in a sweeping First Amendment ruling. That one decision destroys the Johnson Amendment’s enforcement mechanism forever.

The current IRS has been hiding. This forces their hand. It forces the issue into the Supreme Court. This establishes binding precedent. It neuters all future efforts cold. It would require a future supreme court to try and reverse that ruling.

It ends the war with victory—not delay.

Addendum: But wait: Here’s The Truth About Churches and 501c3
Did you know that all Churches are automatically tax-exempt under 501c3, even if they never file for recognition. Section 508(c)(1)(A) says so.

Deductibility

Did you know that all donors may deduct gifts to churches—even those without determination letters—under IRS Publication 1828, p. 3.

Audits

Did you know that audits of churches are rare. The Church Audit Procedures Act (IRC §7611) limits the IRS. Only high-level officials can approve inquiries, and only with “reasonable belief” of a violation.

The bottom line

So as long as a church functions as a church, donors and churches are protected—even without any formal 501c3 recognition.

The 14 Criteria

The IRS uses a 14-point test to determine whether something is a church. These include things like regular worship, ordained ministers, and a body of doctrine. No single factor is required—but the more you meet, the stronger your protection. See the footnote for the list.

So can a church without 501c3 be taxed?

No. Not unless the IRS can prove it’s not really a church.

You can’t lose a status you never applied for.

But Then Why Does the Johnson Amendment Matter

Yes, legally, churches don’t need to apply for 501c3 status to be tax-exempt. They’re automatically exempt under 508(c)(1)(A). Donations are deductible. The law is already on your side.

So why fight this at all?

Because perception is more powerful than law.

Try convincing a pastor, a board, a lawyer, or a bank that they don’t need an IRS letter. Try convincing a hesitant donor.

The problem isn’t just the code—it’s the fear.

That’s why the Johnson Amendment must be gutted publicly. Judicially. Irreversibly.

Once it’s dead in the courts, pastors won’t need courage. They’ll have precedent. And precedent protects where conviction wavers.

BOTTOM LINE

You’re already free.

But most don’t believe it.

So we need to kill the lie publicly—once and for all.

Because as long as the Johnson Amendment exists, fear will remain. And where fear remains, pulpits stay silent.

And we’re out of time for that.

Late“summer, 1814. The British were once“again at war with their American brothers and sisters—and it was going well for them. A British fleet, commanded by Rear Admiral“George Cockburn,“transporting an army of Redcoats, commanded by Major General Robert Ross, had made its way

up the Chesapeake“Bay. On August 23 they disembarked“troops who attacked Washington, D.C. “They forced President James Madison to flee and on the following day“they burned both the White House and the Capitol Building. But Washington was not their strategic“objective. It was farther up the bay:“Baltimore. That city was a major seaport“and commercial center. Conquer and“occupy that and you drive a dagger into the throbbing heart of America.

Vice“Admiral Alexander Cochrane commanded the naval force that would undertake the“attack. General Ross’s force of about 5,000 landed on the“east side of the bay and first engaged the Americans at the Battle of North“Point. The Americans delayed the British“advance long enough to allow for the preparation of the defenses guarding the“City of Baltimore. While doing so, Ross“was killed by an American sharpshooter. “The British land force continued its advance to Baltimore. Meanwhile Cochrane’s fleet proceeded up the“bay.

Major“George Armistead commanded the meager forces at Fort McHenry and was tasked“with thwarting the naval advance of the British. He flew a massive American flag over the“fort. It had been commissioned a year“before and measured 30 by 42 feet—the largest American flag to date. Armistead wanted a flag, “so large that the“British would have no difficulty seeing it from a distance.” He ordered the sinking of several commercial“ships to block the entrance to Baltimore Harbor. He also moved his canons with the longest“range out of the relative security of the fort and placed them outside where“they could reach farther down the bay. As“soon as the British fleet came within range, the Americans unleashed hell. Cochrane, fearful of the losses he might“suffer, halted his fleet and began a savage bombardment of Fort McHenry with“Congreve rockets and mortars, called “bombs.” “It was September 13.

The“cannonade continued through the day and into the night. A detachment of British soldiers was“dispatched under cover of darkness to support the attack on the Americans.

Francis“Scott Key, an American lawyer, had approached Admiral Cochrane to release his“friend, Dr. William Beanes, who had been taken prisoner for rendering“assistance to the Americans during the earlier fighting around Washington,“D.C. The admiral agreed to release“Beanes after learning he had also aided wounded British soldiers, but he forced“both men to stay on board a truce ship until the battle was over because thy“knew too much about the British plans. “This gave Key, an amateur poet, a perfect observation post to watch the“course of the battle. He prayed for God’s assistance for the American“cause. The red glare from the Congreve“rockets and the burst of light from the exploding bombs gave proof through the“night that the stars and stripes still flew over the fort. But a couple hours before sunrise the“shooting stopped—on both sides. Key“feared the worst. Why would all the“firing stop unless the fort had fallen. “By the dawn’s early light, Key strained to see whose flag flew over the“fortress—the telltale sign of who held the fort. It was still too dark to tell. And then a light breeze stirred the banner“hanging on the flagpole. Key couldn’t discern“the pattern on the flag, but one thing soon became obvious: the flag was“huge. The Americans at Fort McHenry had“help their position, which denied critical naval gunfire

support for the“British land forces, and inspired generations of Americans ever since. The British withdrew.

Key“wrote his description of the battle in a poem originally entitled “Defense of Fort M’Henry.” Today, we call it the “Star Spangled-Banner”,“which officially became our national anthem in 1931.

Most“of us know the first verse. Few know“there are four verses. The last verse“goes like this.

**O thus be it ever when freemen shall“stand
Between their lov’d home and the war’s“desolation!
Blest with vict’ry and peace may the“heav’n rescued land
Praise the power that hath made and“preserv’d us a nation!
Then conquer we must, when our cause“it is just,
And this be our motto - "In God“is our trust,”
And the star-spangled banner in“triumph shall wave
O’er the land of the free and the home“of the brave.**

We“often hear in patriot speeches or read on patriotic placards “Home of the Free Because of the“Brave.” Certainly, our enduring freedom“owes much to the brave men and women who have fought to preserve it. But we owe much more to the God who answers“the prayers of the patriots. “In God we“trust” must be more than a slogan we inscribe on our money. It must be a passion-ate commitment that we“inscribe on our hearts.

Analyzing a MEGA Miracle

Many of us have witnessed the moral decay in our country with social justice pressuring society to accept a-moral values that challenge our religious beliefs and code. This has been seen as a fight against good and evil more than it has been a fight between political parties.

One side has manifested ideology that encompassing wokeness; diversity equity and inclusion (DEI) along with social justice. The other side promotes moral Judeo Christian values. Many Christians have been praying for a turnaround from America's a-moral culture but few recognize the extent of the victory taking place.

On January 23, 2025, President Trump addressed the World Economic Forum (WEF) opposed their entire agenda of wokeness, DEI, social justice, and economic reforms (video cut and transcript of his address to WEF on January 23, 2025 is online). His address to the group defined America's new role and position on the domestic and international stage. This became a turning point for many U.S. corporations embracing WEF's agenda (over one hundred U.S. companies were members of WEF). In addition, most U.S. government agencies also changed direction including the military. This was the beginning of purging evil ideology from Western society. This purging process is evolving with many challenges ahead. President Trump's fight not only took on ideologies of the global elites, but challenged financial empires as well; which brings us to his fight with the Federal Reserve.

When the past Federal Reserve Chairwoman, Janet Yellen, left the Federal Reserve in 2018, she signed a non-compete contract for BlackRock to manage all of the Federal Reserve assets. This includes the Fed bonds, Fanny Mae and Freddie Mac and also all Federal Reserve Notes. Because of this, In effect, Fed Chairman Powell is a puppet of BlackRock's. This helps us understanding the power and influence WEF has when combined with the financial controls of BlackRock's CEO. This is the global principality issuing control over the Western governments pushing for a "one world government;" the fight President Trumps has taken on.

The World Economic Forum (WEF), was founded by Klaus Schwab in 1971. Its purpose was to shape globalist views in education, economics, and in state relationships within a membership community. Membership includes heads of state, corporations, educational institutions and non-government organizations (NGOs). Klaus Schwab retired from WEF after Trumps address but, what is interesting is the Americans that sit on WEF's Board of Trustee that include Al Gore and Larry Fink (CEO of BlackRock). BlackRock managed over \$10 trillion in assets in 2021, or about 40% of the Gross Domestic Product of the United States. This was expanded to \$25.347 trillion in 2022. When we consider international partnerships, this number raises to over \$30 trillion under direct influence or control of BlackRock. They hold one in seven mortgages in the United States.

President Trump wants to block China's hold on the Panama Canal (subject of recent U.N Security Council Meeting). China owns the ports at each end of the canal under C.J. Hutchison venture. As of this writing, BlackRock is in negotiations to buy the ports for \$22 billion with a joint venture (with Switzerland-based Mediterranean Shipping Company) that still includes the China (remember, Larry Fink is a director of a Chinese business school and addresses them on the global economy each year).

The purpose of mentioning this is to point out the economic and financial power one company has over the U.S. and its opposition to Trump. If the Federal Reserve hold interest rates at 4.5%, BlackRock stands to make over \$20 billion on inflation interest from their massive holdings, enough to buy the Panama ports. The president of Panama, Jose Raul Mulino, wants the ports under Panamanian control and neutrality.

In addition, BlackRock was pushing the Feds, as our Central Bank, to

issue crypto currency (only congress can establish currency). Trump beat them to the punch by blocking the Central Bank from issuing crypto in the Big Beautiful Bill/Genius Act which passed legislation.

The Genius Act defines Stable Coin and how it is to be issued by banks. Crypto (Stable Coin) will be backed by U.S. Treasury Notes and/or the U.S. dollar. In addition, the first week of August, a Presidential Executive Order (EO) on crypto was issued that allow crypto, plus other individual assets such as real estate, to be added to 401K retirement accounts. In addition, by EO banks can not refuse a customer based on political affiliation (remember under wokeness several banks would not allow top conservatives to bank with them; President Trump was one that was discriminated against).

elites in ideology, global economics, and domestic politics; all in the interest of American citizens. His tariffs negotiations counter everything the World Trade Organization acts on against American companies. He is fighting the BRIC as a global trade and reserve currency. Church Leaders May Want ot be Political

2024). Yet in a 2024 Rasmussen Report, 55% of Christians surveyed believe they should be politically involved. Ninety-two percent saw the 2024 election as "important in determining America's future" and 78% viewed the election as "very important" (Rasmussen Reports, 2024). Overall, it appears church goers don't want to hear about politics from the pulpit.

Church leaders feel it's too risky, pointing to potential division in the church. Some lament we protest and they still pass the laws they want despite our opposition. Others claim it's already hard to keep parishioners in the seats because of one issue or another, so why make things more uncomfortable? Yet others just don't want the economic loss, which could make it hard to keep the church open.

The 1954 Johnson Amendment may have been a key driver, following Supreme Court rulings that interpreted Thomas Jefferson's "wall of separation" clause in his letter to Danbury Baptists as a restriction on the First Amendment right of church leaders to speak freely about political endorsements. It held tax-exempt organizations in fear of losing their tax-exempt status for expressions of support or opposition for political candidates. However recent changes due to a court filing by the Internal Revenue Service (IRS) may dra-

Watchmen—Not Silent Spectators

Christians should never get involved with politics or so it's been said for decades. Polling numbers from a Lifeway Research 2024 poll find that 98% of pastors had not "backed a candidate during a church service [that] year. Sixty percent of Americans say it's inappropriate (Lifeway Research,

matically change political conversations in churches, pastors to openly endorse candidates without losing their tax status.

But others say it's time to be bold. Towns have burned down; humans are being trafficked, crime is increasing and anti-biblical laws prevail. It seems negligent not to say anything or worse encourage anti-biblical behavior. The data shows followers of Christ rely on their faith, faith community and Christian media to make decisions on civic affairs, however other polls identify a strong secular social-political influence on the church. Advocates for healthy political discourse argue it's because political issues are being left out. These realities should push pastors to, at minimum, share both sides of important issues.

Inaction may still have negative consequences where the church is concerned.

Being objectively informed about political issues might be likened to being a watchman on the wall. Why? Because some issues that even Christians have rubberstamped go against their better interests. The role of a watchman was to watch for threats to the city or kingdom, and prophet watchmen like Ezekiel warned of God's impending judgment so people had opportunity to turn from sin and return to right standing with God. David watched over sheep to avert attacks of dangerous threats. Jesus is the ultimate watchman, admonishing his followers to "watch" as the day draws near.

Today, issues come up like waves, too quickly to fully assess by cursory view. Those who serve as church leaders have a duty to watch and be aware of what happens on the civic landscape so the church might have clues on the timetable for Jesus' return. It is also imperative that believers know what not to support and how to use proper Bible knowledge to make informed civic decisions.

The statistics are shocking. California is no doubt suffering from a troubling mental health crisis. Physicians are stretched too thin or inaccessible to those who need them. Virginia Dixon and her team at R.E.S.T.™ are on a mission to transform mental wellness services.

Within The Golden State’s diverse population, the 2024 California Health Care Foundation Survey reported a staggering 81% of Californians agree that policymakers in the state urgently need to prioritize increasing access to mental health care¹. Why? One leading factor is over half the participants reported they were unable to make an appointment with a mental health physician because of their particular insurance. In comparison, only 14% noted the same obstacle in scheduling a physical healthcare visit.

California’s Search for a Sound Mind

Limited appointments, insufficient numbers of mental health providers, long wait times, and high costs—daunting roadblocks where one in four Californians surveyed admitted either themselves or someone they love has sought treatment for a serious mental illness.

In most conventional medical settings, a person in psychological crisis is often met with a prescription pad. While medication can provide relief, it rarely addresses the root causes of a person’s distress. At R.E.S.T.™, they are shifting the paradigm. Virginia Dixon and her team are intentionally moving beyond the conventional diagnose-treat-cure model and expanding conversations, tools, and modalities to address root causes to facilitate healing.

Dixon, author of R.E.S.T.™, developed an approach to mental health care that addresses the whole person: spirit, soul, and body. After years of working in the field of neuroscience technology, collaborating with medical professionals, and experience as Director of Inner Healing and Spiritual Formation at a leading cancer center in Orange County, Virginia has become increasingly committed to bringing lasting health and transformation to those she serves.



While pursuing advanced education in neuro-regeneration, biofeedback, and traumatic stress—and supporting medical doctors and practitioners along the way—Virginia noticed the limitations of the conventional healing model. Determined to expand the conversation beyond conventional methods, Virginia and her team tirelessly labor to improve the standard of care. The R.E.S.T.™ philosophy views wellness not merely as the absence of illness, but as the restoration of clarity, order, and peace in place of chaos, confusion, and disease. This holistic, common-sense model offers what the traditional “diagnose-treat-cure” method often misses: the pathway to genuine freedom and wholeness.

March 17, 1776, the British evacuated Massachusetts ending General Washington’s successful siege of Boston. Washington correctly divined the British would re-appear in New York City.

He moved his army to Long Island and awaited the enemy. As expected, they arrived in August and in overwhelming numbers. On August 27, 1776, one to the largest battles of the Revo-

lution was fought with around 40,000 troops engaged. The Battle of Long Island was a rout, and the Patriot army retreated to the west. On August 29, just two days after being defeated by the British, General Washington found his army trapped at the west end of Long Island, pressed against the East River. The British fleet had attempted to sail up the river to cut off any escape attempt, but strong winds prevented them from moving into position.

Washington had ordered a search for all available craft to ferry his battered army across the waterway, and on the night of August 29, that operation began. But as sunrise approached the next morning, only about half of Washington’s troops had made the crossing.

The British would soon see what was happening and order an attack, which would have resulted in the annihila-

tion of the American Army. Minutes before it would become light enough to reveal the ongoing American evacuation, a thick fog rose and covered the crossing. The British remained unaware, and the evacuation continued with Washington taking the last ferry across. Very shortly after landing on the Manhattan side, the fog lifted, the British looked on dumbstruck, and Washington’s army lived to continue the fight.

During his first inaugural address on April 30, 1789, Washington wasted no time honoring the God who had made the institution of the Constitutional government possible. “No people can be bound to acknowledge and adore the Invisible Hand which conducts the affairs of men more than those of the United States. Every step by which they have advanced to the character of an independent nation seems to have been distinguished by some token of providential agency....”

Washington would know. He personally witnessed several of those providential steps, including conjuring a thick, blinding fog that allowed his army to escape, survive, and ultimately achieve an impossible victory against the British. But if you have read the Bible, you already know that overcoming impossible odds is one of God’s specialties. From the emptiness that existed a split second before the Creation to the empty tomb that existed a split second after the Resurrection,

God works and God wins. Americans need to remember this as we face our own challenges. We do not need to face them alone. God was there for Washington, and He is here for us. Without God, we cannot win. With God, we cannot lose. So, humble ourselves, pray, seek His face, and turn from our wicked ways, then He will hear from heaven and will forgive our sin and heal our land.

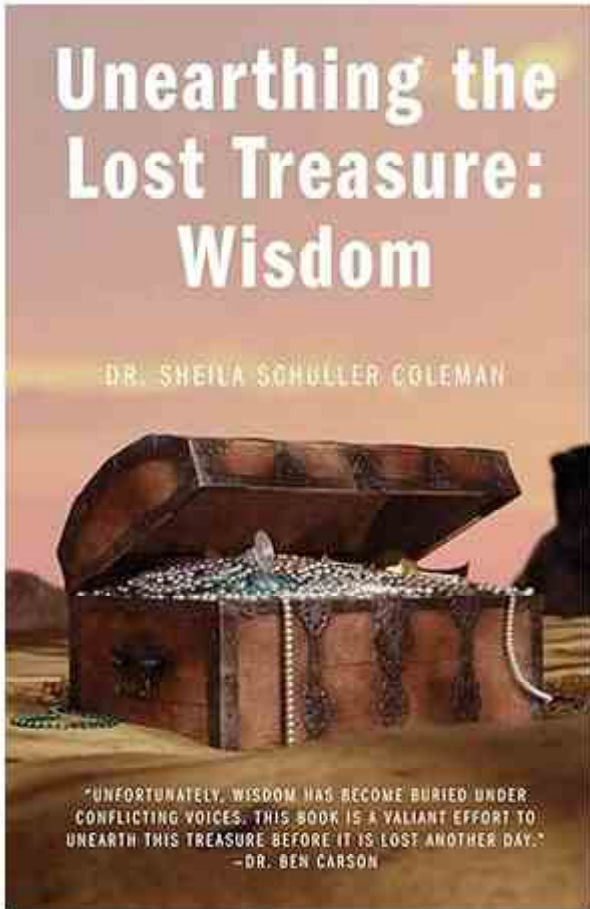

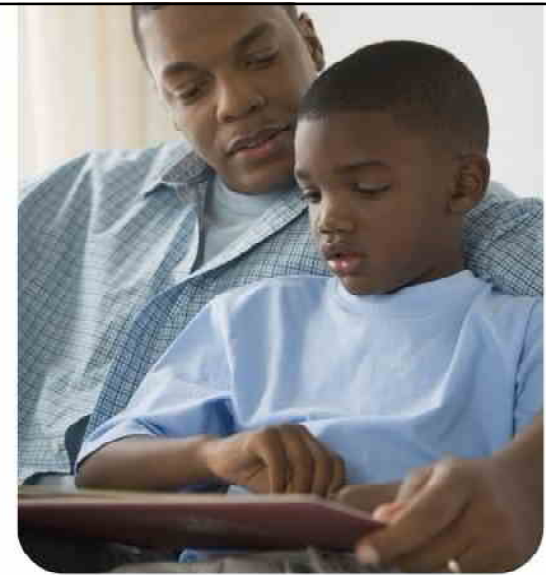
