Central Avenue Reconstruction Project

The Council took action on Change Order #2 for the Central Avenue Reconstruction Project. The change order restored the construction items omitted in Change Order #1. The additional funds are to come from GSU.

Capital Outlay

The Council was advised of the new Capital Outlay funding from the FY2024-2025 session. The city has \$1,000,000 in Priority 5 funding for water system improvements. The city has \$2,000,000 in Priority 5 funding for sewer system expansion.

The Council was advised of the status of the current WSP and CWSRF.
