

# LESSON POLICY

SEPTEMBER 2021-AUGUST 2022

## GENERAL POLICIES

- **Calendar:** The following dates are built-in days off, but may be used for make up lessons as needed.
  - Labor Day (Monday, September 6, 2021)
  - Thanksgiving Week (Wednesday, November 24, 2021 through Sunday, November 28, 2021)
  - Winter Break Week (Friday, December 24, 2021 through Saturday, January 1, 2022)
  - Memorial Day (Monday, May 30, 2022)
  - Fourth of July (Monday, July 4, 2022)*\*All other holiday/vacation conflicts will be handled on a case by case basis*
- **Safety:** Please keep the lesson area and instrument(s) clean and safe for everyone. This includes clearing driveways and entryways of snow/ice/debris. If weather conditions are not safe, virtual lessons will be provided with ample notice from the studio manager.
- **Policy & Rate Updates:** The policies and tuition rates are subject to change yearly.
- **Photo Release:** Lessons By Brooke & Company may use photos, videos, and audio recordings of the student(s) for online and print promotional materials. To opt-out, please submit your request at [lessonsbybrooke@gmail.com](mailto:lessonsbybrooke@gmail.com).
- **Referrals:** We are honored each time you refer us! When your referral signs up for their first month of lessons, you earn a \$25 credit applied to the following month's invoice. Referrals do not apply for siblings or members of the same household.

## TUITION & PAYMENT

- **Flat Tuition:** The tuition fee is divided equally over a twelve-month period and the monthly tuition amount remains the same regardless of how many lessons are taught in the month. Rescheduling is strongly encouraged when conflicts arise. The holiday dates listed above as well as periodic, excused absences have already been factored into the monthly tuition rate. Tuition reserves your time slot for the same day and time each week and includes: weekly lessons, lesson planning, studio resources, and student participation in all workshops, programs and performances affiliated with Lessons By Brooke & Company.

### **2021-2022 Monthly Tuition Rates:**

- \$149/month for 30 minute, weekly lessons
  - \$219/month for 45 minute, weekly lessons
  - \$298/month for 60 minute, weekly lessons
- \*\$10/month sibling discount*

### **2021-2022 Drop In Lesson Rates:**

- \$45/30 minute lesson
- \$67.50/45 minute lesson
- \$90/60 minute lesson

- **Payment:** Invoices will be sent by the 25th of each month. Payments can be made via credit, debit or ACH withdrawal either manually by the responsible party, or set up on monthly autopay to be charged on the 1st of each month.
- **Declined/Late Payments:** Payments that are either declined or not made by the 5th of the month will incur a \$30 fee. If tuition is still not received by the 7th of the month, lessons are suspended until payment is received in full. Serial late payments may result in the student(s) being dismissed from the studio.
- **Lesson Discontinuation:** To discontinue lessons, written notice must be sent via email to [lessonsbybrooke@gmail.com](mailto:lessonsbybrooke@gmail.com) by the 15th day of the final month of lessons. Lesson day/time slots will not be held once lessons are discontinued. Credits or refunds will not be issued for any reason.

## SCHEDULING

- **Absences:** A minimum of 48 hours notice is required for any schedule conflicts or changes aside from illnesses or emergencies. If less than 48 hours notice is given, the lesson will be considered a missed lesson and will not be rescheduled. Rescheduled lessons can occur in person, virtually or via written/video lesson at the instructor and studio manager's discretion within 30 days of the absence. Credits or refunds will not be issued for any reason.
- **Tardiness:** The instructor will wait 1/3 of the total scheduled lesson time for student(s) to arrive before the lesson will be treated as a missed lesson. Instructors will do their best to arrive on time for in person lessons, and if traffic or weather results in a delayed start, student(s) will always receive their full, scheduled lesson duration.
- **Lesson Transfers:** Lessons are not transferable between students of the same household unless previously agreed upon at least 48 hours in advance, with notice given to the studio manager. Last minute lesson transfer attempts may result in a missed lesson.
- **Illness:** Lessons must be rescheduled if any member of the household is ill. The instructor reserves the right to cancel a lesson if the student is too ill to be taught or appears to be contagious. If a student stays home from school/work, they are not to have a lesson. Please give as much notice as possible for cancellations due to illness.
- **Emergencies:** Exceptions to our policies due to illness, emergencies and/or extenuating circumstances will be made at the discretion of the instructor and studio manager.
