#### Minutes of the Urbana Board of Trustees Meeting held Monday, May 13, 2024

The Board of Urbana Township Trustees met on this date with Trustee Blair Stinson, Trustee Matt Harrigan and Trustee Roger Koerner present.

The April 15, 2024 meeting minutes and financial status reports were reviewed and accepted. Mr. Koerner moved, seconded by Mr. Harrigan to approve the April 15, 2024 meeting minutes and current Financial Status Reports. Roll call was as follows: Mr. Stinson, yes; Mr. Koerner, yes; Mr. Harrigan, yes.

Trustee Stinson - Chief we will take care of you right away.

Chief Ortlieb – provided first quarter report. (see attached)

Trustee Stinson provided the road report. Richard (McCain) has done one pass on all of the township roads. He kept up with all of the other mowing. Ready to go do some pole spraying. Took care of digging a grave. Grave side service tomorrow at 10:30.

Trustee Harrigan – you said something about doing the first pass. Is that the first cut of the season?

Trustee Stinson – he does one pass instead of going to the crop line. Most places it almost takes the whole township easement, but you have to wait until the farmers get in and establish their border and then Richard can go in.

Trustee Harrigan – so the first pass is right of the road edge?

Trustee Stinson – yes its 20 foot from the road.

Provided Zoning Report for Sean Tullis, Zoning Inspector (see attached dated 5/6/24)

Trustee Stinson – The other thing we did was joined with the city and they poured 2 footers. We joined with the city and so we are up to date and have nothing pending

Trustee Harrigan provided the hall rental report.

Trustee Harrigan - Applied the hall rental form on our website and made a separate page for it. I mention that they can contact any one of us trustees to schedule. If you guys have any questions I can help with that too. No requests at this time.

Trustee Stinson – for right now if you do get anything send it to me.

Is there any old business – none.

New business – we have the county round table meeting on Wednesday, May  $22^{nd}$  at 6:00. At the community center. Sandi will RSVP.

Ms. Perry – Engineers meeting has been moved to September 4th.

Trustee Stinson – that is the third quarter county meeting. First quarter is always Health Dept and third quarter is Engineers. Second quarter is round table meeting. Fourth quarter meeting is the Christmas party and swearing in of new officers.

Trustee Koerner – I would like to move that in June, July, and August that we meet at the same time, on the third Monday of each month. Trustee Harrigan seconded the request.

Trustee Stinson - open up for discussion.

Trustee Harrigan – some months are a little bit slower. It's my first time around.

Trustee Koerner – Sandi do you have anything on it?

Ms. Perry – Doesn't have a problem with it. Knows trustees are busy in the summer months with the roads and mowing. Let me look at those dates just to make sure if I am going to notify the calendar, so June 17<sup>th</sup>, July 15<sup>th</sup>, and August 19<sup>th</sup>. Does anyone have any conflicts with those dates.

No conflicts were reported.

Trustee Stinson – so June, July, and August, third Monday at 5:00. Roll call was as follows: Mr. Stinson – yes; Mr. Koerner – yes; Mr. Harrigan – yes.

Trustee Stinson - Any more new business? None reported. Danny do you have any comments?

Mr. Evilsizor – does this building have wifi? Mr. Stinson replied affirmatively.

Mr. Evilsizor inquired about the recent Vancrest meeting.

Trustee Stinson – thank you for asking. There is nothing to report. They are pursuing avenues that I am out of the loop on because what they are deciding to do does not involved the township. They are probably trying to bring that into the city from what I gather.

Ms. Perry – they are looking to bring that into the city limits?

Trustee Stinson - It takes time, legal, the commissioners and the city is involved. The township really has little.

Mr. Evilsizor – did you have a meeting with them last week or so.

Trustee Stinson – I did. I think it was on April 25<sup>th</sup>.

Mr. Evilisizor – was it with the local staff there or was corporate?

Trustee Stinson – corporate. It was myself and corporate. It was very brief and they know pretty much where we stand. They don't understand why they were never brought into the city in the first place. They are paying for city water and city sewer. I can't speak for them so I need to stop there.

Mr. Evilsizor – curious regarding the letters to the residents of the subdivisions.

Trustee Stinson – we tabled it. There is an issue going on with a vehicle recall. We have talked to the engineer and their recommendation was to leave it alone as well. The residents agreed with that also. As soon as everyone understood what was going on, that completely calmed down. Once the recall is fixed, it's a Hyundai, once it's fixed, it's going to be parked back in the driveway.

Mr. Evilsizor – who is it that does the grounds maintenance here?

Trustee Stinson indicated that he does.

Mr. Evilsizor – the same with the cemetery. Trustee Stinson indicated that he does.

Mr. Evilsizor – there is an American flag here and at the cemetery. They are up after dark and they are not illuminated. I assume you are aware of the policy of having the flags lit? You do have a rain gauge. Mr. Evilsizor provided photos marked Exhibits A, B, and C. (see attached)

Regarding the grounds here. There is a man hole cover severely damaged and deteriorated. It has been that way for a lengthy amount of time. (provided attached photos as Exhibits D, E, F, and G) And I was curious of what the status was on that?

Trustee Stinson – yeah there is a damaged riser on that. We can look into that.

Mr. Evilsizor – going back to the discussion on the smoking. You made the comment that it seemed to be ok and ok with legal that someone smokes in the shop and the justification was that there's two open pilots out there. The issue is that those two devices don't put out second hand smoke that would affect anyone that walks in. That's the major concern, the second hand smoke. I have also attached here, exhibits H and I. (see attached) For people to come into this building to go to the zoning office or go and discuss cemetery business, they have to enter through door in the shop. And every member who walks through there is subject to second hand smoke. That is not proper. You urged me to contact legal. I did so and I don't know who you talked to but who I contacted said that they are investigating and that is not proper. They are going to pursue their own investigation. I don't know who you talked to that said it is ok.

Mr. Evilsizor – The same with smoking in the automobiles. Do you all allow smoking in the automobiles?

Mr. Stinson – point?

Mr. Evilsizor – The point is there is smoking going on in the township vehicles. I think everyone would understand and agree the trade in or resale value goes down for vehicles that are smoked in is far less than a non smoking vehicle. I don't believe you have the authority or right to jeopardize tax payer money to reduce the value of those vehicles number one. Number two there is still the issue of second hand smoke in those vehicles.

Do you agree?

Trustee Stinson – I am listening.

Mr. Evilsizor – So you don't agree. Trustees Stinson reiterated listening. I asked you a simple question do you agree or not.

Trustee Stinson – I'm listening Dan, that's my answer.

Mr. Evilsizor - Matt do you agree?

Trustee Harrigan – like Blair said we are taking in what you are giving Dan to try to see exactly what you are after.

Mr. Evilsizor – you are familiar with second hand smoke and are ok with that?

Trustee Harrigan – I don't have it around myself.

Mr. Evilsizor – but you condone it in the vehicle.

Trustee Harrigan – we were asked if we were ok with it in the moment, and we were ok with it.

Mr. Evilsizor – Roger?

Trustee Koerner – I don't smoke in the vehicles. I don't know what you are saying. It's a combination of things.

Mr. Evilsizor – I guess it is evident to me.

Trustee Stinson - Whatever we are told by legal is what we are going to abide by.

Mr. Evilsizor - Which legal are your referring to, Jane?

Trustee Stinson – whoever makes the ruling.

Mr. Evilsizor - You have not read it before hand?

Trustee Stinson – read what?

Mr. Evilsizor – about smoking in the workplace. Second hand smoke.

Trustee Stinson – we are not going to argue about this Dan.

Mr. Evilsizor – I didn't ask for an argument I am asking a question, yes or no.

Trustee Stinson - there are situations for everything. I will come back to you with this. You have been part of this township forever. Here for the last 10-15 years you have lived in the township. Richard has worked here for 16 years. Where has then been before.

Mr. Evilsizor - the law has changed.

Trustee Stinson – not recently. That is the part that concerns me. You had ample time to bring these points up. You had time to bring these points up when you were running for trustee.

Mr. Evilsizor – indeed I was not aware of it at the time and couldn't believe it was permissible until I witnessed it and then I brought it up.

Trustee Stinson – so you didn't know Richard smoked? We are not going to argue about this, again.

Mr. Evilsizor – it's not about Richard smoking it's about anybody. Is there a restroom in the shop?

Trustee Stinson – no.

Mr. Evilsizor – so in order for someone to come to the restroom they have to open this door and come in the public part?

Ms. Perry – there is a restroom with a shower out there.

Trustee Stinson – I'll entertain a motion to pay bills and distribute and mail checks. Mr. Koerner moved, seconded by Mr. Harrigan to pay bills and distribute checks. Roll call was as follows: Mr. Stinson, yes; Mr. Koerner, yes; Mr. Harrigan, yes.


