- □ Bank account number and routing number (for direct deposit)
- □ Date of birth for yourself, spouse and dependents
- □ Full names and Social Security Numbers for yourself, spouse, and children
- □ Copy of Last Year's Tax Returns
- □ Payments of estimated Federal, State, or Local Taxes

Income Documentation

- □ Alimony received
- Business Income Profit/Loss Statement
- □ Miscellaneous Income: Jury Duty, gambling winnings
- \Box Rental property income and expenses
- □ W-2 for Wages, Salaries, and Tips
- □ SSA-1099: Social Security Benefits
- □ 1099-MISC: Independent Contractor Forms
- □ 1099-S: Sales of Real Estate
- \Box 1099-C: Cancellation of Debt
- □ 1099-R: Distributions from IRAs or Retirement Plans
- □ 1099: Interest and Dividend Income
- \Box 1099-G: State Tax Refunds
- □ 1099-INT: Interest Income
- □ 1099-DIV: Dividend Income
- \Box 1099-B: Sales of Stock, Land

Adjustments to Income

- \Box Alimony paid
- $\hfill\square$ Records of IRA contributions made during the year
- □ Records of Medical Savings Account (MSA) contributions
- \Box Records of moving expenses
- □ Self-employed health insurance payment records
- □ Teachers: Canceled checks or receipts for expenses paid for classroom supplies, etc.
- □ Form 1098-E: Student loan interest
- □ Form 1098-T: Tuition paid



Deductible Expenses

Itemized Deductions (Schedule A)

- □ Medical and dental expenses, health care insurance, prescriptions, doctors, dentists, eyeglasses
- □ Real Estate and State taxes paid
- □ Job related costs, uniforms, supplies, seminars, continuing education, travel, etc.)
- □ Form 1098: Mortgage Interest Expense
- □ Tax deductible miles traveled for business purposes
- □ Last year's tax preparation fee
- □ Alimony Paid (need Social Security number of recipient)
- □ Casualty and theft losses, insurance reimbursements
- □ Charitable Contributions: Receipts, cash amounts, donated property value
- □ Moving expenses
- \Box Real estate taxes paid
- □ Rental Property Expense
- \Box Work vehicle license fees, mileage
- □ Job-hunting Expenses

Business Deductions (Schedule C)

- □ Advertising (fliers, signs, branded promo items, events, trade shows)
- □ Business Insurance (fire, theft, flood, property, malpractice, liability, workers' comp)
- □ Car Expenses (gas, insurance, registration, repairs and maintenance)
- Depreciation and Section 179 (computers, office equipment, tools, furniture)
- □ Home Office Deduction (business portion of rent, utilities, repairs, insurance, mortgage interest)
- □ Meals (meals with a client and during which you engaged in business discussions)
- □ Office Expenses or Supplies (cleaning services, office maintenance, cleaning supplies, pens, printer ink)
- □ Travel (related to business for lodging, airfare or rental cars, local transportation)
- □ Other Expenses (education to improve skills for your job, banking fees, association dues, business gifts)
- □ Legal or Professional Services (attorneys, tax preparers, accountants, other)
- □ Repairs and Maintenance (repainting office, fixing computer, replacing parts on equipment)
- □ Taxes or Licenses (your share of FICA, state or local licenses)
- Utilities (business related electric, gas, garbage, water)
