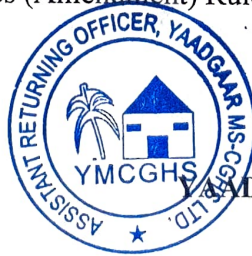
Subject: Declaration of Results of the General Election to the Board of Directors of Yaadgaar Multi-State CGHS Limited
