

## Vendor Liability Waiver & Rules Acknowledgment

Thank you for participating in the Market with a Mission hosted by D&S Cuddling Critters at the Civic Center in Copperas Cove, TX. All vendors must read and agree to the following liability waiver, rules, and event requirements before participating.

### Liability Waiver:

I acknowledge that D&S Cuddling Critters, event organizers, park staff, and associated sponsors shall not be held responsible for any loss, theft, damage, illness, injury, or accident occurring before, during, or after the event. I assume full responsibility for my products, equipment, personal belongings, and safety. I understand that I am responsible for obtaining all relevant permits, licenses, and insurance to operate legally at the market.

### Vendor Rules & Booth Policies:

- Booth fees are flat-rate rentals. No percentage of vendor sales will be collected by D&S Cuddling Critters.
- Vendors must provide their own tables, chairs, signage, and booth setup. We do **NOT** provide this.
- No electricity or water hookups are guaranteed unless stated in advance.
- Setup begins 1.5 hours before market start. All vendors must be fully set up by 3:45 PM.
- Vendors must remain open and staffed until the end of the event at 7:30 PM.
- No early departures without approval from the event manager, Sarah H.
- Any future events may involve different pricing or commission structures. This flat-rate policy applies only to this event.
- Each vendor is responsible for cleaning up their own areas after the event.
- This is a family friendly wellness centered market. Products or displays should reflect a respectful tone.
- No fireworks or pornographic material. Violators will be removed immediately without a refund.
- No pets allowed.
- D&S Cuddling Critters reserves the rights to ask any vendor to leave the premises for any behavior or conduct which is deemed detrimental to the safety of others and the event.
- Vendors are responsible for their own sales tax and reporting for each sale required by the Texas State Department of Revenue.

\*All food vendors must comply with Coryell County and Texas state food safety laws\*

### Food Truck / Food Vendor Requirements:

- Food must be served in sanitary conditions and labeled clearly. Any violations may result in removal without a refund.
- Food vendors are required to provide all required health permits, licenses and insurance at time of application.
- Food vendors are also required to have an active permit with Copperas Cove Code Enforcement.
