FULL TEXT OF PROPOSED AMENDMENT

Art. I is Rights the Bill of Rights

Be it Resolved by the People of the State of Ohio that Article I of the Ohio Constitution is amended to add the following Section:

more accurate and its should be the internal reproductive Article I, Section 22. The Right to Reproductive Freedom with Protections for Health and Safety (mostly for abortion providers)

A. Every individual has a right to make and carry out one's own reproductive decisions including but not limited to decisions on:

contraception;

without limits
gender selection abortion
harvesting body parts
egnancy; chemical castration 2. fertility treatment; 3. continuing one's own pregnancy;

4. miscarriage care; and

trans surgeries on minors

5. abortion > throughout all nine months

B. The State shall not directly or indirectly, burden, penalize, prohibit, interfere with, or discriminate against either:

Does this write PLANNED PARENTHOOD into the Constitution:

1. An individual's voluntary exercise of this right or
2. A person or entity that assists an individual exercising this right,

includes group /activists in schools instructing miners on unless the State demonstrates that it is using the least restrictive means to practice. advance the individual's health in accordance with widely accepted and advance the individual's inequality in accordance with a control w

However, abortion may be prohibited after fetal viability. But in no case may such an abortion be prohibited if in the professional judgment of the pregnant patient's treating physician it is necessary to protect the pregnant patient's life or health.

subjective judgment not age specific of abortionist > possible but not likely

C. As used in this Section: is now protected by the Constitution regardless of the outcome of aborting a fully

1. "Fetal viability" means "the point in a pregnancy when, in the professional judgment of the pregnant patient's treating physician, the fetus has a significant likelihood of survival outside the uterus with reasonable measures. This is determined on a case-by-case basis." 407 defined child

"State" includes any governmental entity/and any political subdivision.

D. This Section is self-executing.

FINAL THOUGHT

The Ohio Legislature will have NO power to mitigate against the abuse of this language, because this is a Constitutional right. Thus, the people of Ohio will be, silenced on this subject.
