AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons.

I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.

Notice to Exhibitors

Test location will be available from 8:00 am to 5:00 pm, or one hour after conclusion of event. No unentered dogs (except set-out dogs) are allowed at the test site. Limited shade is available. Please bring your own chairs. Bitches in season are not allowed. ALL AMERICAN KENNEL CLUB RULES REGARDING CONDUCT WILL BE STRICTLY ENFORCED. No refund for duplicate entries or for any other cause beyond the control of the club. RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY. NO CONDITIONAL ENTRIES WILL BE ACCEPTED. ENTRY FORMS MUST BE SIGNED. **Any type of overnight mail must be marked “No signature required.”** Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without the ‘Current’ Agreement and Rules on the reverse side of the Official AKC Entry Forms are NOT ACCEPTABLE. Owners or their agents are solely responsible for the presence of their dog(s) at the test area. Judges are not required to wait for dogs. Exhibitors are expected to maintain the premises in a clean and tidy condition. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge or barred from competition by action of the Test Committee. If, because of riots, civil disturbances, fire, act of God, public emergency or other acts beyond the control of the Club it is impossible to open or to complete the test/trial, no refund of entry fee will be made. Children must be under the supervision of their parent or guardian at all times. Non-compliance with this rule will force the committee to ask them to leave the premises. **Due to the COVID-19 situation, masks are recommended.**
