How do we Select Judges

Submitted by Jolynn Hefferman and Vanessa Forselius

Overview

We can't speak for others as to their process, but we can spell out ours. We do it by the numbers, primarily. At least that is where we start. We use a matrix to check ourselves.

We know we will need a Group judge for each day. One judge for a group each day is sufficient for all groups but Working and Herding. One judge can cover Herding, but it is tight. Our two largest breed entries are Australian Shepherds and the Mini American Shepherds, which are prevalent in Colorado. We work to avoid judge changes after entries are received. We also know it takes 1.5 working group judges each day.

- Be prepared! Have multiple clinic's contact information posted. Have your dogs health records accessible.
 Keep a copy of all of this on your phone or a readily accessible file.
- 3) Call first. Although there is no way to guarantee you will be seen, calling ahead to see if they are open and have capacity to see your pet may save your dog's life or, at the very least, make the difference between being seen immediately or waiting hours.
- 4) Don't wait until the last minute. If you think your pet is headed downhill physically, make an appointment with your regular vet or an alternative general practice vet to be seen before it becomes
- an emergency.

 5) Take notes. Write down the symptoms, your concerns as well as any pertinent medical history to give to the vet care team in the likely event you will not be in the clinic with your pet.
- 6) Have multiple dogs? Keep a notebook of every dog's meds, illnesses and symptoms.
 7) Consider pet insurance, so you can make decisions that are best for your pet and your wallet.
 8) Advocate for your dog's care but do so kindly.

Many Considerations to Filling the Matrix

Our matrix for judges covers all breeds and assignments. Some people may be asking how we fill that matrix. One consideration is the number and type of groups the judge does. The second consideration is cost to the club. The first two considerations involve cost to the club. Married judges share a room and rental cars. Some locations are cheaper to fly out of. We also try to only hire judges we can use all three days, although we use some Colorado judges, and we try to help local judges get their provisionals.

The third consideration is less by the numbers. That consideration is the judge themselves. Have they judged in this region to often lately? Do exhibitors like them? Are they abusive to exhibitors or stewards? Is the judge to high maintenance for our small club? This information comes from stewards and exhibitors. Finally, yes, we maintain a "do not hire" list. All clubs do because of bad experiences with a judge.

Provisional Judges: What and Why

We talked a bit about provisionals (a breed for which the judge is seeking AKC approval). The AKC requires that we assign provisionals as a condition for holding a show. We also see this as a way of expanding our pool of judges locally and nationally. When a judge begins their career, they must get assignments with entries in their initial breed. Later they seek assignments in their provisionals, even if they get no entries. That lets them expand their approved breeds list.

That means we look for judges that are seeking to expand their list of approved breeds and groups. We give them their provisionals, or try to, to help them grow their careers. Many times this includes judges with multiple groups. Occasionally, you will see us bring in a local judge for some of these reasons.

Technical Considerations

The last piece of judge selection is the technical piece. The AKC maintains a show management database. That database will not let you violate assignment rules or it will return an error on the assignment. When you make assignments for a judge, the only assignments that can be selected are those for which the judge is qualified.

The AKC also maintains a judges directory. It lets you seek a judge from a certain state for a particular breed or group. That directory also lets you look at other regional assignments for a judge. This directory is linked in the AKC database to the show management system.

When we hire a judge, we list them in show management piece of the database as soon as it is possible to do so. This helps other local clubs in their judge search. This is a benefit to exhibitors as it can lessen the potential for a judge to appear to frequently in the area. It is also a benefit to the club. We do not want to lessen entries because of repeat judges.
