## Terrific Treat Recipes!!!

### Healthy Dog-Treat Recipe Meatloaf Treats: - Source: Kathy Sdao

1 lb ground beef or turkey, hi-fat (15-20%), drained of excess liquid (Don't use lean meat; the treats will be too crumbly.)

1 beaten raw egg

¼ cup grated parmesan cheese

In a large bowl, mix together the egg & cheese, then use your hands to mix in the ground meat thoroughly. Divide into three equal portions. Roll each into a log about 8" long, 1.5" in diameter. Bake in a shallow pan at 350 degrees for ~40 minutes. Cool. Cut into small cubes. Refrigerate. (You can also freeze whole logs.)

1 microwave the cubes, spread out on a paper towel, on low power for ~4 minutes to dry them out. These are safe to leave in my bait bag – out of the fridge – for several hours while training.

## Kids Corner By Kay Allen

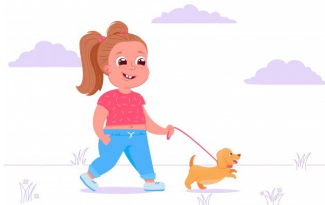
**Be sure to discuss the content of each book or game as you complete the activities**

ONLY USE THOSE TECHNIQUES WITH WHICH THE ADULT IS COMFORTABLE.** Practice can be completed with other dogs, as the adult feels appropriate.

Move Over, Rover! By Karen Beaumont, 2006, Theodore Seuss Geisel Honor Book (can be purchased on Amazon). This humorous book features western wildlife.

Read and discuss the book. Older siblings can read it to the younger ones. Be sure to emphasize the humor and discuss the wildlife. Put the name of each animal in a plastic Easter egg, including the dog and cat. For a large group, use more eggs and assign each team a color. Hunt for the eggs. When all the eggs have been found, put the animals in the order they appeared in the book.

**Dottie Conard**, 81, passed away Wednesday, March 17, 2021 at the Platte County Memorial Hospital in Wheatland..

Dottie worked as a veterinary technician for many years and owned a dog-boarding kennel on her property in Florida. When the vet she was working for gave her a show quality cocker spaniel, Dottie knew she had found her passion in life! She learned to groom and show the cocker spaniels. She showed her own dogs against many of the highest paid handlers in the country and won her fair share of competitions. Her cocker spaniels were outstanding because she made sure they were loved, had the best of care and were free of hereditary defects. She also trained her dogs herself. Her dogs had beautiful temperaments and were always sweet and loving. She completed championships on many, many dogs. Due to her high standards of breeding and care, she also provided healthy, wonderful pet puppies to loving homes that she personally chose. At one time she had the #5 ranked black cocker spaniel in the country. His name was Sir. The name of her kennel was Des-Sir-Cay.

After leaving Florida, she went looking for another place to live. When she found Wheatland, she decided it was the perfect place to call home and she never changed her mind!
