Uncooked Food Distribution during Covid19 Pandemic



Agragati Education Foundation made a small effort towards easing

Agragati Education Foundation organised School Leadership Training for the Principals' of North Delhi Municipal Corporation School Principals. A number of Save the Children Personnel also attended the trainings. The main components of the training were types of leadership, Self Awareness, Monitoring & Mentoring, Listening & Feedback etc.

Teaching Strategies of English – Our expert Resource Person conducted an activity based and experiential training for Govt. School Teacher of NDMC Schools Delhi. A skill base approach of teaching was shared with them. Teachers were excited with the hand on mode of training delivery by our trainer.





## **Teacher Training**

North Delhi Municipal Corporation School Math Teachers were given hands on training on the teaching strategies of Mathematics. A lot of activities on visualization and problem solving were done with them. How to make mathematics a less formidable subject was a focus in the training.

## **BHARTI FOUNDATION**

We created a comprehensive English Remedial Package for Bharti Foundation to be used in Meghalaya, Assam, Telengana and other states where they are supporting govt. schools for Quality Education, apart from their 254 Satya Bharti Schools. It is an end to end programme with dedicated components for teacher, students and school authorities for programme implementation and evaluation. The Package has the following critical components:

## **Online Survey Results**



32% of the respondents were teachers and heads of schools, followed by 30% of parents, 26% of the respondents were students and 13% of the respondents were administrators or school management professionals.

Yes in any examination the parents and students are the most affected. While 83% of school administrators/school management professionals and 60% of the teachers/heads of the school responded that the exam cancellation/rescheduling impact them






Figure 2: Does the Cancellation or rescheduling examinations 2020 affect you?


