## Full Terms and Conditions – *Material Intelligence* People's Choice Award

- 1. Primrose Park Art and Craft Centre Inc (PPACCI) are offering a People's Choice Award of \$100 to the entry receiving the most votes from those attending the Material Intelligence Sydney Craft Week Exhibition at the Centre, in person.
- 2. Voting postcards will be available on the reception desk at the exhibition. The name of artist and title of work is required for vote to be eligible and personal details of the voter.
- 3. Voting is limited to once per person attending (regardless of how often they visit the exhibition).
- 4. The award is open to all entries the vote will be counted by someone who hasn't entered a piece in the exhibition.
- 5. Eligible voting participants are those who attend the exhibition and supply voting details requested. Entry to the exhibition and voting is free.
- 6. Eligible voting participants will be required to provide their name, phone number and email address to complete their voting postcard.
- 7. Duplicate, illegible, incomplete or incomprehensible entries will be ineligible.
- 8. The promoter is Primrose Park Art and Craft Centre Inc (PPACCI) ABN 65 065 606 100.
- 9. The promoter's decision in respect of any aspect of the competition is final, and the promoter will not enter into correspondence regarding the result.
- 10. The voting opens at **11am on Saturday 4th October 2025** and ends at **3pm on Thursday 30th October 2025**.
- 11. The winner will be announced on **Monday 10th November 2025 at 5.00pm AEST** on PPACCI's Website.
- 12. If the winner is under the age of 18 years the prize will be awarded to their parent or legal guardian.
- 13. The award cannot be transferred.
- 14. If the votes result in a tie the award will go to all artists receiving the most votes and the prize money will be split between all winners.
- 15. The promoter reserves the right to request winners to provide proof of identity. Identification considered suitable for verification is at the discretion of the promoter. The promoter also reserves the right to require confirmation of acceptance of these terms and conditions by the winner or their parent or legal guardian, before awarding the prize.
- 16. The promoter reserves the right to refuse to allow a winner to take part in any or all aspects of the prize, if the promoter determines, in their absolute discretion, that a winner is not in the mental or physical condition necessary to be able to safely participate in the prize or the promoter has reason to believe that the winner has breached any of the conditions or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the promotion. It is

- a condition of accepting the prize that the winner may be required to sign a legal release in a form determined by the promoter in its absolute discretion.
- 17. If for any reason this promotion is not capable of running as planned, including due to tampering, unauthorised intervention, fraud or any other causes beyond the control of the promoter, which corrupt or affect the administration, security, fairness or integrity or proper conduct of this promotion, the promoter reserves the right in its sole discretion to disqualify any individual who tampers with the entry process or make any necessary changes to these conditions to give effect to the promotion and ensure safety, security, fairness and integrity, taking any action that may be available, including cancelling, terminating, modify or suspending the promotion, subject to state government legislation.
- 18. The promoter shall endeavour to contact the winner via phone and email prior to the announcement on **Monday 10th November 2025 at 5.00pm AEST**. In the event that the winner cannot be contacted within that time, the next artist receiving the most votes will be announced as the winner.
- 19. If the winner is a 'single collaborative entry' (from one of our groups) the prize money and award will be made to the Group as a whole. If a collaborative entry is separate pieces by individual artists (ie Basketry NSW collaborative entry) then votes will be cast for each piece allowing an individual artist to win.
- 20. It is a condition of entry that the winner agrees to the publication of their name and state on the website.
- 21. The promoter shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to direct or consequential loss) or for any personal injury suffered or sustained in connection with any prize/s, except for any liability which cannot be excluded by law. The promoter does not take any responsibility for any tax consequences or imposts that arise from the receipt of the prize. The winner should seek independent financial advice about any tax implications that may arise from winning the prize.
- 22. The prize pool consists of one (1) prize of AUD \$100, payable by electronic funds transfer in Australian dollars. The details provided by the winner will be used for the transfer and the promoter is not responsible for the prize going awry where details provided were incorrect.
- 23. In the event that for any reason whatsoever a winner does not take an element of the prize at the time stipulated by the promoter then that element of the prize will be forfeited by the winner and no other value will be awarded in lieu of that element of the prize.

Personal information about voters and artists is collected, used and disclosed by the promoter for purposes including administering the promotion, complying with applicable laws (such as laws relating to running competitions), contacting participants and announcing the winner. The information may be disclosed to third parties who are assisting in administering the promotion, supplying the prize and otherwise as set out in these terms and conditions or permitted by law. The personal details supplied by voters will be destroyed after the vote is counted and will not be used for marketing or other purposes.
