The 'Essential Memories Package' is offered at a special introductory rate while Tan Pictures continues to expand its wedding portfolio. Deliverables, pricing, and availability are subject to change at the videographer's discretion.

ESSENTIAL MEMORIES PACKAGE

1. SERVICES PROVIDED

- a) Single videographer utilizing a dual-camera setup to capture key moments throughout the wedding day.
- b) Up to 8 hours of on-site wedding videography coverage
- c) Capture of key moments (ceremony, major events, candid moments etc.)
- d) High quality post production processing including color grading and audio mixing
- e) Deliverables:
 - 3 x Social Clips - Vertical (9:16) format (15–60 seconds each)
 - Optimized for Instagram Reels and TikTok
 - Highlight Film (4–8 minutes):
 - Editor's Selection Clips
A curated collection of edited and color-graded highlights from the ceremony, speeches/toasts, first dance, and other memorable moments throughout the day. The number, duration, and content of the clips will vary depending on the event and available footage, allowing each collection to reflect the unique story of your wedding.

All deliverables are 4K High Dynamic Range (HDR) and Standard Dynamic Range (SDR), delivered via digital download / private link and a physical archival copy on Blu-ray M-Disc for long-term preservation.

2. BOOKING PROCESS

- a) Review and select package. (Currently only offering 'Essential Memories Package')
- b) Sign Wedding Videography Agreement.
- c) Submit booking retainer.
- d) Complete Wedding Questionnaire approximately 30 days prior to the event.
- e) Final balance due prior to the wedding date.

7. PROJECT RETENTION & REPLACEMENT COPIES

Tan Pictures retains archived copies of final delivered films and project materials for up to two (2) years following final delivery. During this retention period, clients may request up to two (2) replacement deliveries of their final films at no additional charge. Additional replacement requests may be subject to an administrative and media handling fee. Clients are encouraged to maintain their own backups of all delivered materials.

8. WHAT IS NOT INCLUDED

As part of the introductory and promotional package plus to maintain a focused and reliable service, the following are **not included** in the Essential Package unless explicitly added as a separate agreement in writing:

Second shooter or additional crew

Extended hours beyond agreed coverage

Raw footage and Post Production project files

Drone footage

Advanced lighting setups

9. SPECIALTY FILM (SUPER 8 / 16MM) – OPTIONAL ADD-ON

Super 8 and 16mm film coverage are not included in the Essential Package.
