TOURNAMENT RULES

1. All participants must have current USBC Adult membership and be 18 years of age or older at time of competition. If current membership cannot be verified, **a USBC Associate membership card must be purchased at the tournament site for \$35.**
2. **NO SUMMER LEAGUES WILL BE USED.** Entrants must use their **HIGHEST 2024-2025** average with at least 21 GAMES as listed on Bowl.com. If a bowler does not have a 2024-2025 average, he/she must use the highest 2025-2026 league average with at least 12 games and must present a current league standing sheet signed by a league official. If none of the above applies, the bowler must enter the tournament with a 220 average. **THE USBC 10-PIN AVERAGE RULE WILL BE APPLIED.** Any bowler who won \$600 or more in our 2024 tournament with at least 12 tournament games bowled may be subject to an average adjustment applied to their entering average in accordance with USBC Rule 319e at the discretion of the Tournament Director. All averages will be verified again before the final payout.
3. All bowlers, regardless of average, must comply with Rule 319d (Reporting Prior Prize Winnings) from CERTIFIED AND NON-CERTIFIED tournaments. Any bowler who has qualified within the last 12-month period for the prize: 1) \$300 or more in any event; 2) Total combined prize winnings of \$500 or more in any one (1) tournament; 3) Total combined prize winnings of \$1000 or more in all tournaments within the last 12 months; must report the name of the tournament, amount of prize and ACTUAL SCORE BOWLED to qualify for a prize. Failure to comply is cause for a forfeiture of entry fees and prize winnings.
4. Members of the PBA / WPBA, may participate, but no more than one (1) per team and one (1) per set of doubles. USBC Youth are not eligible to participate.
5. After the Tournament Director has accepted an entry, entry fees will not be refunded.
6. Multiple entries are permitted for the mixed teams/doubles event; three (3) players on the same team will be allowed to re-enter the team event, and the same doubles partners will be allowed to re-enter but may only cash once using their highest doubles score.
7. Bowlers may enter the singles handicap and/or scratch event at \$15/division (\$30 for both divisions). Multiple entries will be permitted for the singles event and will be accepted until 30 minutes before the scheduled time to bowl. The individual bowler's team event score will count as his/her singles score. Bowlers will only be allowed to cash once using their highest score in the singles event. There will be a separate Men and Women divisions for singles.
8. Prizes will be awarded at a Ratio of at least one (1) prize for every six (6) entries per event. The Prize Fund will be returned 100%.
9. **There will be no change in the submitted original line-up.**
10. Substitutes will be allowed as long as they are eligible and have written verification of average. After a SUB has started a game, he or she will complete the SERIES. If a bowler is late for any event, a score of zero will be given for each missed frame. The Tournament Office must be advised of substitutions at least 1 hour before scheduled bowling time. **Pacers will not be allowed.**
11. Team captains for mixed teams and individuals for mixed doubles must sign official score sheets. Said signatures will be considered as final approval, and only protests of obvious errors in transposing and addition will be considered valid.
12. Protest concerning eligibility or general playing rules shall be made in writing to the Tournament Director. The decision of TBCJ, Inc. shall be final unless an appeal is made to USBC.
13. TBCJ, Inc. shall be liable only to the extent of returning entry fees if and when the entrants shall be prevented from bowling any event in the tournament through delay, unexpected yet necessary schedule change, or premature termination of the tournament, which may be brought about by War, National Emergency, or Emergencies or causes relating thereto or resulting from fires, strikes, lockouts, labor difficulties or other causes beyond our control.
14. **ALL PRIZE CHECKS must be cashed within 60 days of the date on the check. If a Bowler loses a prize check, there will be a \$30 fee for replacing the lost check.**
15. **ALL USBC RULES WILL APPLY FOR ANY RULE NOT COVERED IN THESE TOURNAMENT RULES.**
16. Reserve Team entries will close at midnight on October 14, 2025. All entries received the first Post Office business day following the entry closing date will be accepted.

WALK-INS WILL BE ACCEPTED ONLY IF LANES ARE AVAILABLE UP TO ONE (1) HOUR BEFORE SCHEDULED SQUAD.
