

Motion to Censure Kershaw County Republican Party (KCGOP) Chairman Autumn Dunlap
for Violating a KCGOP Standing Rule to Hold Monthly Executive Committee Meetings

Whereas the November 6, 2023 KCGOP Executive Committee Meeting Minutes record a motion adopted by 13 Yays, 1 Nays and 1 Abstain as follows "... Executive Committee Meetings [must be held] on the third Thursday of every month beginning in January [2024]. A new date shall be set by the Executive Committee if the 3rd Thursday falls on a holiday."

Whereas the February 1, 2024 KCGOP Executive Committee Meeting Minutes record a motion adopted by 15 Yays, 0 Nays and 1 Abstain as follows "Elgin 2 EC R. Trobaugh made motion, was 2nd, move to amend Frequency of meetings motion in regard to EC meetings policy, by striking out 'the 3rd Thursday' everywhere within the previously adopted 'Meetings' policy and inserting 'the 1st Thursday.'"

Whereas Chairman Autumn Dunlap violated the aforementioned standing rule by scheduling quarterly Executive Committee Meetings for June 5, 2015; August 7, 2025; November 6, 2025; February 5, 2026; May 7, 2026; August 6, 2026; November 5, 2026, and February 4, 2026;

Whereas Chairman Dunlap violated the aforementioned standing rule by scheduling other events open to the public on the remaining first Thursdays at the facility designated for the KCGOP Executive Committee meetings without the consent of the KCGOP Executive Committee;

Whereas minutes, affidavits, and witness statements will be presented during a hearing as supporting documentation to these charges; now, therefore, be it

Resolved, that the Kershaw County Republican Party Executive Committee:

1. is initiating a process defined by Roberts Rules of Order to formally censure Chairman Dunlap for the aforementioned violation and will provide the accused due process as described hereafter;
2. is notifying Chairman Dunlap in writing herein if present, otherwise, she will be notified in writing on the following day so she can prepare to defend herself in a hearing before the Executive Committee before voting to censure once all evidence has been presented;
3. calls a special-called meeting to be held for the sole purpose of said hearing on Thursday, October 30th at 6:30 PM at a location determined by the Executive Committee; and
4. requires the censure resolution if adopted be distributed to all Kershaw County Republican elected officials, local media, the SCGOP Executive Committee, the National Federation of Republican Women, and Moms for Liberty in SC and to the national headquarters.

Outen stated 3-minute time limit for Chairman - 1 minute for each EC total of 5 mins</p> <p>2nd VC Mike Jones stated clarifying procedures and motion each side 5 pro/5 against. To this Cassat EC W. 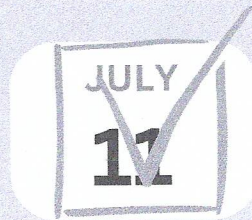

Motion	Elgin 2 EC R. Trobaugh made motion, was 2 nd , to move KCGOP committee meetings be free to plan their meeting types, dates, times, and locations. (Chairwoman stated, "that because the motion on May 25 th mins was unanimously accepted by body, this motion requires 2/3rds. of vote to pass)	10 Yay/ 6 Nay- did not meet the 2/3 rd requirement-motion does not pass.
Point of Clarification	Elgin 2 EC R. Trobaugh asked for clarification and said, "that only new committees formed can make that decision, but the current ones are not allowed to make that decision?". Chairwoman stated, "the ones that were proposed by chair and then approved by EC". Then Elgin 2 EC R. Trobaugh stated, "so you are saying if committee is willing to cover costs, and still move, they cannot?" Chairwoman Outen, "one reason you picked this location was because it was centrally located from all areas and people could hit more than one meeting if they wanted." "This body adopted that".
