No waiver, benefit, privilege, or service voluntarily given or performed by a Party shall give the other Party any contractual right by custom, estoppel, or otherwise.

Attorneys' Fees and Costs. if nay legal action or other proceeding is brought in connection with this Agreement, the successful or prevailing Party, if any, shall be entitles to recover reasonable attorneys' fees and other related costs, in addition to any other relief to which that Party is entitled. In the event that it is the subject of dispute, the court or trier of fact who presides over such legal action or proceedings is empowered to determine which Party, if any, is the prevailing party in accordance with this provision.

Entire Agreement, This Agreement contains the entire agreement between the Parties related to the matters specified herein and supersedes any prior oral or written statements or agreements between the Parties relating to such matters.

Enforceability, Severability, and Reformation.
