- **Custom Delivery** – Your rental items will be carried to and from a place beyond the truck tailgate. Please contact us in advance of delivery/pickup additional fee and to arrange for these services so that your delivery will be appropriately scheduled and staffed.
- Late returns may incur additional fees of per item.

6. CONDITION & USE

- Lessee agrees to use the Rental Items solely for their intended purpose and in a careful and responsible manner.



- Lessee shall not modify, sublease, or transfer the Rental Items without written consent from Lessor.

7. DAMAGE, LOSS & LIABILITY

- Lessee shall be responsible for any damage, loss, or theft of Rental Items and agrees to compensate Lessor for repair or replacement costs.
- Lessor shall not be liable for any injuries, accidents, or damages arising from the use of Rental Items.

8. CANCELLATION POLICY

- Cancellations made 48 hours before the rental date are eligible for a full refund.
- Cancellations made within 48 hours of the rental date will result in a cancellation fee of \$50

9. INDEMNIFICATION

Lessee agrees to indemnify and hold harmless Lessor from any claims, damages, or legal actions arising from the use of the Rental Items.

10. GOVERNING LAW

This Agreement shall be governed by and construed under the laws of Georgia State/Country.

11. ENTIRE AGREEMENT

This Agreement constitutes the entire understanding between the parties and supersedes any prior agreements or discussions.
