### CALL TO ORDER

**APPROVAL OF MINUTES:** Tim Bryan makes a motion to accept December minutes. Mike Shives seconds it. Motion is passed and carried.

BILLS REVIEW: Cheryl Byers makes a motion to pay the bills. Bryan seconds it. Motion is passed and carried.

COMMENTS FROM PUBLIC: Mike Bowers, Darke County Economic Development, updated council on what is going on with the Miami Valley Regional Planning Commission and gave us some information on possibilities of help on run down properties and grants.

- 6. 2022-3 AN ORDINANCE REGUARDING THE HIRING OF A VILLAGE SOLICTOR FOR THE VILLAGE OF GETTYSBURG, OHIO Shives makes a motion to pass Ordinance 2022-3. Luedeke seconds it. Motion is passed and carried.
- 7. Executive Session Personnel Bryan makes a motion to go into executive session. Shives seconds it. Motion is passed and carried. Council goes into executive session at 7:43 p.m.

Meeting resumes at 8:43 p.m.

Council discusses the open position. It is decided to get an ad together to hire a Street Supervisor stating compensation will be based on qualifications.

Shives makes a motion to make a vote of no confidence against the Mayor, Donnie Harmon, for his handling of Susan and for the treatment of women. Williams seconds it. Motion is passed and carried.

Luedeke asks Cox if the village itself has any liability due to the mayor's actions.

Bryan stated that there has been a lot of things that happened in the meeting the Mayor had with Him and Byers last year. There were things that were said to Byers, like writing her up, and getting her removed from council with no authority to do so. The mayor has made comments where contracts are being threatened. He reminds council that they are the ones with the authority. Not the Mayor. The only time he gets a vote is when there is a tie. Otherwise, council is the one with power. He said this needs to end.

Bryan makes a motion to end meeting. Byers seconds it. Motion is passed and carried.

The meeting ends at 8.50 p.m.
