Matt Pierron said that the village should get an engineer's approval to put down the speed bumps.

Don Harmon suggested putting the speed bumps staggered instead of one complete across the road so Emergency vehicles could drive around them. Even though the fire department and EMS do not agree with the speed bumps, they did appreciate this change.

Mark Whittaker, Sheriff, said that he would get the speed trailer to collect some data on Bridge Street.

The mayor asked the solicitor what the proper channels were to sell a property in the village. The village must take bids but are not obligated to take the highest bid. He also asked if there was any type of regulation for parking anything with a motor in the garage at the park. Harmon would also like all the extra chairs in the garage at the park to be moved to the school.

# **OTHER REPORTS:**

- a. Water/Sewer: Jay Roberts informed council that the tank at the water plant is being rerouted.
- b. Park Board: No report.

c. Zoning: John Archey let council know about an issue with 241 Factory Street. Archey had a conversation with the owner of the home. He let the resident know that if he was putting a pool up that was more than 30" deep that it needed a fence put around it. The resident now has the pool up and filled with no fence. Archey went back to the resident to see why his fence wasn't up and the resident showed his receipt that the fence has been ordered but it was on back order. Byers is concerned about the villages liability if something horrible would happen. Matt Pierron, solicitor recommends draining the pool. After discussion, the solicitor felt a temporary fence would suffice if council was against draining the pool. Bryan makes a motion to allow the resident to erect a temporary fence until his permanent one comes in, with the stipulation, the permanent fence is up by August 1, 2020, if not, the pool will need to be drained. May seconds it. Motion is passed and carried.

Byers let everyone know that they are nearly half way through revising the zoning ordinances. She says they are hoping to wrap it up by the end of August. Byers also had a variance meeting about a resident wanting to put a pool in. There was only one negative

## **OLD BUSINESS:**

- 1. Miami Valley Lighting Bob from Miami Valley Lighting said that Gettysburg is on the plan to get lights changed out in August.
- 2. Auld Street Property Archey brought up the property on Auld Street. He had a conversation with Ron Lynch. Lynch said he would be willing to bust up the concrete and remove it at no charge to the village, since he could use it for fill. Archey then said we could use the dump truck to bring in dirt that the village has at the water plant to fill it. The mayor told John to move ahead with this project. If the village wants to put the property up for bid, they must put a bid for property in the newspaper.

- 3. Ordinance 2020-4 Setting temporary appropriations for fiscal year 2021 and declaring it an emergency. Bryan makes a motion to suspend the three reading rule. Mays seconds it. Motion is passed and carried. Bryan makes a motion to accept Ordinance 2020-4. Mays seconds it. Motion is passed and carried.
- 4. Resolution 2020-4 Requesting the village's share of funds from Coronavirus Relief Distribution. Byers makes a motion to suspend the three reading rule. Mays seconds it. Motion is passed and carried. Mays makes a motion to accept Resolution 2020-4. Bryan seconds it. Motion is passed and carried.
