COMMENTS FROM PUBLIC: Craig Knapke with Access Engineering said that there were just 4-5 things left to finish up the water tower site. Jay Roberts is getting contractors to get equipment off the old tower. Knapke wants to close the project out and there will be a 1-year maintenance warranty. The project amount was \$1,286,100. May makes a motion to pay final pay request to McGuire Iron of \$39,120. Cindy Shives seconds it. Motion is passed and carried. Knapke discussed the demolition of the old tower. Once items are off the tower, demo will be scheduled. He also said that it would cost an extra \$5000 to remove the concrete at the bottom of the old water tower. Council agreed it wasn't necessary to remove the concrete for \$5000.
