#### **OLD BUSINESS:**

1. Trash Bids – Bids were opened. Rumpke offered \$16.13 a month for 2021-2022. Best Way offered \$16.10 for the first year with an increase in the second year to make it \$16.58. After discussion, council decided on Option one from Rumpke with the small recycling tote.

#### **NEW BUSINESS:**

4. Resolution 2020-8 – Authorizing Fiscal Officer to amend fund 2902, emergency. Bryan makes a motion to suspend three reading rule. May seconded it. Motion is passed and carried. May makes a motion to pass Res. 2020-8. Shives seconded it. Motion is passed and carried.

Shives makes motion to adjourn meeting. Bryan seconds it. Meeting ended at 8:02 p.m.
