Parkman states that Matt is well worth the money he is asking for and that he provides answers when we have questions. Archey stated that we are lucky to have him. Council unanimously agrees. Welcome back Mr. Pierron.
- 2. Christmas Décor Parkman makes a motion to allow Canan to spend \$2500 towards Christmas decorations. Cindy Shives seconds it. Motion is passed and carried.
- Resolution 2023-5 A resolution for accepting the amounts and rates as determined by the budget commission. Williams makes a motion to accept Res. 2023-5. Dan May seconds it. Motion is passed and carried.
- 4. Ordinance 2023-5 An ordinance setting the temporary appropriations for fiscal year 2024, and declaring it an emergency.

Shives makes a motion to approve first reading of Ord. 2023-5. Parkman seconds it. Motion is passed and carried.

Parkman makes a motion to suspend the rules and give second and third readings by title only. Williams seconds it. Motion is passed and carried.

Hammons makes a motion to adopt Ord. 2023-5. Williams seconds it. Motion is passed and carried.

Parkman makes a motion to adopt the Ordinance as an emergency. Hammons seconds it. Motion is passed and carried.

Archey lets council know that his neighbors are still carrying on. Children are laying in the street and blocking traffic. Council to revisit in January with new solicitor. It was suggested to invite the commissioner to a meeting.

Archey makes a motion to go into executive session at 8:05 p.m. Hammons seconds it. Hammons invites Hunter Clarkson to executive session. May seconds it. Motion is passed and carried. Session ends at 8:53.

Parkman makes a motion to adjourn the meeting. Hammonds seconds it. Motion is passed and carried.
