### COMMENTS FROM PUBLIC

Travis Pearson asked if the Village was interested in selling the school (Cardinal Center), and expressed interest in buying it. A lengthy discussion on the topic of selling the school ensued.

Paula Harshbarger expressed her interest in the Council seat that becomes vacant in 2018. It was explained to her and others present, the seat cannot be filled until the January Council Meeting, and that three other citizens (in addition to Harshbarger) have submitted letters of interest in the open Council seat.

### **MAYOR'S REPORT**

Mayor Lance spoke about the drug and crime rate in Gettysburg, going into length and citing examples. The Mayor then went on to express his frustration that in the face of Gettysburg's ever growing crime rate, drug problem and other obstacles, we have Villager's negatively criticizing the administration, Village employees, and Village volunteers over petty, inconsequential things – constantly creating hostile work conditions; and in some cases

compromising Village progress. Mayor Lance went on to mention a social media site in which these particular Villagers are constantly utilizing to ultimately bully all those who are working to improve the Village. Resident Paula Harshbarger attempted to interrupt but Mayor Lance stopped her. Resident and Village employee Susan Parkman, who works as an administrative assistant/office back-up, utility meter reader, Park Board member, and volunteer, gave a passionate speech about the negativity she has witnessed, experienced, and has recently seen her husband Rocke (who is Park Board Vice Chair, and volunteers as the Village Snow Plow Driver) experience. Resident Paula Harshbarger again interrupted in an attempt to defend some of the negative statements she has made, and again Mayor Lance stopped her, stating the Citizen Comment portion of the meeting was over. The Mayor went on to state that there was no excuse for the kind of negative statements and constant criticisms she (Harshbarger) and others are making. Harshbarger shouted a profanity and stormed out of the Council Meeting. A small discussion on positive language vs. negative language ensued. A further discussion regarding crime rate ensued and Councilman John Archey asked about the Rental Registration Program that was introduced a few Council Meetings ago. The Mayor concluded by reminding Village Officers and Employees not to get involved in disputes on social media.

### SOLICITOR'S REPORT

Solicitor Mathew Pierron updated Council on Zoning Board and Zoning Officer efforts, and explained the relative Ordinances that will be presented in New Business.

### FISCAL OFFICER/VILLAGE ADMINISTRATOR:

Fiscal Officer/Village Administrator Jesse Berry read over his report, informing Council of his Year End UAN efforts. Berry informed attendants that he met with the Finance Committee to review temporary appropriations for 2018. Berry mentioned some discrepancies in a couple of the funds that will need worked out before final revenue and expenditures can be submitted to the County Auditor – due by January 31, 2018. Berry then informed Council that Karen Stubbs was coming over the following week to assist in those efforts.

Berry also included in his report details of a salt supplier change at the water plant, and pointed out that he gave most of the details during the Water Operator report.

Finally, Berry updated Council on the upcoming state audit; noting that he'd received some paperwork, filled out a questionnaire, and participated in a Q and A teleconference with the State Auditor's Office and potential third party auditing firms.

### **OTHER REPORTS:**

Water/Sewer: Water Operated Jay Roberts explained a change in salt suppliers for water operations; which will result in an approximate annual savings of \$12,000.00. Berry read further details from his report; crediting Roberts for finding the savings. Roberts went on to brief Council on complications with the park sewage lift station.
