OLD BUSINESS

1. **Debt retirement** – Kelsey Chrisman talked with Pierron about looking into properties not paying debt retirement. Pierron said that he doesn't think the village should go retroactive. He suggested creating a new ordinance. After discussion, council tabled this until more information is found.

NEW BUSINESS

1. **Vanguard** - Majeed G. Makhlouf attended the meeting with his Director, Oscar, from Vanguard on the phone to talk about their business they are wanting to bring into the village by renting space from

Shurgreen. Vanguard works with renewables. They use food waste that will be broken down and then trucked out. Product is usually in and out within 24-48 hours. They plan to hire locally and hope to increase production. They plan on renting all available space through Shurgreen. May asked how many years their lease will be. Makhlouf said they are usually for 20 years. They hope to become well established in Gettysburg. Parkman makes a motion to approve of Vanguard bringing their business to the village and renting from Shurgreen. May seconds it. Motion is passed and carried.

- 2. **Shurgreen Water Bill** Aaron Flora said that there was a line broke and fixed at Shurgreen and he ran a lot of water through the system to make sure it was cleaned out. Shurgreen would like the sewer billed adjusted. Parkman stated that they need to pay the bill. Flora said he would call them.
- 3. **Asphalt Patching** Flora presented a quote from Wagner Paving to fix holes around the village. He said there are around 16-17 of them. John Archey makes a motion to accept the bid. Parkman seconds it. Motion is passed and carried.
- 4. New Truck/Plow Flora informed council that he would like to look into purchasing a new truck, plow and salt spreader for the village. Council told him to bring quotes to the next meeting.
- Approve Payment to Advanced Demolition Services Parkman makes a motion to approve final
 payment for demolition of the old water tower, which ends the new water tower project. Chrisman
 seconds it. Motion is passed and carried.
