#### CALL TO ORDER

Mayor Jon Michael Shives led attendants in the Pledge of Allegiance and called the meeting to order at 7:00 PM.

AGENDA REVIEW: Dan May makes a motion to amend the agenda to go into executive session about employment. Kelsey Chrisman seconds it. Motion is passed and carried.

COMMENTS FROM PUBLIC: Adam Kremer from Shur Green Farms answered questions from council and the public. He said that the building is being used for a warehouse only. There are no plans for hog barns or a lagoon. They removed dirt from the property that was needed for another one of their properties. There are no other plans for the property at this time. It will just be used for storage and they don't foresee an issue with odors. The plans are to use the building for storage and to farm the rest of the property. They may consider renting out some office space, since they do not need the entire building.

Patsy Riley wanted to know what is going on at the old pizza place. She was told that Shaun Hayes is planning a laundromat. She said they need to get permits from Troy.

Leslie Clark, from 571 N. Bridge, spoke about the standing water in her yard, that she believes is being caused by issues with storm tiles. This has been approached several times with them being told it wasn't an issue for the village. After discussion from other citizens in the area, Chrisman agreed to call Jim Surber and to get an official answer from someone about whose issue this is.
