<sup>2</sup> Public Safety/Security includes third party security group's patrol of district; other public safety programs.

<sup>3</sup> Business Recruitment/Marketing includes special supplemental services such as marketing retail/restaurants in district, promotional ads, job fairs, marketing/recruitment events, district website development and maintenance.

<sup>4</sup> Cultural Events includes events and programs that highlight the culture and arts of the district.

<sup>5</sup> Audit line item includes fees for quarterly and annual accounting.

<sup>6</sup> Any carryover surplus in excess of 20% of the annual net assessment shall be distributed between the Area Improvements and Public Safety/Security categories.
