# How the ASHBA Proposed Bylaws Affect Members and Horse Shows

Many of you have heard through social media, ASHBA mailings and email blasts that there is a proposed change to the bylaws of the ASHBA. Here is what we know so far:

### What's Happening?

On January 8, American Saddlebred Horse and Breeders Association (ASHBA) member, Scott Hagan, in accordance with Article XVI, Section 3, proposed amendments to the current ASHBA Bylaws to be voted on by the Membership at the ASHBA Annual Meeting on February 13 in Lexington, Kentucky.

### How do the Proposed Bylaws affect me as a Member?

According to proponents, the proposed bylaws will:

- 1. Return control of the Association to the Membership by returning the ability to vote for the Board of Directors,
- 2. Prohibit amending the bylaws without vote of the membership (requiring 2/3 majority of the members voting to amend the bylaws),
- 3. Reduce the number of Board Members from 18 to 11 to improve accountability and productivity,
- 4. Populate the Board with at least six amateurs and four professionals, six of whom must be breeders (whether professional or amateur); and
- Prohibit ASHBA Directors from holding positions as Directors/Officers of any other associated equestrian organization (such as USEF, UPHA or ESC) to eliminate potential conflicts of interest.

#### How Does This Affect Horse Shows?

On January 5, the ASHBA sent out the "2025 Horse Show Application" to all horse show managers and secretaries. (As you know, the KSF WCHS is handling their own qualifications, so that is no longer a function of being an ASHBA Star Show.) However, for horse shows to have their competition results recorded with the Registry on the horse's record, shows must choose from three options:

- 1. USEF/USEF Lite;
- 2. Star Show (USEF Saddlebred and Half-Saddlebred rules must be used for competition); or
- 3. "Non-Affiliate" Horse Show.

In order for a show to choose any other governance option, the only available choice is #3, "Non-Affiliate" which is the most costly and the most restrictive. It offers NO CH Points, NO points earned towards ASHBA Year End High Point Awards, and NO National Select Series classes can be offered. We are hopeful that a change in the bylaws and new leadership will result in ASHBA taking a more governance-neutral position moving forward.

If you agree that members, under current ASHBA rules:

- 1. are being denied the opportunity for input in selecting which individuals are elected to the ASHBA Board of Directors, and
- 2. are being denied a voice in the decisions that the Association is making with regard to matters that affect us all

Then a "YES" vote in favor of the proposed bylaws would return your right to have a vote/voice in these important decisions.


