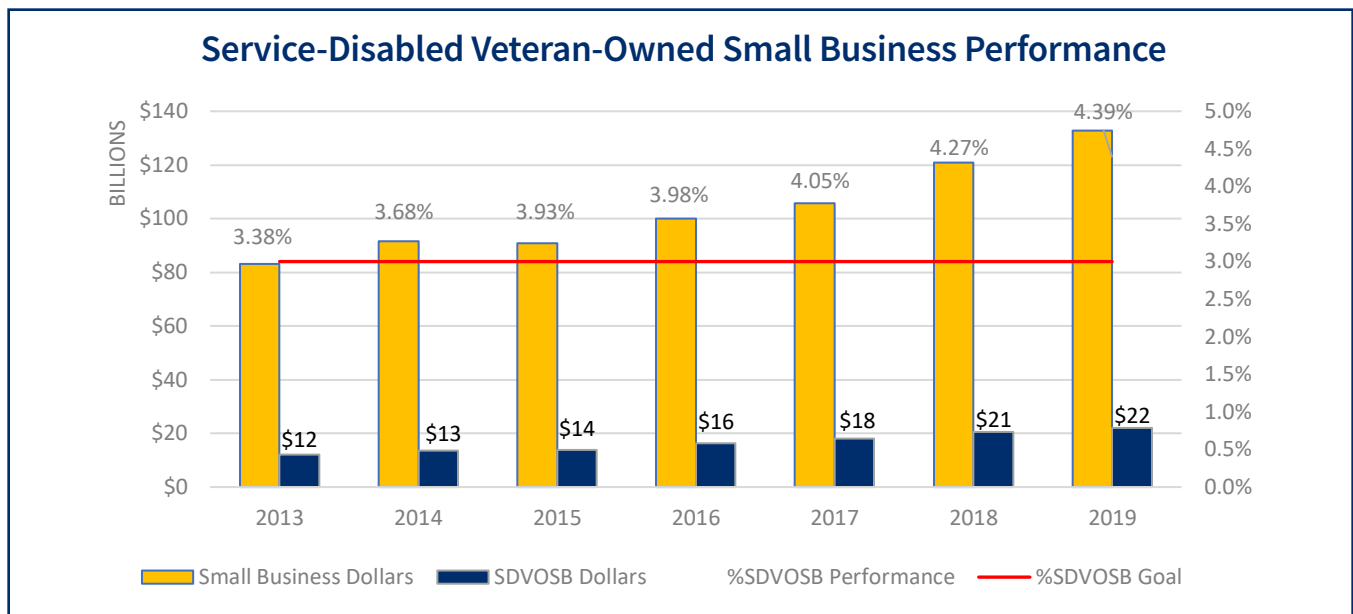


# Service-Disabled Veteran-Owned Small Business Prime Contracting FY2019

Small business is expanding and contributing to the economy at a record-breaking level. By better competing for and winning federal contracts, small businesses have supported about 677,000 jobs, driving job creation, innovation, and growth on a local, regional, and national level.



## Outreach Efforts

Continued outreach on certification programs and education on federal contracting to veteran population through Veteran Business Opportunity Centers, veteran-focused events, and social media.

## Advocating for Small Business

- Recently lessened the regulatory burden on veteran business owners by consolidating ownership and control requirements into one regulation. (*SBA Final Rule 83 FR 48908*)
  - Lessened requirement that a service-disabled veteran (SDV) make all decisions.
  - Defines “extraordinary circumstances” in which a non-SDV can have shared decision-making authority.
  - Established that control could shift when the veteran is called to active duty.
  - Surviving spouse can own and control 100% of the SDVOSB for up to 10 years after the veteran’s death.

## FY2019 Highlights

- Federal government exceeded the small business contracting goal for the seventh consecutive year.
- Awarded record-breaking **\$132.9 billion** in prime contracts to small business.
- More than **\$22 billion** in contracts were awarded to Service-Disabled Veteran-Owned small businesses; could equate to **113,000 jobs**.
- Prime contracts awarded to over **5,400 SDVOSB** - over 7% total small business vendors.
- Average award of **\$4.3 million** per prime contractor.
